# **Course Description**

This course introduces students to quantitative research methods and skills of producing and analyzing statistical results. The course has three primary objectives: to explain the goals of quantitative research in social sciences; to provide students with skills of conducting their own quantitative research; and to develop students' skills in comprehending and evaluating statistical results. By the end of the course, students will learn to run *Statistical Package for the Social Sciences* (SPSS); produce, translate, and evaluate statistical results. The course is designed to teach students the statistical techniques from scratch and, therefore, no previous experience of using SPSS or related software is expected.

### **Course Format**

This course is taught online and synchronously. Every class includes a two-hour online lecture through the BigBlueButton (BBB) learning platform with a break in between and a fifty-minute lab. In the first part, the instructor will give an online lecture with slides delivered through the BBB. The instructor will create the BBB session on cuLearn before class, and students can join by clicking on the BBB session every Tuesday & Thursday from 2:35 to 4:25. The second part of the class will include an online lab which allows students to exercise SPSS and produce statistical results. The instructor will post the lab instructions on CuLearn page. - reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another's data or research findings;
- failing to acknowledge sources through the use of proper citations when using another's works and/or failing to use quotation marks;
- handing in "substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.

Plagiarism is a serious offence which cannot be resolved directly with the course's instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They may include a mark of zero for the plagiarized work or a final grade of "F" for the course.

**Submission and Return of Term Work:** Papers must be submitted directly to the instructor according to the instructions in the course outline and will not be date-stamped in the departmental office. Late assignments may be submitted to the drop box in the corridor outside B640 Loeb. Assignments will be retrieved every business day at **4 p.m.**, stamped with that day's date, and then distributed to the instructor. For essays not returned in class please attach a **stamped**, **self-addressed envelope** if you wish to have your assignment returned by mail. Final exams are intended solely for the purpose of evaluation and will not be returned.
