Natural Right and the Specter of Values

For the classical political theorists, the community takes priority over individual self-interest, just as duties take priority over rights. For the early modern political thinkers, it is the exact reverse — the social contract exists to maximize individual self-interest, and individual rights take priority over common duties. But classical and early modern political theory did share one fundamental premise in common. Both began with an exploration of human nature and psychology and derived from it a rationally binding account of political life; in other words, both were based on the concept of natural right. However, natural right was seriously challenged by Max Weber's argument that it was not possible to derive an Ought from an Is — that any empirical description of natural human behavior could not yield a binding account of political life. But if the social contract has no objective basis in human nature and psychology, what justifies it? Is it merely the ratification of the conventional status quo? And if our values are, as Weber maintained, decisions projected into an ethical void, how can one political alternative be reasonably preferred over another? That is the specter haunting political inquiry that we will uncover in this seminar.

REQUIREMENTS AND BASIS OF GRADING:

a) Students will make presentations on an equally rotating basis on the readings assigned for each class. There is no written component. The aim is to lead the seminar group through the readings and generate a collective discussion of them. Worth 50% of grade.

b) A term paper on the textual exegesis of one or more of the assigned readings. Suggested topics will be provided. You are welcome to use your seminar presentation as a dry run for the term paper, but you are also free to write on something else entirely. Length: For 4000-level students: 15 thesis pages double-spaced typed. For 5000-level students: 20 thesis pages double-spaced typed. Due on the last day of classes, April 12. Worth 50% of grade. Late papers will be fined by a fraction of a grade (i.e., A to A-) for each day.
