Please note that beginning on 7 March, the class will move to on-line delivery.

The class will meet on Tuesdays for approximately two and one-half hours. **Students must attend each class**.

This is the second half of the PhD core course in Canadian Politics. The principal objective of the course is to expose students to key debates and literature in the study of Canadian politics. This half of the course concentrates on Canada's political institutions and the different approaches to studying them. In some weeks, we will be joined by faculty members from the Department who will lead discussions in their areas of expertise. There is a considerable amount of reading for the course and all readings are available electronically on course reserve through the Carleton library. A list of readings will be posted on Brightspace prior to the first class. Students are expected to have read and carefully considered each reading before class. Classes will run as seminar discussions and the bulk of the time should involve students discussing the material with each other.

Assignments and evaluation

Attendance and Participation (25%): Students are expected to attend each class session and to participate fully in class discussions. The grade will reflect both the quality and quantity of participation (with greater emphasis on the former). For each class, students will be responsible for leading the discussion on one of the assigned readings. More information regarding this will be provided in the first class.

Reading reflections (30%): Each student will submit written reflections on the readings for two weeks of their choosing. The reflections should identify and assess the major themes from that week and discuss the contributions and connections of the different readings for the week. These are not simply summaries of the readings but must deal

with the readings as a whole in a cross-cutting fashion. The recommended length is approximately 2,000 words. The first reflection is due on February 17 and the second on April 4.

In-class Test (15%): As one of the purposes of the course is to prepare students for the comprehensive examination in Canadian Politics, an in-class test will be held on 28 March.

Prime Ministerial Assignment (30%): Students will write a paper, of approximately 20 pages, applying readings from the course to the tenure of a Canadian Prime Minister. The paper is due at the start of class on 11 April. Further details of this assignment will be discussed in class. Students will make an oral presentation of their paper in class on 11 April.

Any late submission of papers must be agreed upon by the course instructor prior to the listed submission dates. In no case will work be accepted after 17 April 2023.

Covid-19 Pandemic Measures
