

# Sumita Dixit Scholarship for Diverse Voices

## Terms and Eligibility

Awarded annually on the recommendation of the Chair of the Department of Political Science to an outstanding undergraduate student who identifies as a woman and is Indigenous, Black or a member of another racialized group. Eligible recipients will be entering or continuing in a Bachelors degree in Political Science with a scholarly specialization in International Relations and/or Comparative Politics. Application is required. Established in 2024 by the Dixit family, in memory of Sumita Dixit BJ/1998, a Canadian diplomat who advocated for the inclusion of women's voices in humanitarian and diplomatic arenas.

## Rationale

Gender, race, and Indigeneity have emerged as key themes in scholarly debates in International Relations and Comparative Politics. However, racialized women remain underrepresented as faculty members and policy practitioners. This results in a lack of role models and institutionalized recognition for female students from racialized groups in Political Science undergraduate programs. This award seeks to create a strong form of recognition for these students to emphasize that their voices are essential in debates about international and world politics, and to help train a new generation of scholars and policy practitioners.

*This award is valued at \$1,000 for the 2025/2026 academic year.*

## **General Eligibility Criteria**

- Indigenous, Black or racialized students who identify as women
- Enrolled full-time in an undergraduate degree program in the Department of Political Science who are specializing in International Relations and/or Comparative Politics.
- Outstanding academic achievement
