**Course description:**

*“The expectation that human beings can and will bring about their own perfect order by their own efforts, however, presents us with one of the most perplexing issues in political philosophy: namely, why can we not find a ‘perfect’ form of rule?”*  
James Schall, *At the Limits of Political Philosophy*, pg. 26-27

The question of political statesmanship is a central theme in political philosophy. As Schall has rightly asked, why can we not find a “perfect” form of rule? What are the limits and possibilities for political rule? How do experiences of goodness and evil in man aid and/or complicate the ability of a statesman to establish good political order? What forms of order practiced by the statesman are most compelling? Using the work of classical and modern political theorists such as Aristotle, Machiavelli, Hobbes and Hannah Arendt, we will explore classic pieces of literature to see how the authors’ ideas express the challenges to politics outlined by the political theorists. These books raise important questions that help us to understand about the role of virtue and vice in the political community, the power of man’s will, and the presence of tyranny, just to name a few. In order to delve into these questions, we will closely examine both the diversity of human-types represented in the characters and the political environment in which they inhabit.

## Course Requirements

First Essay – 25% (Due: Monday, October 6, 2008)

*(As per earlyfeed back guidelines, this assignment will be returned by Oct 31<sup>st</sup>.)*

Second Essay – 25% (Due: Monday, November 10, 2008)

Take-Home Exam – 40% (Due: Saturday, December 20, 2008)

Attendance and Participation – 10%

All assignments will be given a numerical mark and a corresponding letter grade. All components of the course must be completed (two essays, one take-home exam, attendance/participation) in order to receive a passing grade. Assignments must be submitted in paper copy. Electronic submissions are not permitted.

## Evaluation of Term Work

The first essay is due Monday, October 6, 2008, in class at 2:35 p.m. and the second essay is due Monday, November 10, 2008, in class at 2:35 p.m. Each essay will be four to five (4-5) pages in length and will be based on essay questions assigned in class. Any student wishing to create their own essay question must receive permission by the instructor. Both essay assignments will provide an opportunity to explore one particular text examined in the course in relation to the political theorists studied.

Emphasis will be placed on a close examination of a work of literature – ie: the characters, key themes and ideas, etc. Secondary sources are strongly discouraged; rather, the student should focus on the literature in question, as well as the primary texts of the theorists examined in this course. The essay will be graded on the strength of the academic argument and knowledge of the texts (both literature and of the political theorists), as well as on spelling, grammar and style.

Attendance will be taken at each class after the break (approximately midway through the scheduled lecture hours). Participation is based on constructive contribution to the class discussion.

The take-home exam is due on Saturday, December 20, 2008, at 4:00 p.m. and will be based on essay questions distributed on the last day of class (Monday, December 1, 2008). The exam is due to my office by 4:00 p.m. I will have office hours on December 20 in order to collect exams between noon and 4:00 p.m. Please note the following excerpt from Academic Regulation **2.4 Examination Regulations:** *In courses below the 4000-level, **take-home examinations may not be assigned before the last day of classes and are due on the last day of the official examination period.***

Please note: If you choose to submit any assignment to the Political Science Department's drop-box (located at B640 Loeb Building), then your assignment will be subject to the rules of the drop-box. Anything submitted after 4:00 p.m. on a Friday will NOT be collected until Monday morning, and will therefore be date stamped accordingly and the appropriate late penalty will be applied. Furthermore, the Political Science Department's drop box is intended to collect late assignments only or if a student has extenuating circumstances and is unable to submit the essay directly to class or the exam directly to me. You should be aware that the drop box is emptied **every weekday at 4:00 p.m.** and all items collected at that time are date-stamped with that day's date.

If you choose to submit your take-home exam to the Political Science Department's drop-box after 4:00 p.m. on Friday, December 19, it will not be retrieved until Monday, December 22 and a late penalty will be applied.

Late penalty: Items that are late will receive a five (5) per cent reduction for each day it is late. Weekends count as two days.

Extensions will only be granted for medical reasons or unforeseeable emergencies. Proper documentation must be provided. Do not assume that an extension will be granted without contacting me at your earliest convenience to discuss your request for an extension.

## Academic Accommodations

**Oral Examination:** At the discretion of the instructor, students may be required to pass a brief oral examination on research papers and essays.

**Submission and Return of Term Work:** Papers must be handed directly to the instructor and will not be date-stamped in the departmental office. Late assignments may be submitted to the drop box in the corridor outside B640 Loeb. Assignments will be retrieved every business day at **4 p.m.**, stamped with that day's date, and then distributed to the instructor. For essays not returned in class please attach a **stamped, self-addressed envelope** if you wish to have your assignment returned by mail. Please note that assignments sent via fax or email will not be accepted. Final exams are intended solely for the purpose of evaluation and will not be returned.

**Approval of final grades:** Standing in a course is determined by the course instructor subject to the approval of the Faculty Dean. This means that grades submitted by an instructor may be subject to revision. No grades are final until they have been approved by the Dean.

**Course Requirements:** Students must fulfill all course requirements in order to achieve a passing grade. Failure to hand in any assignment will result in a grade of F. Failure to write the final exam will result in a grade of ABS. FND (Failure No Deferred) is assigned when a student's performance is so poor during the term that they cannot pass the course even with 100% on the final examination. In such cases, instructors may use this notation on the Final Grade Report to indicate that a student has already failed the course due to inadequate term work and should not be permitted access to a deferral of the examination. Deferred final exams are available **ONLY** if the student is in good standing in the course.
