# Special Topics in Political Management: Political Management and the Law (POLM 5906A)

## **Course Description**

This course will help students identify common legal issues that affect party officials, parliamentarians and political staffers. It will introduce students to access to information laws, privacy laws, election laws, campaign finance laws, whistleblowing laws, defamation laws, national security laws and criminal laws. It will also introduce students to parliamentary law and procedure, including the concept of parliamentary privilege. This course has been designed to be an introductory law course. Students are not expected to become legal experts.

#### Readings

A textbook is not required for this seminar. All assigned readings are outlined in Appendix 1 ("Detailed Reading List").

#### **Evaluation**

Students will be evaluated based on attendance/participation (20%), mini-writing assignments (30%) and an open-book, take-home final exam (50%).

There will be two mini-writing assignments worth 15% each. The goal of these assignments is to have students identify (potential) legal issues within hypothetical fact patterns. Outside research is not required. Detailed instructions, including formatting instructions, will be provided with each assignment.

Late assignments will be subject to a 10% penalty for each 24-hour interval, or fraction thereof, that they are late. For example, if an assignment due Thursday at 5:00 PM is received after 5:00 PM Thursday, but before 5:00 PM Friday, then the mark will be reduced by 10%. If the assignment is received after 5:00 PM Friday, but before 5:00 PM Saturday, then the mark will be reduced by 20%, and so on.

Please keep a copy of each assignment that is submitted—and a copy of each e-mail used to submit each assignment.

The open-book final examination will be worth 50% of the final mark. The exam will cover topics discussed in the lectures and in the readings. The final exam will be distributed on the final day of classes (October 16, 2024) and will be due the final day of the examination period

(October 27, 2024). It is an open-book, take-home examination. It will be due the final day of the official examination period. It must be completed individually.

Despite the weighting described above, completion of all three assignments and the final exam is required for successful completion of the course. In other words, the three assignments must be completed—and the exam must be written in order to receive a passing grade.

As a general note, each student should write their student number on the front page of their assignment—and each subsequent page of their assignment. Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.
