This is an application filed under section 68 of the *Labour Relations Act, 1995*, S.O. 1995, c.1, as amended (the "Act") for a declaration that the applicant has acquired the rights, privileges and duties of its predecessor Carleton University Postdoctoral Association, by reason of a merger, amalgamation or a transfer of jurisdiction. Notice of this application has been sent to the responding party employer and the alleged predecessor trade union.
