#### **Course Description**

This course is an introduction to the text of the Qur'an in English translation, as well as to some of the academic approaches used to study it. Topics to be covered include: historical debates about the history of the written text, its historical context, the Qur'an's structure and literary style, its major themes, and some of the main ways that the Qur'an has often functioned scripturally in the lives of Muslims past and present.

**NOTE:** It is not the purpose of this course to attempt to persuade you to adopt or reject any particular religious viewpoint. This course presupposes that students accept that the Qur'an will be studied using critical methods that are employed in a modern research university when examining <u>any</u> text, religious or otherwise.

#### **Learning Objectives**

By the end of the course, students should be able to:

- distinguish between primary and secondary sources and engage with the Qur'an as a primary source
- distinguish among descriptive, explanatory, and prescriptive modes of discourse about the Qur'an
- correctly use the categories and terms employed by Quranic Studies scholars
- give an introductory overview of key debates in Quranic Studies today
- describe the structure, literary features, and main themes of the Qur'an
- discuss ways that different historical, socio-political and cultural contexts shape the meanings of scriptures for religious communities

#### **Required Course Readings**

- All assigned readings are available through cuLearn. In order to access most of these readings anywhere other than campus, you must be signed in to the off-campus login on the library web page.
- The following translation of the Qur'an is highly recommended: *The Qur'an: A New Translation*, trans. M.A.S. Abdel Haleem (Oxford University Press, any edition).

#### **Course Evaluation**

Your final grade will be determined by the following:

- Reading responses (8 responses x 5 marks each)—40%
- Film response assignment—15%
- Midterm exam (take-home)—20%
- Final exam (take-home)—25%

**NOTE:** The assigned readings <u>and</u> the online classes are essential parts of this course. The readings cannot substitute for the online classes—or *vice versa*. Some course materials will only be covered in class. It is expected that all students will attend class regularly, having already done the readings.

#### **Reading responses**

Ten classes in total (Sept. 17 and 24; Oct. 1, 8, 15, and 22; Nov. 12, 19 and 26; Dec. 3) will have reading response questions, which deal with topics drawn from or related to the assigned readings for that class. The response should be no more than 1-2 paragraphs in length. You can choose to answer any 9 of these (the lowest mark will be dropped). These questions will be announced during the online portion of the class, and you will have until 6 pm on that day to upload your answers. **These questions are to be your own individual work, and the wording must be your own** (the point is to demonstrate that you have understood the material; **do not** cut and paste answers from the course readings, or from any other source). No substitutions for the reading responses will be permitted.

#### The film response assignment

This assignment (4-5 pages max.) is a written response to a documentary film in light of two of the assigned readings. More detailed instructions will be posted on cuLearn and discussed in class. It is due on the date specified in the syllabus.

#### **Exams**

Both the midterm and the final exams will contain short answer and essay questions. They are take-home and open book. All answers must be in your own words (<u>do not</u> cut and paste from the course readings or from any other source). **Both exams are to be completed on your own**. Exams must be written and uploaded on the day and within the time frame specified.

## Academic Integrity at Carleton

The University Senate defines **plagiarism** as "presenting, whether intentionally or not, the ideas, expression of ideas or work of others as one's own." This can include:

- reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another's data or research findings;
- failing to acknowledge sources through the use of proper citations when using another's works and/or failing to use quotation marks;

• handing in "substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs." Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course

# Deferred Term Work

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

1. Students who claim illness, injury or other extraordinary circumstances beyond their control as a reason for missed term work are held responsible for immediately informing the

instructor concerned and for making alternate arrangements with the instructor and in all cases this must occur no later than three (3.0) working days after the term work was due. The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.

2. In cases where a student is not able to complete term work due to illness or injury for a significant period of time/or long term, the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.

#### Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

- 1. be made in writing to the Registrar's Office no later than three working days after the original final examination or the due date of the take-home examination; and,
- 2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination.
