**Course Description**

This course introduces the Quran through a careful study of its content, form, style, central themes, and process of canonization. Emphasis will also be placed on the Quran's vast interpretive tradition (*tafsir*), as well as the various ways in which scholars attempt to understand the Quran's textual history and its various stylistic and linguistic features.

## Assignment 1

### Instructions

Carefully read “The Islamization of Old Arab Virtues” by Toshihiko Izutsu and answer the following question: How did the Quran’s message radically alter the ethical and religious worldview of the pre-Islamic Arabs?

### Value

The paper is out of 25, and is worth 25% of the total course mark.

### Due Date

Papers are due via email submission on **January 29<sup>th</sup>**.

### Late Assignments

Papers submitted late due to medical or other compassionate reasons must be accompanied by relevant documentation.

### Form

1. Your paper should be **six** full pages in length, double spaced, and written in Times New Roman font (size 12).
2. Diction is to be formal, and each piece is to be written in Canadian English. Grammar, syntax, spelling, and style must be impeccable. You may write in the first person.
3. At the top right of the first page of your paper, include the course code, your full name, and the assignment’s due date. This should be in Times New Roman font (size 12).
4. When citing materials, please follow the *Chicago Manual of Style*.

## Assignment 2

### Instructions

Carefully read 50 pages from any part of Maybudi's monumental Persian Sufi commentary upon the Quran entitled *Unveiling of the Mysteries*. The translator's introduction and notes should be consulted in order to make sense of the book's content. After you have read the relevant portions of the book, write an essay that addresses the following question: What is the role of love in Sufi Qur'anic exegesis?

### Value

The paper is out of 35, and is worth 35% of the total course mark.

### Due Date

Papers are due via email submission on **March 11<sup>th</sup>**.

### Late Assignments

Papers submitted late due to medical or other compassionate reasons must be accompanied by relevant documentation.

### Form

1. Your paper should be **seven** full pages in length, double spaced, and written in Times New Roman font (size 12).
2. Diction is to be formal, and each piece is to be written in Canadian English. Grammar, syntax, spelling, and style must be impeccable. You may write in the first person.
3. At the top right of the first page of your paper, include the course code, your full name, and the assignment's due date. This should be in Times New Roman font (size 12).
4. When citing materials, please follow the *Chicago Manual of Style*.

## Assignment 3

### Instructions

Drawing on the class lectures and required readings, address **both** of the following topics. Use appropriate examples to illustrate your points.

1. Offer an account of the Quran's depiction of the end of time and the afterlife.
2. Recount the story of Joseph as told in Q 12, paying particular attention to the various Quranic exegetes' interpretations of its most salient features.

### Value

Each question is out of 20 and is worth 20% of the total course mark. Thus, your entire paper is out of 40 and is worth 40% of the total course mark.

### Due Date

Papers will be due via email submission on **April 8<sup>th</sup>**.

### Late Assignments

Papers submitted late due to medical or other compassionate reasons must be accompanied by relevant documentation.

### Form

1. **Each** of your answers should be **four** full pages in length, double spaced, and written in Times New Roman font (size 12). So the total number of pages for this assignment is **eight** pages.
2. Diction is to be formal, and each piece is to be written in Canadian English. Grammar, syntax, spelling, and style must be impeccable. You may write in the first person.
3. At the top right of the first page of your paper, include the course code, your full name, and the assignment's due date. This should be in Times New Roman font (size 12).
4. When citing materials, please follow the *Chicago Manual of Style*.

#### Academic Integrity Policy

The University Academic Integrity Policy defines **plagiarism** as “*presenting, whether intentionally or not, the ideas, expression of ideas or work of others as one’s own.*” This includes reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source. Examples of sources from which the ideas, expressions of ideas or works of others may be drawn from include but are not limited to: books, articles, papers, literary compositions and phrases, performance compositions, chemical compounds, artworks, laboratory reports, research results, calculations and the results of calculations, diagrams, constructions, computer reports, computer code/software, material on the internet and/or conversations.

#### **Examples of plagiarism include, but are not limited to:**

- any submission prepared in whole or in part, by someone else, including the unauthorized use of generative AI tools (e.g., ChatGPT);
- using ideas or direct, verbatim quotations, paraphrased material, algorithms, formulae, scientific or mathematical concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings without appropriate acknowledgement;
- submitting a computer program developed in whole or in part by someone else, with or without modifications, as one’s own; and
- failing to acknowledge sources through the use of proper citations when using another’s work and/or failing to use quotations marks.

Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.

### ***Co-operation or Collaboration***

An important and valuable component of the learning process is the progress a student can make as a result of interacting with other students. In struggling together to master similar concepts and problems and in being exposed to each other's views and approaches, a group of students can enhance and speed up the learning process. Carleton University encourages students to benefit from these activities which will not generally be viewed as a violation of the Policy. With the exception of tests and examinations, instructors will not normally limit these interactions.

#### Deferred Term Work

In some situations, students are unable to complete term work because of extenuating circumstances beyond their control, which forces them to delay submission of the work. Requests for academic consideration are made in accordance with the [Academic Consideration Policy for Students in Medical or Other Extenuating Circumstances](#).

1. Students who claim short-term extenuating circumstances (normally lasting up to five days) as a reason for missed term work are held responsible for immediately informing the instructor concerned and for making alternate arrangements with the instructor. If the instructor requires supporting documentation, the instructor may only request submission of the University's self-declaration form, which is available on the [Registrar's Office website](#). The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule.
  - a. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.
2. In cases where a student is not able to complete term work due to extenuating circumstances lasting for a significant period of time/ long-term (normally more than five days), the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.
3. If a student is concerned the instructor did not respond to the request for academic consideration or did not provide reasonable accommodation, the student should follow the appeals process described in the Academic Consideration Policy.
4. If academic consideration is granted, but the student is unable to complete the accommodation according to the terms set out by the instructor as a result of further illness, injury, or extraordinary circumstances beyond their control, the student may submit a petition to the Registrar's Office

(undergraduate courses)/Graduate Registrar (graduate courses). Please note, however, that the course instructor will be required to submit an earned final grade and further consideration will only be reviewed according to established precedents and deadlines. #### Deferred Final Exams

Students who are unable to write a final examination because of extenuating circumstances, as defined in the [Academic Consideration Policy](#), may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

1. be made in writing to the Registrar's Office no later than three (3) working days after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation. In cases of short-term extenuating circumstances normally lasting no more than five (5) days, students must include the University's self-declaration form, which can be found on [the Registrar's Office website](#). Additional documentation is required in cases of extenuating circumstances lasting longer than five (5) days and must be supported by a medical note specifying the date of onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office [here](#).

#### Financial vs. Academic Withdrawal

Make sure that you are aware of the separate deadlines for Financial and Academic withdrawal!

Making registration decisions in Carleton Central involves making a financial and academic commitment for the courses you choose, regardless of attendance. If you do not attend, you must withdraw in [Carleton Central](#) within the published deadlines to cancel your registration. A fee adjustment is dependent on registration being canceled within the published [fee deadlines](#) and dependent on your course load. A course dropped after the deadline for financial withdrawal will receive a grade of Withdrawn (WDN), which appears on your official transcript.

Even if you miss the deadline for financial withdrawal, you might decide to drop a course to avoid a failure or a poor grade showing up on your student record and bringing down your CGPA. It is your responsibility to drop the course via Carleton Central within the published [deadlines](#) (see Academic Withdrawal).

If you are considering withdrawing from a course, you may want to talk to an advisor first. Course withdrawal may affect your student status, as well as your eligibility for student funding, immigration status, residence accommodation and participation in varsity sports, etc. Additionally, remember that once you choose your courses, you must use the “Calculate amount to pay” button to determine the correct amount of fees to pay.
