Course Description

This asynchronous online course discusses the question '*What is religion?*' using facts, concepts, and diverse approaches to religion in China, Japan, and Korea. The range of ancient traditions and contemporary movements includes Ancestral Rites, Confucianism, Daoism, Shintō, Zen Buddhism, Pure Land Buddhism, Christianity, and Feminism. Each topic is studied through multiple modalities to facilitate success on assignments and hone communication skills.

Learning Outcomes

1. Distinguish between the various beliefs, practices and historical contexts of East Asian religions;
2. Describe beliefs, practices and historical contexts of East Asian religions in coherent prose using the support of interpretive categories such as context, style, point of view and theme;
3. Distinguish between primary and secondary sources and use them appropriately to discuss beliefs, practices and historical contexts of East Asian religions;
4. Distinguish between and apply different generalized theoretical approaches to primary and secondary sources pertinent to East Asian religions;
5. Reflect on and identify how the use of different theoretical approaches in combination with one's personal situatedness impacts one's learning.

Course Assessment

Quizzes

10 x 2% = 20%

At the end of each content-based module of this course, students have two tries to successfully complete an automatically graded quiz each comprising 1-10 questions in multiple choice or drag and drop format. Each quiz will close at the end of the time period assigned to its module, as indicated in the schedule below.

Discussion Participation

2 x 20% = 40%

Students discuss how to best apply the assigned reading in order to explain a video of their choice. For each discussion, students choose to join one Topic Group and then post and reply according to the Guidelines for Discussion Forums (see below in 'Instructor's Policies'). Each student will participate in two (2) discussions over the course of the semester.

Learning Reflections Proposal Sheet

10%

Over the course of the semester, students have six (6) reflection topics to choose from so that they can reflect on how the diverse general approaches we are using to study religion affect their learning. Near the end of the course, students are asked to submit a Proposal Sheet answering questions about how they will approach one (1) of these reflection topics.

Learning Reflections Take-Home Exam

30%

Using the feedback on their Proposal Sheet as a point of reference, students write on the reflection topic chosen therein for their Take-Home Exam. The format for the take-home exam is flexible and can be entirely written, entirely video or include a mix of visual, audio, and textual media, with the option of creating an ePortfolio. The length is flexible depending on the format, but each exam must contain a very minimum of five (5) relevant historical facts and/or concepts from the course module about the religion chosen as a topic and at least five (5) page references to the relevant assigned readings in the Ares online Library Reserves.

Instructor's Policies

Lateness. The policies regarding lateness are specific to each form of assessment:

- Discussion Participation involves time-sensitive interactions with others. There is no late penalty for signing up to a group or making an initial post late, but all posts must be complete for grading by the reply deadline, unless a student is granted late registration or has documented proof of mental/physical illness or personal crisis. In these cases, a make-up assignment can be arranged to replace a Discussion Participation grade.
- The Learning Reflections Proposal Sheet has a late penalty of one grade point (A to A-, A- to B+) after the due date and then every 24-hour period afterwards, unless there is documented proof of mental/physical illness or personal crisis.
- The Learning Reflections Take-Home Exam is submitted in place of a formal exam and so students must arrange for a formal deferral if they are unable to submit this exam by the end of the examination period.

N.B. For all assignments, lateness for reasons of individual technical errors must be penalized equally for lateness, and so students are advised to double-check their online submissions by closing their browsers after submission and then re-opening their submitted assignments on cu Learn to make sure that the correct item has been successfully uploaded.

Appeals

If a student judges any mark on an assignment to be unfair, then appeals must be made within two weeks after the distribution of the mark. Unless the mistake is a calculation error, the grade appeal must include a paragraph written by the student to

explain why a better mark is justified with reference to the relevant grading rubric provided within the Assignment Descriptions module.

E-mail

The instructor is committed to responding to student e-mails within 48 hours. If you do not receive a response within that time frame, then there is the strong possibility of a technical error, so please re-send the e-mail. If a student asks a question that is not of a private nature, and that the instructor feels would benefit everyone, then students are encouraged to post their questions in the Ask Your Instructor discussion forum on the course webpage, so that everyone can benefit from the answer.

Discussion Forum Guidelines

These guidelines will be used to evaluate the quality of all contributions to the weekly Discussion Forums.

DO

- When expressing an opinion, use phrases like “The way I understand it” or “From what I’ve read” to show other students that you are open to discussion.
- Include specific examples to support your opinion, especially when agreeing or disagreeing with someone else’s post
- Both when posting and when replying, make new connections between the discussion topics and the assigned readings by referring to specific pages in the readings (e.g. Woo 2014, 268).
- Include thoughtful questions to show that you care what your classmates think.

DON'T

- Copy material from other course participants’ posts. If you’re not sure what you can add, contact the instructor or Academic Advising for support.
- Post about things that are completely unrelated to the coursework, like your personal plans for the weekend.
- Insult or make fun of posts or use sarcasm. If you disagree with a post, then explain why in a constructive and empathetic manner, i.e. Remember the Human: if you wouldn’t say it to someone’s face, then don’t say it online.
- Get involved in flame wars—especially not over issues of spelling, grammar, FAQs, and so on. If things do flame up, remember that you can stand by what you said and still apologize for the way in which you said it.
