Course Description:

The course continues on from RELI 1015, Introduction to Sanskrit I. In it we hope to cover chapters 10-18 of our grammar, the *Devavāṇīpraveśikā*. Successful completion of RELI 1015 is needed to register for this course. By the end of this course students should have a strong enough knowledge of Sanskrit to read classical Sanskrit with the assistance of a dictionary.

Required Texts:

Devavāṇīpraveśikā: An Introduction to the Sanskrit Language, second edition, revised. Delhi: Motilal Banarsidass, 2009.

- The text book is **not** available through the Carleton book store. Students should buy the book on-line via Amazon.ca (also check the US and UK Amazon sites for availability), or abebooks etc
- Motilal Banarsidass is the latest publisher for the book. Before Motilal it was published by the University of California. If you find a used edition from Uni of California it will be fine to use in the class

Course Requirements and Evaluation:

1. Attendance, participation and homework checks (20%) Students will receive a grade for attendance and for participation when homework is taken up. Students who are absent or who come to class without completed homework will be penalized.
2. Quizzes (20%) There will be quizzes on each of the nominal and verbal paradigms taught in the course. With the exception of the first class, there will be at least one quiz per class.
3. Tests (30%) There will be a test at the end of each chapter, though in some cases tests may cover two chapters. Students should expect about six to seven tests over the course of the class, at least one test a week.
4. Final exam (30%) The final exam will be written in the formal examination period and will be scheduled by examination services.

General Notes on Evaluation:

1. Please see “Regulations Common to all Humanities Courses” attached to the syllabus for policy on plagiarism, grading systems, requests for academic accommodation and petitions to defer.
2. Missed tests, quizzes, exams and assignments can only be made up if the student supplies adequate written documentation (i.e., a doctor’s note, an obituary) for the absence.
3. Attendance and completing the assigned homework is very important for success in this course. The course compresses 12 weeks of work into 6 weeks; hence, missing class or falling behind doubles the amount of work a student has missed if they fail to attend and do the assigned work.

PLAGIARISM

The University Senate defines plagiarism as “*presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “*substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.*”

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of “F” for the course
