Course Description:

Course will look at Greek religion in context of shrines and sanctuaries as there is remarkable variety in dates of construction and use, purpose, and integration with local community or wider Greek world. Second part of course will examine in detail the three surviving Greek liturgies (a) Homeric Hymns, (b) Orphic Hymns and (c) Hymn to Isis that were sung at festivals, with performance, as well as Pindar's epinician (victory) odes that were commissioned for victors at games sponsored by the more important of the sanctuaries.

Deferred Term Work

Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. The application for a [deferral](#) must:

1. be made in writing or online to the Registrar's Office no later than **three working days** after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination.
