### Course Description

The famous Muslim mystic Jalal al-Din Rumi (d. 1273) has been hailed by many as the greatest love poet of human civilization. The work of this seminar will attempt to understand why that is the case. We will do so by engaging in an in-depth examination of Rumi's teachings on love, cosmology, use of symbolism, metaphysics, spiritual psychology, and poetic art through a detailed study of his writings (in translation), situating them in their appropriate religious, historical, and cultural contexts.

### Learning Objectives

*By the completion of this course, the student will be able to:*

- ❖ Apply a theoretical perspective to a primary text
- ❖ Formulate and defend a thesis based on advanced research
- ❖ Recognize different modes of interpretation and be familiar with hermeneutics
- ❖ Articulate the debates within the field of the academic study of religion concerning both theories of religion and methods in the study of religion
- ❖ Write a well-researched academic paper on a topic in religious studies that is free of grammatical and syntactical errors and uses proper citation and bibliographic style
- ❖ Become acquainted with the field of Persian Sufi literature
- ❖ Understand the methods employed by scholars in studying Sufi poetry

## **Guidelines for Exegetical Exercise**

### **Instructions**

Write a **five** page double-spaced paper on **any single theme of your choice** from the assigned texts in Rumi's writings which are translated in *The Sufi Path of Love*. The half of your assignment will offer a general summary of the passages in question, and the second will offer an analysis of Rumi's arguments, with respect to their form and coherence, in these texts. This assignment is designed to provide you with an opportunity to think critically about Rumi's poetry. It will also prove to be very beneficial in preparing for your final paper.

### **Evaluation**

This assignment is out of 20 and is worth 20% of the total course mark. For a good grade, you have to (1) offer an effective summary of the texts in question; and, most importantly, (2) demonstrate to me, through your analysis of the work, that you have given considerable thought to the issue(s) raised by the author.

### **Due Dates**

Papers are due via email submission at **8 am on February 14<sup>th</sup>, 2021**.

### **Penalties**

Papers submitted late due to a medical or other compassionate reason must be accompanied by relevant documentation (i.e., a medical certificate, etc.). Plagiarized essays will be assigned a zero, and the issue will be taken up with the Faculty of Arts and Social Sciences.

## Research Paper Guidelines

### Instructions

Write an **eighteen** page double-spaced paper on any aspect of Rumi's thought, poetry, art of story-telling, etc. as enshrined in one or more of these three works (all of which are available on the course site): *Signs of the Unseen*, *Masnavi, Book 1*, and *Swallowing the Sun*. You must decide on your paper topic before reading week. The literature on Rumi—both primary texts in translation and secondary studies—is vast. Consult with me when you have an idea of the kind of topic that interests you and I will be happy to point you to relevant materials for your research.

### Evaluation

Essays are graded out of 80, and are worth 80% of the total course mark. Each essay will be evaluated in terms of (1) the clarity of its thesis, (2) the coherence of its argument(s), and (3) evidence of original research and its careful integration into the fabric of the essay.

### Due Date

Essays are due via email submission at **8 am on April 8<sup>th</sup>, 2021**.

### Penalties

Papers submitted late due to a medical or other compassionate reason must be accompanied by relevant documentation (i.e., a medical certificate, etc.). Plagiarized essays will be assigned a zero, and the issue will be taken up with the Faculty of Arts and Social Sciences.

## Deferred Term Work

---

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

1. Students who claim illness, injury or other extraordinary circumstances beyond their control as a reason for missed term work are held responsible for immediately informing the

instructor concerned and for making alternate arrangements with the instructor and in all cases this must occur no later than three (3.0) working days after the term work was due. The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.

2. In cases where a student is not able to complete term work due to illness or injury for a significant period of time/or long term, the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.

## Deferred Final Exams

---

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

1. be made in writing to the Registrar's Office no later than three working days after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination.
