# Course objectives

In this information age, the use of visualizations is increasing every day. With the growing number of visualizations, visualization literacy, the ability to read, interpret, and create data visualizations is becoming as important as reading and writing texts. Everyone needs to have visualization literacy to avoid misuse and misinterpretation of data visualizations. Visualization literacy does not only include reading and interpreting data representations, but it also includes the ability to critically review, effectively interact, carefully design and develop data visualizations.

In this course, we will go over visualization principles, showcase examples of standard visualizations, and the steps needed to design and develop a comprehensive data visualization. I will advise students on all the necessary steps from ideation to the final delivery of their project. As delivering a working data visualization is one of the main goals of this course, we do not have an examination for this course. Rather, the student evaluation throughout the term is divided into their performance in-class activities, their assignments (i.e., literature review, visualization topic presentation), and all steps of the visualization design project.
