The normal requirement for admission to the master's program is an honours degree (or equivalent), with at least a B+ average.

For admission to the program, applicants should normally meet the following requirements:

- A four-year degree (or equivalent) in a humanities or social science discipline, with demonstrated coursework in at least 3.0 credits in the European/Russian/Eurasian area, ideally covering multiple area covering three different disciplines (not solely language (excluding language courses); and

 (normally equivalent to two academic years of instruction, or one year with an intensive summer program).

 Applicants may be admitted with no proficiency or inadequate proficiency in an appropriate language; in this case they must be prepared to undertake language will require additional language training during the course of the MA program in addition to fulfilling the beyond normal M.A. requirements.

Practical experience in the area of study will also be taken into consideration.

Applicants who do not have the required interdisciplinary background in the European/Russian/Eurasian area are encouraged to apply to the program, but additional coursework beyond the 5.0 credits may be required.

Accelerated Pathway

The accelerated pathway in the Institute for European, Russian and Eurasian Studies is a flexible and individualized plan of graduate study for students in their final year of a Carleton undergraduate degree.

Students in their third-year of study in a Carleton undergraduate degree should consult with both the Undergraduate Advisor in their program of study and the Graduate Advisor in EURUS to determine if the accelerated pathway is appropriate for them and to confirm their selection of courses for their final year of undergraduate studies.

Accelerated pathway requirements

- 1. At least 1.0 credit in EURUS courses (5000 level or higher).
- 2. Minimal overall CGPA of at least A-.

Students may receive advanced standing with transfer of credit of up to 1.0 credit which can reduce their time to completion.

Qualifying Year

Applicants who have a general (three-year) bachelor's degree in one of the disciplines represented in the program, or who lack sufficient area studies or language training, may be admitted to a qualifying-year program designed to raise their status to that of honours graduates in European, Russian and Eurasian Studies. Students are expected to achieve a B+ average or better in the qualifying-year program in order to qualify for admission to the Master's year.

New Resources	No New Resources
Summary	Minor update of the section on Admission Requirements.
Rationale for change	The admission requirements outlined in the calendar are in some respects stricter than the ones that have actually been applied by the MA admissions committee in recent years. We have not enforced the requirement of undergraduate training in three relevant disciplines; students without an adequate language background have not been discouraged from applying. We have developed mechanisms in the MA degree to ensure that interdisciplinary knowledge and language skills can be obtained during the MA degree. We are concerned that the outdated section on Admission Requirements might discourage qualified candidates from applying for the MA program. The point is that students who are admitted with no language must be ready to make an extra commitment to language training, and we want to be upfront about this.

 - Learning outcomes
 - Enhanced abilities to examine within thesis issues of public policy from the perspectives of multiple disciplines.
 - Enhanced abilities to address within thesis analytical challenges to the study of public policy (e.g., why particular explanatory, interpretive and normative research questions are asked; and why particular theories, units of analysis, concepts, methods and data are used)
 - Enhanced abilities to apply within thesis appropriate research methods.
 - the rationale for the major modification;
 - The modifications address the two recommendations made by the ERC as part of the 2013-14 Cyclical Review of the PhD Public Policy, namely:
 - To provide a more interdisciplinary experience within and across the core courses;
 - To include a course (or other means) to provide students with suitable research tools.
 - In August 2016 the SPPA Faculty Retreat included a session dedicated to the need for and direction of curricular changes to the PhD Public Policy – bearing in mind the ERC priorities. The greater emphasis on interdisciplinary approaches and research tools within the core courses was recognized as allowing for a better match between the research interests and preparation of the students, and the fields of expertise of the School's faculty – particularly its junior members.

- the effect of the major modification on the existing program, including the effect on prospective and continuing students. This discussion should include an implementation plan, as appropriate.
 - Over the 2018 Winter and Summer terms, the three faculty members appointed to deliver the three revised required courses dealing with public policy analysis will design the courses in consultation with each other to identify linkages, avoid gaps or overlaps, and ensure interdisciplinary nature of each course. Draft syllabi will be presented at 2018 SPPA Faculty retreat (to be scheduled in Summer).
 - Students in the process of completing PhD under previous Calendars will have the choice either of (1) continuing with the old curriculum (by not completing a graduate course in research methods and by using the new required courses to satisfy the old requirements following the preclusion linkages), or of (2) transferring to the new curriculum (by completing a graduate course in research methods and by using the completed old required courses to satisfy the new requirements following the preclusion linkages). We will work with FGPA to ensure that the change in thesis credit will not inhibit the ability of in-progress students to graduate successfully.

2. Current International, National, and/or Provincial Profile

- Provide an account of how the proposed program/major modification relates to the current international, national and provincial profiles of similar programs in the discipline or interdisciplinary area.
 - Public policy although a recognized area of study is not a uniform discipline. Although the curricula and design of corresponding doctoral programs overlap in many respects, they remain distinct products of their provenance and location whether in political science departments, business schools, or schools of public affairs or public policy. In revising the PhD Public Policy, the School took the strategy not to emulate or rival any particular program elsewhere. Instead, it framed a program that would allow all its faculty particularly its younger members to deliver the core courses and to attract and supervise students in their fields of expertise and interest. Accordingly the three required courses in (PADM 6010, 6011 and 6012) have been reconceived as interdisciplinary examinations of public policy from the broad coordinating perspectives of what, why and how courses that a range of faculty, from a range of disciplinary backgrounds, could adapt and deliver.

3. Mission and Strategic Directions

- Describe how the proposed program/major modification supports and furthers Carleton's mission, Strategic Integrated Plan (SIP) and Strategic Mandate Agreement (SMA).
 - The proposed revisions adapt the PhD Public Policy so as to draw upon the teaching acumen of more of its faculty, and to attract and prepare students who wish to work with faculty known in their fields of expertise. Those fields correspond to many of the areas of public policy that are prominent both in Canada and internationally: climate change and sustainability; Indigenous policy and governance; securing an enabling environment for the third sector; international governance; health and social policy; digital technologies and policy formation.
 - Accordingly, the revisions support the Strategic Integrated Plan 2013-18, for example, by securing
 "Public Policy, Administration, and Governance" as a basis of institutional strength, and by
 supporting Carleton's distinctiveness as a centre for "interdisciplinary research in a number of
 areas, including the translation of science and technology into policy and regulation".
 - According, the revisions support all four strategic themes of the Strategic Integrated Plan: namely that Carleton be known –
 - for its research and teaching in programs which respond to the needs of society today and which anticipate the needs of the future;
 - for promoting research excellence and connectedness;
 - for linking its academic endeavours to empower students as productive and engaged citizens in an increasingly diverse world; and
 - for nurturing leadership, encouraging innovation, recognizing achievement and embracing sustainability.

4. Impact on Other Programs

 - Relative to the status quo, the changes will not affect the delivery of other academic programs and vice versa. As in the existing program, students are able to take specialization courses from other departments and schools – with permission from those units.

o The revisions – by making the required core courses more interdisciplinary – will accommodate a wider range of student backgrounds and areas of interest, better allowing them to work with particular faculty members in their fields of expertise. A better match between the research interests of students and the expertise of faculty will better prepare graduates to enter job markets in which their supervisors are known and respected.

 - o No net new resources are needed. The required courses that have been added (PADM 6010, 6011, 6012, 6013) are matched by the required courses deleted (PADM 6111, 6112, 6113, 6114). The graduate research methods course (PADM 5218) that has been added is annually delivered for MPPA students. The revised Doctoral Seminar (PADM 6201) involves no new resources (it replaces the deleted PADM 6200), but confirms that students should start working with their thesis supervisors in second year.

Three subsequent Action Plans submitted to CUCQA outline the comprehensive but interrupted process by which the School has responded to these recommendations. That process culminated in two proposals approved by the School's Management Committee in April 2017.

Rationale for deactivation

The first was to introduce three reconfigured core courses, each of which would provide an interdisciplinary examination of an aspect of public policy making: explanations of what and why (PADM 6010); the normative ends (PADM 6011); and the institutional means (PADM 6012). In early Summer, a committee comprising senior and junior faculty developed course descriptions that made explicit the move away from a bi-disciplinary Economics/Political Science approach to one that would be sufficiently broad such that different instructors with different disciplinary backgrounds and interests could see themselves teaching.

The second proposal was to introduce new required courses that would cover research design (PADM 6013), research methods, and an immediate opportunity to apply these (PADM 6904) in preparation for the PhD Thesis.
