### 1. CALL TO ORDER

The Chair called the meeting to order at 2:00 p.m.

### 2. APPROVAL OF AGENDA

The Chair noted that one item was left off the agenda under Reports for Information, and that there was one spelling error on the agenda. It was **MOVED** (C. Miller, A. Arya) that Senate approve the agenda for the meeting of Senate on November 24, 2017, with corrections. The motion **PASSED**.

### 3. APPROVAL OF MINUTES

The Chair noted two additions to be made in the minutes under the attendance record. It was **MOVED** (E. Grant, P. Smith) that Senate approve the minutes of the Open Session of the Senate meeting on October 27, 2017, with these modifications.

The motion **PASSED**.

### 4. MATTERS ARISING

There were none.

### 5. CHAIR'S REMARKS

- **Carleton University at Queen's Park** The Chair noted that there were significant follow-ups from the Ministry of Indigenous Relations and Reconciliation after Carleton's visit to Queen's Park in October. We can expect a positive impact on some of our programs and more opportunities for student internships as a result of this visit.
- **Convocation** The Chair extended a special thank-you to faculty and staff from the platform party for attending Convocation and showing a strong level of support for graduating students. Dean Matthias Neufang was given special recognition for accurately reading all of the graduate students' names at both ceremonies.
- Career Readiness Fund Phase I \$740,000 in work opportunities has been awarded for student experiential learning. We have applied for a similar amount for Phase II, which will provide funding for students with disabilities. Additional funding for mental health will be used for counselling for Indigenous students and for FITA programs (From Intention to Action).
- Algonquin College Strike The strike has affected 500+ Carleton students registered in joint programs between Carleton University and Algonquin College. 40% of the coursework in these programs normally is provided at Algonquin College. To ensure that students do not lose their term, faculty and staff on both sides have changed the delivery of the Algonquin College component. Individual timetables have been sent to students, and they are able to apply for strike relief funds as promised by the

government. There is no need for Senate action because we were able to make individual accommodations for the students and did not require scheduling or programmatic changes that would affect the progress of students in the future. The Chair thanked Lorraine Dyke and Chris Joslin for their work on this issue.

# 6. QUESTION PERIOD (Chair)

There were no questions submitted in advance or from the floor.

### 7. ADMINISTRATION (Clerk of Senate)

### • Senate and Senate Committee appointments

Two new Contract Instructor representatives to Senate won their positions through an election held November 12 - 13. The Clerk introduced them and welcomed them to Senate.

In addition, the Clerk reported that one undergraduate student had been nominated to fill a vacancy on the Senate Review Committee.

A Senator asked why Senate needs to approve these appointments if an election has been held. The Clerk clarified that Senate's job is to ratify the appointments and announce them to the Senate body.

It was **MOVED** (D. Russell, D. Long) that Senate ratify the new Senate and Senate Committee appointments, as presented. The motion **PASSED**.

The Clerk also announced that if there is no formal business for the December meeting of Senate, it may be cancelled. A decision will be made on December 5<sup>th</sup> and will be communicated to Senators.

### 8. REPORTS

# a) SAPC Senate Academic Program Committee (Tomberlin)

# 1. MSc in Management – New Program Approval

J. Tomberlin outlined the process for new program approval. A Senator asked why the name of the degree was changed from MMS to MSc, given the lack of science courses in the M.Sc. in Management program. L. Dyke replied that the M.Sc. reflects the research focus of the degree, and is more consistent with other programs. M. Neufang concurred that the M.Sc. is a reflection of common practice for naming such degrees at other universities in Canada.

It was **MOVED** (J. Tomberlin, L. Schweitzer) that Senate approve the proposed M.Sc. program in Management to commence with effect from Fall 2018. The motion **PASSED**.

### 2. Graduate & Undergraduate Major Modifications – 2018 – 19 Calendar Curriculum Proposals

OMNIBUS MOTION:

It was **MOVED** (J. Tomberlin, S. Klausen) that Senate approve the major modifications for the Master of Arts in European, Russian and Eurasian Studies program, the Master of Arts in Art History program, the PhD in Public Policy program, and the Master of Cognitive Science program as presented with effect from Fall 2018. The motion **PASSED**.

# 3. Final Assessment Reports and Executive Summaries (CPR)

### OMNIBUS MOTION:

It was **MOVED** (T. Tomberlin, W. Clement) that Senate approve the Final Assessment Reports and Executive Summaries arising from the Cyclical Program Reviews of the undergraduate and graduate programs in Art History, the undergraduate program in Food Science & Nutrition, and the undergraduate and graduate programs in Music, as presented. The motion **PASSED**.

# 8. REPORTS (continued)

# b) SCCASP Senate Committee on Curriculum, Admission and Studies Policy (H. Nemiroff)

It was **MOVED** (H. Nemiroff, L. Schweitzer) that Senate approve the Calendar Location stating the 3.5 minimum credits in a concentration and specialization in R-UG.4.6 as presented. The motion **PASSED**.

It was **MOVED** (H. Nemiroff, W. Clement) that Senate approve CAEL scoring changes in UG and GR calendars as presented. The motion **PASSED**.

H. Nemiroff also mentioned the inclusion of a statement in the calendar to clarify that recommended courses are recommended for coursework rather than for admission.

### c) SAGC Senate Academic Governance Committee (Clerk)

The Senate Academic Governance Committee considered the comments of Senators presented at the last meeting of Senate, and made the following further adjustments to the Terms of Reference for the Senate Emergency Academic Response Committee (SEARC):

- The two student representatives on the Committee will be elected from and by students serving on Senate
- Three faculty member positions have been added to make the committee more representative of Senate.

It was **MOVED** (D. Russell, C. Miller) that Senate approve the proposed revisions to the Terms of Reference for the Senate Emergency Academic Response Committee, as presented.

### Discussion:

Several senators asked about the definition of an "emergency" and noted that this was not addressed by the committee in the revisions. SAGC had suggested that the new SEARC could come up with a definition and bring it to Senate for discussion, debate and approval, but other Senators questioned whether a committee can determine its own Terms of Reference and procedures, and whether instead, this should be the purview of Senate.

It was also noted that the proposed composition of the committee excludes representation from the University Registrar. A representative from the Registrar has been listed as a resource, but would not be a voting member. Senators asked what the precedent would be for including staff in a non-voting position on an emergency committee. Others indicated that the definition of an emergency could help to determine who is needed on the committee.

Senators acknowledged that the membership of the Senate Emergency Academic Response Committee should be limited in number, but planning for emergencies could be done by a larger committee, or perhaps a working group.

The Chair noted that Senators are still asking for "emergency" to be defined as a first step, before membership is determined. Other Senators suggested that the Senate Academic Governance Committee could strike a working group themselves to discuss issues of membership and definition.

It was **MOVED** (L. Dyke, D. Long) that the revised Terms of Reference for the Senate Emergency Academic Response Committee be referred back to the Senate Academic Governance Committee for further deliberation. The motion **PASSED**.

J. Paulson asked if Senate could consider a motion to withdraw the authority of SEARC to meet and exercise responsibilities until Senate has agreed on a definition of what constitutes an emergency. J. Tomberlin called a Point of Order, indicating that a 2/3 vote of Senate would be required to add this motion to the agenda.

Senators were asked to vote on whether they would consider the motion introduced by J. Paulson. 22 voted for considering it, and 25 against. The motion was not added to the agenda for consideration.

#### Background

Following Faculty Board approval and, as part of academic quality assurance, major curriculum modifications are considered by the Carleton University Committee on Quality Assurance (CUCQA), the Senate Committee on Curriculum, Admissions and Studies Policy (SCCASP) and the Senate Academic Program Committee (SAPC) before being recommended to Senate.

#### Library Reports (as required)

- a. The committee approved the minutes from the meeting of the Senate Executive May 23, 2017
- b. The committee approved the minutes from E-polls with minor editorial corrections.

### 3. Approval of Senate agenda: September 8, 2017

The committee discussed the draft agenda for the next scheduled Senate meeting on September 8. The Clerk noted that there would be no report from SSCASP and that items from SAPC did not require immediate action from Senate. As a result, the committee decided to cancel the Senate meeting for September 8, and to roll over business from that meeting into the meeting scheduled for September 29. To avoid delaying Senate Committee nominee approval, a list of committee nominees will be circulated by email in early September to Senate members for approval via e-poll.

### 4. Action under the Summer Empowering Motion: SCCASP Motion

A memorandum was circulated regarding the use of students' work in quality assurance and accreditation reviews, and the need to inform students explicitly that their work may be used in this way. The memorandum included a statement, approved by SCCASP via e-poll, that would be added as a late calendar modification for 2017 - 18. Senate Executive was asked to approve the proposed statement.

Members discussed how students might opt out of this process. The committee decided that for existing students, requests to opt out would be accommodated on a case-by-case basis, as individual requests are submitted. New students entering Carleton from Fall 2017 on would not be able to opt out.

It was **MOVED** (B. Hughes, J. Tomberlin) to include the proposed statement "Use of Student Work in Program Assessment" as a late modification to the 2017-18 academic calendar.

The motion **PASSED UNANIMOUSLY**.

### 5. Items for discussion:

### a. FPA Board Secretary – attendance issue at Senate

According to governance rules, Faculty Board secretaries automatically become members of Senate. However, in at least one case this year the Faculty Board secretary is not able to attend Senate meetings due to scheduling conflicts. After a short discussion, the committee agreed that the Faculty in question (FPA) should be allowed to elect a separate member to serve on Senate.

### b. Committee Nominees – Review

Progress has been made in filling faculty-specific vacancies on Senate Standing Committees. The current list of nominees for committee memberships will be presented to Senate for approval.

For non-specific Faculty vacancies on the Senate Executive Committee and the Senate Student Academic Integrity Appeals Committee, the Provost has agreed to consult with the Deans regarding appropriate faculty members for nomination.

# c. Vacancy (Chair) for Senate Committee on Student Awards

A third faculty member is needed on this committee. The position of Chair is currently vacant, but the committee will choose its own Chair, once all of the faculty positions have been filled. The Provost has agreed to consult with Deans to find the right fit for this committee.

# d. Vacancy (Chair) for Senate Review Committee

The Senate Review Committee (formerly Senate Financial Review Committee) has recently been redefined with new Terms of Reference. It is currently in need of a Chair, which is elected by Senate. Committee members put forward the names of two faculty members currently serving on the committee – Raili Pollanen (Sprott) and Roshdy Hafez (FED) – as candidates for this position. The Clerk of Senate agreed to contact one or both to determine availability and interest.

### e. Nomination of a Senate representative for the Board of Governors

Alexis Shotwell (FASS) has been suggested as a possible candidate for this position. The Clerk of Senate will reach out to Professor Shotwell to gage her interest; if she is available and interested, her name will be brought forward with other nominees to the next Senate meeting.

# f. SMA for next Senate meeting

The Strategic Mandate Agreement will be circulated to Senate members for information, prior to the next Senate meeting. The Chair will speak to the SMA at the meeting.

### 6. Other Business

# a. Senate Representative for Chancellor Search Committee

The Board of Governors is moving forward in the search for a new University Chancellor, and a representative from Senate is needed on this committee. Committee members approved the Chair's suggestion that Interim Provost and Vice-President (Academic) Jerry Tomberlin be recommended for this position.

The Chair called the meeting to order at 11:07 am.

### 1. Approval of the Agenda

The committee approved the Senate Executive agenda for October 17, 2017.

### 2. Approval of the Minutes

The Committee approved the minutes from the meeting of the Senate Executive on August 29, 2017.

### 3. Rescission of PhD Degree (J. Tomberlin)

Jerry Tomberlin spoke to this item. The student in question completed a literature review which drew substantial content from just two papers, one of which was not cited in the review. The student was asked to rewrite the review but the revised edition still made inappropriate use of the material from the two authors. The thesis was still valid but the literature review remained unacceptable. The Provost recommends that the degree be rescinded, that the student be allowed to rewrite the literature review, and potentially be awarded the degree again after one year. Committee members agreed that this action is appropriate, since the penalty is serious, but not career ending.

It was **MOVED** (Tomberlin, Debanné) that the Senate Executive Committee rescind the degree of the named student and approve the penalty as described in the memo dated October 12, 2017 to the Executive Committee.

The motion **PASSED UNANIMOUSLY**.

# 4. Approval of Senate agenda: October 27, 2017

L. Dyke asked for the Algonquin College strike to be added to the agenda for Senate, since our students in the BIT program, which is a joint program between Algonquin College and Carleton University, are being adversely affected by the strike.

A discussion ensued regarding the potential role of the Senate Emergency Academic Response Committee (SEARC) in dealing with this issue. Some felt that the Terms of Reference for SEARC would allow it to operate in this circumstance, as it was meant to address the modification of academic rules and procedures in the event of an emergency. Other Senators maintained that this committee should only be used if Senate cannot meet and/or if we are prevented from meeting in large groups, which would happen in the event of an epidemic or terrorist attack. The Governance Committee had discussed modifying the TOR for SEARC in the wake of the CUPE 4600 strike last year. These recommendations were not brought to Senate but will be reviewed at the Governance meeting on Thursday October 19.

It was agreed to bring this item to Senate as an extra agenda item for the meeting on October 27, and to wait for the report from the Governance Committee before deciding on further action. It was also suggested that members of the SEARC committee might meet informally to discuss possible actions that would help students and mitigate the impact of the strike, but that any such actions would need to be approved at Senate.

The Committee approved the agenda for the meeting of the Senate on October 27, 2017, with modification.

[J. Tomberlin left the meeting.]

NOTE: Due to changing circumstances, the agenda item regarding the strike was removed from the main Agenda several days after Senate Executive met. It was addressed in the Chair's remarks.

# 5. Items for discussion:

a. <u>Student Senate and Senate Committee appointments</u>

D. Russell, with assistance from K. McKinley (Secretary of Senate) and Emily Grant (President of CASG) presented to the Committee the list of nominees for undergraduate student positions on Senate Standing Committees. Several positions were contested and nominations were received for almost all of the vacancies. The nominees were all verified to be in good standing and studying full-time at Carleton.

The Committee reviewed the list, applying the following guidelines to the process of matching students with positions:

- Any first year students were eliminated, as the AGU discourages first year students from serving on committees
- If a position is uncontested, the nominee is recommended for that position
- If possible, positions should be found for all nominees
- If two positions are available on a single committee, students from two different degree programs should be appointed, if possible.

The Committee arrived at a final list of recommendations to bring to Senate for approval on October 27.

Non-student committee appointments have mostly concluded, with the exception of the position of Chair for the Senate Review Committee, which still remains vacant. D. Russell agreed to send an email to Senators to ask for nominees for this position.

### b. SMA Process

D. Russell and K. McKinley have been tasked with bringing to Senate background documents about the first Strategic Mandate Agreement. Although the submission and final signed agreement have been found, there are no documents outlining the past SMA process. L. Dyke agreed to investigate.

### 6. Other Business:

### a. Call for Questions

The Call for Questions has been a required agenda item in Senate meetings for decades, as mandated in Senate Governance documents, but in recent years it has not been included on the agenda. The current President of Carleton would like to reinstate the Call for Questions as an agenda item, but Senate needs to be reminded of the process for using this item. The Call for Questions works best when Senators submit their questions in advance of the Senate Executive meeting (about two weeks before Senate meets). Questions then would appear in the package circulated a week prior to the Senate meeting. This allows the President (or other Senators called on to answer) enough time to properly prepare a response and to present it in the Senate meeting, thus building in efficiency.

This was discussed and supported by the Senate Executive Committee. D. Russell agreed to present this plan to the President for his approval.

# b. <u>Chair for Senate Review Committee</u>

The Senate Review Committee replaces the Senate Financial Review Committee. Its expanded mandate allows it to engage in a wide variety of problems and issues, in addition to the budget review.

D. Russell has agreed to send an email to Senators in an effort to find a volunteer/nominee for this role. The Committee proceeded to brainstorm potential names to bring forward. L. Dyke suggested Anne Bowker as a potential candidate.

### 7. Adjournment

**a.** The meeting was adjourned at 12:16 pm.
