Questions regarding the Carnegie Classification presentation on May 31, 2019

- 1. What does it cost Carleton, in terms of both financial and staffing resources, to receive and then to maintain the classification?
- 2. What will be expected of Carleton in order to keep the classification?
- 3. a) Will there be any top-down requirements on how faculty incorporate community engagement into their classrooms or programs?
- b) Will any decision-making powers (from, e.g., Senate or Faculty Boards) regarding community engagement's relationship to our academic mission be subsumed by this program?
- 4. If I understand it correctly, the success of our community engagement will be evaluated. On the face of it, this could very easily be 'gamed', as we seek good evaluations by highlighting the partners with whom we already work well, but at the expense of doing what might be the hardest and (perhaps the most important) work. A version of this question was posed to Senate, to which the answer was that we won't jettison the tough collaborations that might tell us we need to be doing much more work; but what are the mechanisms to prevent it?

Tributes to his public service include the Vanier Medal, a Fellow of the Royal Society of Canada, a member of the Queen's Privy Council for Canada and a Companion of the Order of Canada. Mr. Robertson's association with Carleton began in the early 1960s when he was appointed a member of the Board of Governors (1962-1971). In 1980, he became Carleton's fifth Chancellor, a position he held until 1990. In that year he received an Honorary Doctor of Laws from the University and in 1992 was named the University's first Chancellor Emeritus. To recognize his outstanding contributions to Carleton, Robertson Hall, a key administration building on campus is named in his honour.

Eligible recipients will be either entering or proceeding from one year to the next in a program at Carleton University. The Dean of Graduate and Postdoctoral Affairs will award to selected graduate recipients. Preference will be given to Inuit students undertaking scholarly or research work of benefit, either in the present or the future, to Inuit communities in the Canadian Arctic (Nunavut) and including Newfoundland and Labrador, the Northwest Territories and Quebec. Endowed in 2004 by Gordon Robertson, C.C. Gordon Robertson, had an illustrious career with the Canadian government. Over the course of thirty-eight years, he served in a variety of capacities including Deputy Minister of Northern Affairs and National Resources, Clerk of the Privy Council and Commissioner of the Northwest Territories. Tributes to his public service include the Vanier Medal, a Fellow of the Royal Society of Canada, a member of the Queen's Privy Council for Canada and a Companion of the Order of Canada.

Mr. Robertson's association with Carleton began in the early 1960s when he was appointed a member of the Board of Governors (1962-1971). In 1980, he became Carleton's fifth Chancellor, a position he held until 1990. In that year he received an Honorary Doctor of Laws from the University and in 1992 was named the University's first Chancellor Emeritus. To recognize his outstanding contributions to Carleton, Robertson Hall, a key administration building on campus is named in his honour.

Subject: Revisions to Honorary Degree Policy

The Honorary Degrees Committee is recommending 2 changes to the Honorary Degree Policy:

- 1) <u>Notifications</u>: Nominators will not be informed of the decision of Senate, to protect the confidentiality of the process.
- 2) <u>Active List</u>: Approved nominees will stay active for 5 years instead of 3 years, to allow enough time to schedule the receDipt of the degree.

MOTION: That Senate approve the changes to the Honorary Degree Policy, as presented.



Senate Honorary Degree Policy

The conferring of honorary degrees provides the University with an opportunity to convey to the world our values and principles by recognizing the contributions and accomplishments of exceptional individuals. The honorary doctorates conferred at each Convocation also provide our graduating students with exemplary role models and meaningful messages that will carry them into their futures.

Degrees Awarded

Carleton University confers the following honorary degrees:

- LL.D. Doctor of Laws Awarded for exceptional service to the University or to the community as a whole, or for outstanding scholarly achievement in a profession not covered by other honorary degrees
- D.Litt. Doctor of Literature Awarded for outstanding achievement in the Humanities
- D. Eng. Doctor of Engineering Awarded for outstanding achievement in the field of Engineering
- D. Mus. Doctor of Music Awarded for outstanding achievement in Music
- D. Sc. Doctor of Science Awarded for outstanding achievement in the pure and applied sciences
- D. Fine Arts Doctor of Fine Arts Awarded for outstanding achievement in the Fine Arts
- D. Arch. Doctor of Architecture Awarded for outstanding achievement in Architecture

In exceptional circumstances, and in recognition of long-term service to Carleton University, the committee may recommend the awarding of an honorary Master's degree.

Guidelines for Nominators

The Senate Honorary Degrees Committee encourages members of the Carleton University community and the general public to submit nominations of exceptional and distinguished individuals for an honorary degree.

Nominations must be submitted to the Committee in strict confidence and therefore should not be discussed with the nominee.

Nominations may be submitted to the Senate Office at any time throughout the year, and will be reviewed at the meetings of the Honorary Degree Committee, which normally occur twice per year.

Eligibility and Exclusions:

Citizens and nationals of any country may be nominated. Serving employees of the University, sitting members of the Board of Governors, and sitting members of legislative bodies, such as Parliament, are not eligible for nomination. Also, current adjunct professors and research fellows at Carleton University are normally excluded from consideration.

Carleton University also does not award honorary degrees posthumously, or in absentia. The approved candidate is expected to attend a Convocation and address graduating students.

<u>Criteria for Selection</u>: The Committee will review each nominee in terms of whether they personify the core values of the relevant Faculty and/or the University, and exemplify the personal and professional characteristics to which we wish our students to aspire. An honorary degree recipient is someone who:

- is a scholar of notable significance, pioneering or revolutionizing a field,
- has made a significant contribution to the University,
- has made a significant contribution to the community, nation, or the world, and/or
- Drings honour to Canada on the world stage.

Procedure:

Nominators should begin by completing all sections of <u>the online form</u> for nomination. Incomplete nomination forms will not be forwarded to the committee. Note that additional information and documentation to support the nomination may be attached to and included with the nomination form.

Each nomination should be accompanied by two letters of support from individuals who are familiar with the candidate's achievements and knowledgeable in the candidate's area of expertise. The letters should state the relationship of the writer to the candidate, and should complement, rather than reproduce, the information provided on the nomination form, by providing a broader context to the candidate's accomplishments and their impact. The individuals supplying these letters must be informed of the need to maintain strict confidentiality; they should not contact the candidate to inform him/her of the nomination. The form and letters should be submitted to the Senate Office at the address below. The Committee may contact the nominator if further information is required.

The Honorary Degrees Committee will consider all nominations in strictest confidence. Candidates recommended by the Committee will then be presented to a closed session of Senate for approval. Nominators will be informed of the decision of Senate, but must maintain confidentiality and should not contact the candidate. In order to protect the confidentiality of the process, nominators will not be informed of the decision of Senate and will only be contacted if and when the granting of the honorary degree has been scheduled. If a nominee is approved by Senate, the President will choose when to contact the candidate with an offer to receive the honorary degree. The President also decides, in consultation with the candidate, at which Convocation ceremony the degree will be awarded, and when the honorary degree will be publicized.

Approved nominees are held on an active list for a period of three five years to allow time for the candidate to attend a convocation ceremony to receive the degree.

Revocation of Honorary Degrees

In rare and exceptional circumstances, where the behaviour of an individual has caused significant concern, the Honorary Degrees Committee has the right to review and recommend to Senate the rescinding of an Honorary Degree.

Please find attached the revised Institutional Quality Assurance Process (IQAP) that is the result of a review process led by the Office of Vice-Provost and Associate Vice-President (Academic). A document setting out in detail changes from the version of the IQAP approved by Senate in June 2015 is also attached.

Background

Carleton University's IQAP was ratified in March 2011, May 2012 to include the affiliation agreement between Carleton and Dominican University College and again in September 2015 to incorporate process changes, amendments requested from the Quality Council and results of the audit report.

The current revisions to the IQAP involved a consultative process with stakeholders, including: Academic Heads Roundtable, the Faculty Deans, unit Chairs and Directors, the Carleton University Committee on Quality Assurance (CUCQA), Senate Academic Program Committee (SAPC) and representatives of the Library. The Office of the Vice-Provost and Associate Vice-President (Academic) extends its thanks to those who reviewed and provided feedback on the IQAP.

The Revised IQAP

The information contained in the attached document is detailed. The following, therefore, is a summary of the most significant changes:

- 1. CUCQA and SAPC have been replaced with the Senate Quality Assurance and Planning Committee, as approved by Senate on May 31, 2019, thereby eliminating a second review of the same documentation;
- 2. The committee approval of the three volume brief, prior to the external reviewer site visit, has been removed in order to streamline and expedite the process;
- 3. The process of reporting on action plan items has been revised to introduce midway reporting as part of the cyclical program review process, rather than reporting at every milestone;
- 4. Changes were made to the major modification tracks A1, A2 and B;
- 5. The appendices containing the list of programs in scope was replaced with the criteria defining in scope programs;
- 6. Definitions were removed and reference was made to the glossary regularly updated in the University Calendar;
- 7. The unit response to the external reviewers' report and action plan have been combined into one step for cyclical program reviews.

It should be noted that the Provincial Quality Assurance Framework requires that IQAPs encapsulate not only quality assurance processes narrowly defined, but also a University's processes of program and curriculum approval, including those processes (for example, minor modification approval processes) that are not subject to quality assurance.

CUCQA reviewed the revised IQAP at its meeting of June 12th. SAPC unanimously approved the revised IQAP at its meeting of June 13th. If passed by Senate, the revised IQAP will be submitted to the Quality Council for ratification.

The Chair called the meeting to order at 11:01 am.

1. Approval of the Agenda

The Committee approved by general consensus the Senate Executive Committee agenda for March 19, 2019.

2. Approval of the Minutes: February 5, 2019

The Committee approved by general consensus the minutes of the Senate Executive Committee meeting on February 5, 2019, with one minor correction to the attendance record.

3. Approval of Senate agenda: March 29, 2019

The Senate agenda for March 29 (open and closed sessions) was approved by general consensus with the following notations and changes:

- SAPC will bring forward motions for 3 cyclical reviews and 6 major modifications, including the proposal for a new BA and BSc open studies degree.
- The CUISIC (Carleton University Indigenous Strategic Initiatives Committee) consultation planned for the meeting will last between 30 and 45 minutes.
- Item 6c (Schedule of Senate Meetings) will include dates for both 2019/20 and 2020/21.

4. Review of Senate Minutes: February 15, 2019

Two minor changes were suggested under the Discussion summaries for Items 7(a)i and 7(a)ii (Report of the Senate Academic Program Committee), in the minutes for the Open Session on February 15th. The committee recommended the circulation of these minutes to Senate with these changes.

5. Empowering Motion – Posthumous Degrees/Recognition

The Clerk reported on 3 items that have come to Senate Executive for approval through the Empowering Motion:

- Approval for a posthumous Certificate of Academic Accomplishment for an undergraduate student
- Approval for a posthumous degree (BSW) for a student, and
- Approval for a request for a post-graduation change for a student, which would add a co-operative education designation to the official diploma

It was **MOVED** (B. Kuzmarov, J. Tomberlin) that Senate Executive approve the requests for posthumous recognition and post-graduation change, as presented. The motion **PASSED** unanimously.

The approvals will be reported to Senate at the closed session of the next meeting under "Report Under the Empowering Motion."

6. Report on Senate Committee Review (Clerk)

A draft Report on the Senate Committee Review was circulated to committee members in advance. The Clerk indicated that the review summarizes research undertaken so far in the Senate Office, and will be discussed at Senate on March 29th.

The Clerk noted that while undertaking historical research on the Senate committees, the Senate Office discovered a governance anomaly that needs to be resolved before the review can move forward. In 2008, a motion was brought to Senate requesting changes to the Terms of Reference and membership criteria of the Senate Executive Committee. The changes included transferring the responsibility for committee oversight from the Senate Executive Committee to the Senate Academic Governance Committee. The motion passed at Senate, but does not seem to have been formalized. The Terms of Reference for both committees were unchanged, as was the summary of the Senate Executive Committee in the AGU. To complicate things further, in 2011 the Clerk of Senate felt the first vote on this issue at Senate was not legally binding because it did not

record a 2/3 majority. The motion was brought back to Senate for a revote, but only membership criteria were included in the revote, not the terms of reference and/or delegation of authority. As a result, it is not clear who has the mandate to oversee committee restructuring as part of the current committee review.

The Clerk suggested that a solution to this dilemma would be to create a Senate ad hoc committee to oversee the final stages of the committee review and restructuring. The committee would be a neutral "third party" with the authority of Senate, that could resolve the governance authority issues of these two committees, as part of a broad and complete review and restructuring of Senate committees. The Clerk noted that the goal would be to create this ad-hoc committee quickly so that it would be able to meet at least twice in early April and report back to Senate at the next meeting on April 26, with recommendations for changes.

It was **MOVED** (B. Kuzmarov, B. Hughes) that Senate Executive endorse the creation of an ad hoc committee of Senate to finalize the Senate Committee Review.

The motion **PASSED** unanimously.

The Clerk added that the suggested composition of the ad-hoc committee would be similar to the Task Force for the Free Speech Policy: 3 faculty member Senators, 1 Contract Instructor Senator, and 2 Student Senators (1 undergraduate and 1 graduate) plus the Clerk of Senate. If Senate endorses the creation of this ad-hoc committee, the Senate Office will circulate an open Call for Expressions of Interest immediately after the Senate Meeting on March 29, with the goal of confirming membership before April 4th. An election can be held if required on April 3rd. The committee agreed by consensus to this plan.

7. Other Business

Members of the committee discussed the Senate meeting schedules for 2019/20 and 2020/21 that were circulated in the meeting package. The Clerk noted that the Secretariat plans the Board of Governors meeting schedule two years in advance, and this practice will be adopted for the Senate as well moving forward, in order to coordinate the two schedules more effectively.

It was noted that the September 2019 Senate meeting has been scheduled early to avoid a conflict with the Ontario Universities Fair on September 25 and 26. Similarly, the October 2019 Senate meeting has been scheduled

on October 18 to avoid meeting during Reading Week on October 25. However, the Vice-Provost noted that meeting deadlines for program approvals in time to be able to advertise them would be difficult with such an early October meeting date. It was agreed to bring the question to Senate and to change this date to October 25, if enough Senators would be in attendance during Fall Break.

8. Adjournment

It was **MOVED** (B. Hughes, J. Tomberlin) that the meeting be adjourned. The motion **PASSED**.

The meeting was adjourned at 11:37 am.

The Chair called the meeting to order at approximately 11:00 am.

1. Approval of the Agenda

The Committee approved by general consensus the Senate Executive Committee agenda for May 21, 2019.

2. Approval of the Minutes:

- a. Senate Executive Minutes: April 16, 2019
 The Committee approved by general consensus the Senate Executive Committee minutes from April 16, 2019.
- b. Senate Executive E-Poll: April 26, 2019
 The Committee approved the Senate Executive Committee E-poll minutes from April 26, 2019.

3. Approval of Senate agenda: May 31, 2019

It was noted that SAPC will be presenting for approval the new Graduate Diploma in Work and Labour. SCCASP items have yet to be determined. Dwight Deugo will be speaking on behalf of SCCASP, as the Chair, Howard Nemiroff, will be absent. In his introductory remarks, the President will announce the June Senate meeting and the joint Board-Senate reception.

The following changes to the agenda were requested:

 Welcome of new student executive members was moved from Item 7(b) to Item 7(a).

- The Community Engagement item on the agenda will consist of two presentations: Carnegie Classification Pilot Project and HUB for Good.
- Minor modifications from DUC should be added under Items for Information.

With these changes the Senate agenda for May 31, 2019 was approved.

4. Review of Senate Minutes: April 26, 2019

The committee reviewed the draft minutes from April 26, 2019 and suggested a few small editorial changes.

5. Report on Senate Committee Review Task Force (Clerk)

The Clerk reported on the second series of motions that will be presented to Senate this month from the Senate Committee Review Task Force. The first series of motions that were passed in the April Senate meeting included changes to the mandates of the Senate Executive Committee and the Governance Committee, and the creation of an Appeals Board. At that time there had been an agreement in principle among Task Force members regarding ways to streamline and update the Quality Assurance process but the motions for Senate had not yet been finalized. For the May Senate meeting, the Task Force is now prepared to bring forward motions on the quality assurance process that would simplify the QA process. The first proposal recommends the dissolution of the Senate Academic Program Committee and CUCQA, and the formation of a new Senate committee that combine the functions of these two committees. A second motion proposes the creation of a subcommittee, under the Senate Appeals Board, to hear appeals of the Quality Assurance process. The proposed changes would take effect as of September 1st.
