## **Open Session**:

#### 1. Welcome & Approval of Agenda (open)

It was **MOVED** (D. Dragunoiu, J. Wolfart) that Senate approve the open agenda for the meeting of Senate on February 15, 2019, as presented. The motion **PASSED**.

#### 2. Minutes: January 25, 2019

It was MOVED (E. Grant, J. Wolfart) that Senate approve the minutes of the

Senate meeting of January 25, 2019, as presented.

L. Dyke requested a small change in *Matters Arising*. She asked that the word "potentially" be added to the first sentence of Item 3(b), so that the sentence reads as follows:

A question was raised at the Senate meeting in October 2018 regarding the potentially heavy workload for faculty involved in co-teaching courses in this new program.

The change was approved, and the minutes were approved with this change.

#### 3. Matters Arising

- a. Second language requirement for PhD programs at Carleton statistical analysis (M. Neufang)
  - At the Senate meeting on January 25, 2019, some Senators expressed concern with a program modification that eliminated a second language requirement from the PhD in Legal Studies. As a result of the ensuing discussion, Senators requested a follow-up discussion based on information on existing requirements for all PhD programs at Carleton.
  - An overview of the language requirements for the 35 PhD programs at Carleton was circulated to Senators prior to this Senate meeting. Dean Neufang presented an analysis of the data to Senators.
  - Dean Neufang noted that close to 70% of all PhDs at Carleton do not require a second (foreign) language. It is only required in seven PhD programs in two faculties (4 in FASS and 3 in FPA).
     Second (foreign) language proficiency is generally not required for PhDs in Business, Science or Engineering.
  - A Senator asked if comparable data for other Ontario universities is available, but noted that decisions on Carleton's requirements

should be based what is right for students in our programs, and not necessarily on what other universities are doing.

There was no further discussion of the issue.

#### 4. Chair's Remarks

The Chair presented the following campus news highlights of interest to Senators:

- Dr. Dana Brown has been appointed as the new Dean of Carleton's Sprott School of Business. Dr. Brown is currently Pro Vice-Chancellor (Enterprise) and Dean of Business at de Montfort University in the United Kingdom, and previously held the position of Director of the MBA program at Oxford University's Saïd Business School.
- Carleton's current Interim Provost, Jerry Tomberlin, has been appointed Provost of Carleton University. He was the unanimous choice of the Provost Search Committee. The Chair congratulated Jerry Tomberlin on his appointment.
- Carleton University and the Carleton University Academic Staff Association (CUASA) have signed a renewed collective agreement. The four-year agreement covers the period from May 1, 2017 to April 30, 2021. The Chair congratulated both negotiating teams for their hard work throughout this process.
- A renewed collective agreement between Carleton University and PSAC 77000, which represents postdoctoral fellows, was announced on February 1 by Provost Jerry Tomberlin and President of PSAC Donald Fowler. The Chair congratulated both negotiating teams for their hard work throughout this process.
- Professor Sarah Todd, from the School of Social Work, was awarded an esteemed 3M National Teaching Fellowship, for her exceptional contributions to teaching and learning. This award is the most prestigious recognition of excellence in post-secondary teaching in

Canada, and demonstrates Carleton's support for creativity in teaching and learning.

- The Provost and VP Research also recently announced the 2019
   Achievement Awards in Teaching and Research. Thirty members of the
   Carleton community were honoured. A full list of awards with the profiles

- On the Monday following the last Senate meeting, a false alarm about an active shooter created considerable stress on campus. The Chair provided a written commentary on this event in his blog (P15) on Monday February 11. The Chair notes that he has requested a full action plan from several departments on campus to ensure that Carleton is adequately prepared in the event of a real emergency.
- More information has been received regarding the provincial government's plans for a 10% tuition rollback, reductions to the OSAP program and changes to student fees. Carleton is committed to working together with student leaders to adapt to these changes. More discussion of this issue is scheduled for today's Question Period.
- On Monday, Carleton announced that the Collaborate Campaign reached its goal of raising \$300M. This is a tremendous accomplishment. The public phase of the campaign was launched in 2015, and continued to gain momentum under the Here for Good ethos. The Chair acknowledged and thanked former Presidents Roseann O'Reilly Runte and Alastair Summerlee for their crucial role in this shared success, and he acknowledged the exceptional leadership of Jennifer Conley and her team in the Department of University Advancement. The campaign will continue until the end of the fiscal year. Celebratory events will be held in March and April.
- The Chair concluded by wishing everyone a happy Family Day and a great Winter Reading Week.
- There were no questions.

#### 5. Question Period

**a.** CASG Questions regarding changes to student fees.

Given the proposed changes to tuition and ancillary fees from the provincial government, the student body is concerned about the affect this will have on academics, services, and the overall campus community. The Carleton Academic Student Government has consulted with students to form a short list of questions to pose to Carleton's administration and the university Senate. They are as follows:

- 1. How are "essential services" being interpreted by the university? Does the university anticipate it will be allowed to determine what "essential services" are, or will it be determined by the province? Will the essential role played by groups such as CASG be recognized by the university in its implementation of the Students Choice Initiative?
- 2. Marginalized communities receive a lot of support from the Service Centres put at risk of losing funding through student opt-out. How can the university support these Service Centres in continuing to deliver their services?
- 3. Does the university anticipate that the U-Pass will be put at risk with the optouts? Especially considering that some students already choose to go through the extensive process of opting out.
- 4. How can the university increase its support of career development and employability skills?
- 5. Would Academic Advisors/supports on campus be put at risk due to changes in budget or funding allocation?
- 6. What is the Omnibus ancillary fees? What does it pay for?

The University Registrar, Suzanne Blanchard, responded to these questions:

- Carleton has had one technical briefing by telephone with the provincial government; a more detailed framework has yet to be received. However, it appears that the provincial government will identify which fees are mandatory, and will provide a list of those fees. Students will be able to opt out of all others.
- 2. It is too early to comment on plans, but this issue is being addressed through ongoing discussions with student groups.
- 3. The ministry has confirmed that the UPASS, and Health & Dental Plan fees will be mandatory.
- 4. Carleton's focus is to commit to student success and to minimize any negative impact on our academic mission.
- 5. (answered together with #4)

6. The omnibus ancillary fees cover fees for graduation, transcripts and other administrative fees that, in other institutions, students pay for individually.

The Registrar added that discussions are continuing, and information will be shared with the Carleton community as it becomes available.

#### 6. Administration (Clerk)

#### a. Student Senators Membership Ratification

A by-election was held recently to fill Student Senator vacancies for the remainder of the 2018/19 academic year.

It was **MOVED** (B. Kuzmarov, N. Nanos) that Senate ratify the new Senate appointments, as presented.

### b. Senate and Committee members – Call for student nominations for 2019/2020

The Clerk noted that the Senate Office will be holding elections next month (March) for student positions on Senate for the 2019/20 academic year. Previously, student elections have been held in September and October, which resulted in a late start for students to Senate. As first year students are not eligible to serve on Senate, there are no obstacles to holding these elections in the spring for service beginning in the fall.

A Call for Expressions of Interest will be circulated in early March and elections will take place prior to the next Senate meeting.

The Clerk confirmed that moving forward, this new schedule will be adopted for Contract Instructor elections to Senate as well.

#### 6. Administration

#### c. Update on Senate Committee Review

The Clerk commented on the ongoing Senate Committee Review:

- Stage 1 of the review, the Benchmarking Study, was completed in January and was shared with Senators at the Senate meeting on January 25, 2019.
- Stage 2, a review of Carleton's current committee structure and function, is now complete.
- For this stage, the Clerk contacted committee Chairs for feedback on Terms of Reference and membership.
- 10 of the 14 committee Chairs have responded. Through their answers, a distinction has emerged between committees performing core work of Senate (approvals, management, recommendations) and those with less clearly defined oversight functions. This distinction is reinforced through the data gathered in our reporting on the meeting frequency, reporting procedure, and terms of reference of the committees. The framework also maps broadly onto a pattern evident in the Benchmarking Study, and will inform the report and recommendations moving forward in the coming weeks from the Senate Office.
- The next stage of the Review will be the preparation of a report for Senate that summarizes our findings so far. This will be shared at the next Senate meeting in March.

#### 7. Reports

  - i. Major Modifications

The Provost presented eight major modifications to Senate.

#### **Discussion**:

A Senator asked about the credits listed for the BA (Hons) Geography Concentration in Urban Geography. The Chair requested that the committee double check all credit numbers for accuracy and clarity. Another Senator asked why there had been some concern expressed by a unit that supported this modification with reservations. The Vice-Provost replied that there was a concern regarding the potential increase in numbers of students for this program, but this had been addressed by the Department of Geography.

The motion **PASSED**.

#### 7. Reports: a) SAPC (cont'd)

**ii.** <u>Undergraduate Dual Degree Policy</u> – common in Europe, and modelled on the current graduate dual degree policy at Carleton, this policy creates unique opportunities for undergraduate students.

It was **MOVED** (J. Tomberlin, L. Schweitzer) that Senate approve the Undergraduate Dual Degree Policy, as presented.

#### Discussion:

In response to questions, the Provost clarified that the policy is a framework that allows for dual degrees where they make sense but they are not required. A model articulation agreement is attached to the policy. The unit establishing the dual degree program negotiates the agreements and course equivalencies are established as part of the agreement. This allows for a case-by-case approach to these programs. The Dean of Graduate and Postdoctoral Affairs added that the policy is flexible enough to allow for these differences, but the choice of partner institute is critical. Both universities need to be committed.

The motion **PASSED**.

### Senate Committee Review Report

#### Introduction:

Senate is the university's most senior academic body. As such, it makes decisions of significant importance to students and faculty, including awarding of degrees and scholarships, approving new programs and revised curricula, and establishing academic regulations. This core work, defined by the University Act, is central to the administration and functioning of the university.

In the day-to-day operations of Senate, this core work is delegated to standing committees. Not only are these committees necessary for dividing the work of Senate, but they allow for deeper investigation into specific areas and issues. However, in recent years it has become increasingly challenging to staff committees adequately through Senate and the ties between committees and Senate have become weaker.

In order to fulfill its mandate, it is important to ensure that Senate's committee structure clearly reflects its core goals and that Senate committees are staffed appropriately. This is necessary in order to support strong academic governance and to ensure that Senate work is accomplished in a timely and efficient manner. Vibrant academic governance requires a periodic review of Senate's committees and mandate. While the structure of committees was updated in 2008 and 2011, these changes were not part of a comprehensive review of Senate committees. It is the purpose of this report to undertake such a review.

#### Process:

Under the direction of the Clerk of Senate, the Senate Office began a review of Senate committees in December 2018. The first stage of this review was a benchmarking study of Ontario University Senates to understand the broad landscape of Senate committee structure at similar institutions. This was completed in January 2019 and reported to Senate at the meeting on January 25, 2019. The second stage included a review of the current state of Carleton Senate committees. The Clerk of Senate surveyed by email all committee Chairs to obtain feedback on the current structure and function of their committees and to provide some institutional memory for each committee. The third stage involved an archival review of Senate committees. This report represents the fourth stage, which is an analysis of the research.

#### **Current Committee Structure:**

Currently, Carleton's Senate has fourteen Standing Committees. These committees can be grouped broadly into three categories:

- 1. Committees with approval and recommendation functions:
  - a. Senate Academic Program Committee
  - b. Senate Committee on Curriculum, Admission, and Studies Policy
  - c. Senate Committee on Student Awards
  - d. Senate Committee on Medals & Prizes
  - e. Senate Honorary Degrees Committee
  - f. Senate Academic Governance Committee
  - g. Senate Executive Committee
- 2. Committees with independent mandates governed by policies of Senate:
  - a. Senate Undergraduate Studies Committee
  - b. Senate Academic Integrity Appeals Committee
  - c. Senate Graduate Student Appeals Committee
  - d. Senate Academic Accommodations Appeals Committee
  - e. Senate Educational Equity Committee
- 3. Committees with oversight function:
  - a. Senate Review Committee
  - b. Senate Library Committee

Through the survey of committee Chairs, it became clear that committees with approval and recommendation functions meet regularly or as needed according to their mandate. They also generally map onto the core business of Senate and report back regularly to Senate. The committees with independent mandates governed by policies of Senate are mostly appeals committees, some of which meet regularly and others which rarely or never meet, based on work that comes forward. The third category, committees with oversight function, often have difficulty scheduling meetings, finding staff or defining their role and creating work plans. This indicates that the oversight role is less clearly tied to the core business of Senate.

Core Senate committees have deep roots in the history of the university, with some originating as early as the 1950s. This indicates that current committees that have been maintained continue to perform key functions of Senate's mandate. Archival research of Senate committees reinforced these patterns, demonstrating that committees tied to core business of Senate generally revised their terms of reference and membership regularly. Committees with independent mandates governed by policy reviewed their terms of reference according to dictates of the individual policy. It is more difficult to generalize about the committees with oversight function.

In terms of membership, committee Chairs are generally required to sit on Senate, but membership criteria varies widely from one committee to the next.

#### **Benchmarking Study:**

The Senate Office undertook a benchmarking study of 18 Ontario universities in December 2018, to review their Senate committee structures. Information was obtained from the university websites. This review found that the number of Senate committees at Ontario universities ranges between 4 and 15, with an average of nine committees. There is no correlation between the size of the university and the number and structure of Senate committees, or between the size of the Senate and the number of committees. Additionally, some universities' structures included sub-committees.

- Senate Executive Committee

- Research / Research Ethics
- Governance / Bylaws

- Ceremonials / Convocation
- Tenure and Promotion/ Tenure & Promotion Appeals
- Student Affairs
- Technology & Infrastructure
- Educational Equity
- Orientation Activities

- Library

- Long-Range Planning

To put the current state of Senate committees in context, Carleton is an outlier in terms of the number of its committees; in fact, we have the most Senate committees of any university surveyed. Additionally, it was rare for university senate committees to be staffed fully by non-Senators, other than the Chair. Further, the review indicated that many of the committees with approval and recommendation functions, that were noted above, existed in one form or another in all universities. This would include; academic program review, quality assurance, curriculum changes, honorary degrees and student awards. Most universities surveyed had only one appeals committee, and many universities had a committee tasked with planning and establishing priorities for Senate.

#### **Analysis:**

Taken as a whole, this committee review presents the following key observations:

- 1. Senate is due for a comprehensive review of its committee structure;
- 2. The current committee structure does not always reflect the core business of Senate and/or current practices across the sector;
- The difficulties in staffing Senate committees is directly related to both the number of committees and the separation between the core business of Senate and the committee structure;
- 4. Any comprehensive review of the committee structure should take these points into account.



# **Context for Announcements**

- Ontario's Fiscal Situation. Government has committed to reducing \$14.5B deficit
- EY Report. Bolstered by the EY Report in September government is focused on promoting efficiencies, modernizations, enhanced accountability and productivity to reduce costs.
- OSAP Costs. AG's report highlighted significant cost increases from "free tuition"; program costs have grown by 250% in the last decade to \$1.7B last year.



# **Government Policy Announcements**

- Jan. 17<sup>th</sup> Minister Fullerton made major policy announcements in three significant areas
  - Tuition
  - Student Ancillary Fees
  - Ontario Student Assistance Program (OSAP)
- Government framed these decisions as putting money back in the pockets of students and families; it also will reduce MTCU costs.



- New 2 year tuition framework, cover 19-20 and 20-21
- 2019-20 Requirements
  - Universities must reduce tuition fees by 10% for all funding-eligible programs covered by current framework
  - Cuts apply only to funding-eligible students
- 2020-21 requirements
  - Tuition fees to remain frozen at 2019-20 rates.
- No change to TSA (anticipated 10% decline)
- Universities anticipate a reduction of \$360M in tuition revenue next year



- Student Choice Initiative developed "to empower students to choose which student fees they pay and how the money is allocated"
- Ministry will create a new non-tuition ancillary fee framework that identifies "essential" fees, such as health and safety, athletics, career services, academic supports, and others
- Students will be able to opt-out of all "non-essential" fees (e.g. student association fees) online starting September 2019.
- Compliance policies will not change, but universities deemed non compliant could have operating funds impacted.



- Ministry will make nearly a dozen modifications to OSAP eligibility and needs assessment calculations and distribution.
- Elimination of all non-needs-based aid.
- "Free tuition" is over: all students with assessed need will receive at least 10% of OSAP as repayable loans.
- Other changes include: Increases to assumed personal and parental contribution, changing definition of "dependent", increasing annual debt limit, and end of 6 month interest-free grace period.
- MTCU has not yet indicated how much it will save through these changes.

Rationale for change Carleton has offered a Bachelor of Journalism since the mid 1940s. In 1974-75 a BJ combined

honours was introduced. Within the Combined Honours entry in the Bachelor of Journalism, the 1986-87 Calendar introduced a passing parenthetical mention of a combined honours Bachelor of Arts in Journalism, with no other details provided, while the list of degrees offered at the top of the Journalism entry continued to list only Bachelor of Journalism. In subsequent years, a brief description of a process for effecting entry into such a program was introduced. The process described was confusing and did not conform to Carleton's established admission processes. It is doubtful that any student ever availed themselves of

this designation. No such degree program has ever existed in Banner, and there have been no graduates with the designation since at least 2003. The institutional memory of staff familiar with the program in the pre-Banner days is that there were no enrollments or graduations under this designation. There exists no program or audit structure, or academic performance evaluation criteria for this program. Furthermore, the entry is encouraging students to make a transfer into the B.A. as far along as 60 days prior to their completing the final courses for their degree, which does not conform to recommended practice, and which may place the student in a precarious position. On the basis of the above, we are proposing to remove reference to the B.A. combined honours in Journalism, leaving the B.J. Combined Honours intact.

# Glossary

The following glossary of definitions is intended to provide explanations of how certain important terms are used throughout the Calendar. In rare cases where a discrepancy may occur between the definition provided in this Glossary and the use of the term in the remainder of the Calendar, the term as used in the remainder of the Calendar takes precedence.

The Glossary is not intended to be exhaustive; students should refer to Carleton's web site for other important information (e.g., <u>carleton.ca/registrar</u>; <u>gradstudents.carleton.ca</u>).

Except where noted, all definitions apply to undergraduate and graduate students.

Academic Performance Evaluation (APE) Auditing Student	The APE is the annual assessment of student academic standing in undergraduate degree programs and special studies. The possible outcomes of an APE are <i>Good Standing</i> , <i>Academic Warning</i> , <i>Suspension</i> , <i>Continue in Alternate</i> , <i>Continue in General</i> , <i>Dismissed from Program</i> , or <i>Debarment</i> . A student who attends a course for interest and not for credit. Formal registration is required.

Calendar	The official publication of academic regulations, academic programs and course descriptions as approved by the Senate.
Certificate	An undergraduate certificate is a stand-alone Credential that may be taken concurrently with a bachelor's program or independently. It is normally constituted by a structured set of at least four credits of sequential year-level courses in a particular discipline or area of study that introduces students to, or extends their knowledge of, that discipline or area of study.
Challenge for Credit	Undergraduate academic course credit gained through examination based on a student's prior learning experience gained through professional or work experience. A successful challenge for credit is noted in the student's record as CH. (An unsuccessful challenge for credit is noted as UCH). A CH is neither included in the CGPA calculation nor used to satisfy the degree program residency requirement. Challenge for Credit is not available in all courses.
Concentration	A program Element recorded on the transcript and diploma constituted by at least 3.5 credits of required courses at the undergraduate level and 1.5 credits of required courses at the graduate level that concentrates on a particular area of study within the program and provides the student with specific expertise, knowledge and/or practice.
Co-operative	An undergraduate or graduate Option comprising work periods combined with academic study to acquire
Education	work-related experience; the co-op option is intended to complement the student's academic study.
Core	A course or group of courses that are a subset of the courses that constitute a major in an undergraduate program. These are courses of special importance to undergraduate programs and are subject to specific CGPA requirements.
Cotutelle	An Option in any Ph.D. program. Doctoral students undertake to complete the requirements of a Ph.D. program in both their home university and a partner university in another country.

#### Description

A course is a unit of teaching that may count as credit towards the award of a Credential. Courses typically last one academic term and focus on one subject area with a prescribed sequence of units of study (lectures, seminars, tutorials, workshops, laboratories, assignments, essays, tests, examinations and so on). Courses are delivered by one or more instructors and have a fixed roster of students. Students receive a grade after completion of courses that count as credit towards the award of a Credential.

### Course

Courses have unique eight-character alphanumeric course codes, titles and descriptions. The credit value is indicated in square brackets following the course number.

- 1. Numbers 1000-4000 designate undergraduate courses;
- 2. 0000-level courses are also available and may be required to satisfy prerequisites;
- 3. Numbers 5000-6000 designate graduate courses.

# Course Outline

Instructors are required to provide students in each course a written Course Outline (distributed in class or electronically), on or before the first teaching day for undergraduate courses, and before the last date for late registration for graduate courses. The course outline must specify all the elements that will contribute to the final grade, as well as the overall grade breakdown for the course.

Courses that do not contribute to the fulfilment of graduation requirements within the student's program:

1. Extra to the Degree (ETD): Passed credits that are in excess of the required credits;

#### Courses Set Aside

- 2. No Credit for Degree (NCD): Passed credits that are ineligible for credit in the student's program;
- 3. Forfeit: Repeated courses, course equivalencies, preclusions, and courses placed in this category by an academic standing committee or an appeal committee.

#### Credential

## Credit

An academic qualification awarded by the University Senate upon successful completion of an academic program. All credentials are either degrees (bachelors, masters, or doctoral), diplomas, or certificates. The academic value of a course (for example, 0.0, 0.5, 1.0, et cetera).

# Major

Credits Not in the Major are credits that must be taken in programs that require Credits Not in the Major Credits Not in the from disciplines and intellectual areas other than those which constitute the discipline, disciplines or intellectual area of the major in such programs. Credits Not in the Major constitute one form of restricted electives.

# Cumulative Grade Point Average (CGPA)

The key assessment tool for undergraduate Academic Performance Evaluation, and graduate and undergraduate graduation requirements and distinctions. The CGPA may be used in assessments for scholarships, medals and other milestones. The CGPA is the average of grade points earned on all courses required for and counting towards graduation from the student's current program (overall CGPA), or the average of grade points earned on a subset of such courses (for example, those constituting the Major or a Minor) at the time the CGPA is calculated.

## D

## Degree

A Credential at the Bachelor, Master or Doctoral level awarded by the University Senate upon the successful completion of a prescribed set and sequence of program requirements at a specified standard of performance.

#### Description

Post-baccalaureate Diploma: a stand-alone undergraduate credential for candidates already possessing a bachelor's degree intended to: (a) qualify candidates for consideration for entry into a Master's program; (b) bring a candidate who already possesses a bachelor's degree up to a level of a bachelor's degree of 20.0 credits or more in another discipline; (c) provide a candidate who already possesses a twenty-credit bachelor's degree in the same discipline the opportunity to bring their previous studies to current equivalents and/or to examine alternative areas; or, (d) provide a candidate with a professional undergraduate credential for which the prior completion of an undergraduate degree program is appropriate.

Post-baccalaureate diplomas are normally constituted by at least three and a maximum of five credits of advanced undergraduate courses.

## Diploma

#### **Graduate Diploma:**

Type 1: Awarded when a candidate admitted to a master's program leaves the program after completing a certain proportion of the requirements. Students are not admitted directly to a Type 1 Diploma.

Type 2: Offered concurrently with a master's or doctoral degree, the admission to which requires that the candidate be already admitted to the master's or doctoral degree program. A Type 2 Diploma represents an additional, usually interdisciplinary, qualification of 2 to 3 credits.

Type 3: A stand-alone, direct-entry program of 2 to 3 credits, generally developed by a unit already offering a related master's (and sometimes doctoral) degree, and designed to meet the needs of a particular clientele or market.

#### Discredit

For undergraduate students, a discredit is a course registration that results in a grade of F (failure) or UNS (unsatisfactory performance).

### Dual Degree

The Dual Degree refers to a bilateral co-enrolment agreement between two university institutions that enables a student to simultaneously complete an Undergraduate or Graduate program at both institutions.

## Dual Master's Degree

An Option in any Master's program. Master's students may opt to complete the requirements of a master's program in both their home university and a partner university in another country.

Elements are: (i) Undergraduate: majors, minors, concentrations, and specializations; there are a maximum number of elements that may be taken in conjunction with a program at the undergraduate level; (ii) Graduate: concentrations.

Elements are recorded on the transcript and the diploma.

## Equivalency

Courses that are of equal credit value and which are considered to be similar enough that they always preclude one another and may serve interchangeably for the other in terms of prerequisites, co-requisites, and program requirements. These will be identified in the calendar as 'Also Listed As', and are commonly referred to as 'cross-listed courses'.

## Experiential Learning

Experiential learning is the application of theory and academic content to real-world experiences within the classroom, the community, or the workplace. It may be undertaken independently or in teams. It advances learning outcomes and encourages reflection and application of skills and knowledge in contexts that prepare students for the workplace and civil society.

## F

#### Field

A Field occurs only at the graduate level, and is defined as an identifiable area of research activity undertaken by a group of faculty of sufficient number.

#### Description

Flex Term

Flex Term refers to the timing of delivery of 'asynchronous' on-line courses that are currently restricted to special students and in which they may register at any time. Special students may engage with the material of these courses at their own pace. The delivery of 'asynchronous' on-line courses does not therefore conform to the usual beginning and end of Carleton University terms.

**Formative** Assessment Formative assessments are those assessments of a student's work carried out during the course that act to provide feedback and guidance to the student in addition to assessing the student's performance.

Free Elective

Free electives are any approved credit course normally at the 1000-level or higher – including courses from the discipline, disciplines or intellectual areas that identify the major of the degree program in question that may be taken to make up the number of credits required for the degree program in question.

G

Program

General Bachelor's An undergraduate, non-honours Bachelor's program requiring a minimum of 15.0 credits.

Н

Honours Bachelor's Program

An undergraduate Bachelor's program requiring a minimum of 20.0 credits. Pathways to completion constituted by a thesis, research essay or significant project may demand a higher academic standard than a course-based pathway.

Ī

An internship is constituted through a course or sequence of courses that provides students with work experience directly related to the subject matter of their degree program. There are two types of internship:

Internship

- 1. Program Internship: an Option constituted by a structured sequence of at least 4.0 credits of courses at different year levels of an honours bachelors program taken in a work environment off-campus. A program internship provides students with extensive professional work experience directly related to the subject matter of their program.
- 2. Course Internship: an individual course within a degree program taken in a work environment either onor off-campus that provides students with professional work experience directly related to the subject matter of their program.

L

## Learning Outcomes

Learning outcomes are discipline-specific statements that describe the observable skills or abilities associated with the essential knowledge, behaviours, and/or values all students are expected to acquire by the end of a course or program of study.

Letter of Permission A formal document issued by the University Registrar approving a student to register in a course at another institution in lieu of a Carleton course in the student's academic program. The Letter of Permission must be issued before the student takes the course for credit in a Carleton program at another institution.

M

Major

A program Element recorded on the transcript and diploma. The major is constituted by the required course credits in one or more defined disciplines or intellectual areas that define the principle focus of a student's undergraduate program and constitute the basis for the calculation of the Major CGPA. The Major CGPA is calculated as the average grade points earned on the courses that constitute the major.

Each Minor requires at least 4.0 and at most 5.0 credits. Access to minors may be restricted. A minor introduces a student to, or extends their knowledge of, a discipline or intellectual area.

Option	An optional addition to or component of a program with requirements distinct from those of an Element: (i) Undergraduate: co-operative education, study abroad, Mention Francais, program internship; (ii) Graduate: co-operative education, Cotutelle (in Ph.D. programs), Dual Master's Degree (in master's programs), collaborative specialization. Options may be taken in addition to elements and are recorded on the transcript and the diploma.

Pathway	A pathway through a program is a route to completion such as: stream, thesis, research essay, research project, or course only. Pathways may be chosen in addition to Elements and Options, and are not recorded on the transcript or diploma.
Practical Assessments	Practical assessments are those assessments, such as exams or term work, of a student's work where the tasks and conditions are similar to what they would experience in a work environment and are designed to complement their academic skills and competencies.
Prerequisite	A required course or courses that must be completed successfully before registering in the course that requires the prerequisite.
Preclusion	Courses that contain sufficient content in common that credit may not be earned for more than one of the courses. Courses that preclude one another are not necessarily considered equivalent and may or may not

be interchangeable to fulfil program or specific element requirements.

#### Description

A specified combination of academic requirements in a discipline or intellectual area of study which leads to a credential (for example, B.A. in Philosophy, Ph.D. in History, M.Sc. in Chemistry, Graduate Diploma in Public Policy and Program Evaluation, Certificate in the Teaching of English as a Second Language).

There are five types of program at the undergraduate level:

- 1. Single-Discipline General Program: A General Single Discipline program is a program of at least 15.0 credits in which the courses that constitute the program's major are drawn overwhelmingly from one discipline or intellectual area.
- 2. Thematic General Program: A General Thematic program is an interdisciplinary program of at least 15.0 credits that concentrates on a particular interdisciplinary intellectual area or theme, and draws on courses within its major from at least three disciplines or intellectual areas.

#### Program

- 3. Single-Discipline Honours Program: A Single Discipline Honours program is a program of at least 20.0 credits in which the courses that constitute the program's major are drawn overwhelmingly from one discipline or intellectual area. Pathways to completion constituted by a thesis, research essay or significant project may demand a higher academic standard than a course-based pathway.
- 4. Combined Honours Program: A Combined Honours program is a program of at least 20.0 credits in which a student fulfils the requirements for combined honours majors in two such majors from two different programs. Pathways to completion constituted by a thesis, research essay or significant project may demand a higher academic standard than a course-based pathway.
- 5. Thematic Honours Program: A Thematic Honours program is an interdisciplinary program of at least 20.0 credits that concentrates on a particular interdisciplinary intellectual area or theme, and draws on courses within its major from at least three disciplines or intellectual areas. Pathways to completion constituted by a thesis, research essay or significant project may demand a higher academic standard than a course-based pathway.

#### R

Restricted electives are courses required to fulfil elective requirements in an undergraduate program that are not free electives. The courses that may fulfil restricted elective requirements in any program are in other words prescribed by the program.

#### Restricted Elective

Students should refer to individual program descriptions to determine the courses that may fulfil restricted elective requirements for a program.

## S

At the graduate level the term 'collaborative specialization' refers to an Option added to a degree program that provides an experience in a discipline or intellectual area in addition to that provided in the student's home program.

#### Specialization

At the undergraduate level, the term 'specialization' is reserved for specific areas of concentration in programs in which the courses constituting the program's specializations are delivered overwhelmingly by academic units other than the academic unit administering the program.

## Special Students

Students not admitted to a program or a degree leading to a Credential.

Status

#### Description

Full-time status for tuition fee purposes:

- 1. Undergraduate students are full-time when registered in a 60% course load per term as defined by the student's academic program: for example, registered in at least 1.5 credits per term in a 2.5 credit normal term course load. Undergraduate students should consult the website of the <u>Academic Advising Centre</u> to determine their eligibility for various Provincial and University services according to the number of credits taken each term.
- 2. Graduate students are normally admitted and must stay continuously registered as full-time. Students may apply to the Dean of Graduate and Postdoctoral Affairs for exemption from full-time status in exceptional circumstances (for example, medical circumstances); exemptions are normally granted for one term.

Part-time status for tuition fee purposes:

- 1. Undergraduate students are part-time when registered in less than a 60% course load per term as defined by the student's academic program (for example, registered in less than 1.5 credits per term).
- 2. Graduate students may be admitted as part-time students and will be required to continue and complete their program as part-time; a part-time student is not eligible to register in more than 1.25 credits per term, including audit courses.

A Pathway within an undergraduate program constituted by at least 2.0 credits of courses that facilitate concentration on a particular area of study within the program. Streams are not recorded on the transcript or diploma.

Summative Assessment

Stream

Summative assessments are those assessments of a student's work carried out at the end of a course or the end of specific components of a course whose sole purpose is to constitute a judgement on a student's performance in the course or a specific component of the course.

### Т

### Transfer Credit

Academic credit granted for individual courses successfully completed at another institution, either upon admission (admitted with advanced standing from secondary school, or transfer from college or university) or while registered with a Letter of Permission or on exchange.

Transcript

The official record of a student's academic registration and accomplishments at Carleton University.

## U

## Undeclared Students

Undergraduate students admitted to a degree who have not chosen a program ('declared a major') within that degree; normally, students are required to choose a program ('declare a major') before reaching second-year standing.

#### W

A formal process for discontinuing studies in a course or a program.

## Withdrawal

Undergraduate students who wish to drop all courses and terminate their registration in the academic program must follow the procedure available through the Registrar's Office. Students who have been away from the University for nine or more consecutive terms will be withdrawn and must re-apply for admission.

Graduate students who wish to drop all courses and terminate their registration in the academic program must notify their department in writing of their intention to withdraw. Students who do not register for three consecutive terms or do not register continuously in their thesis, research essay, or independent research project will be withdrawn and must re-apply for admission.
