The Ontario Secondary School Diploma (OSSD) or equivalent including a minimum of six 4U or M courses. The six 4U or M courses must include English (or *anglais*), Advanced Functions, and either Calculus and Vectors or Mathematics of Data Management. Note that Calculus and Vectors is preferred.

Applicants submitting an English language test to satisfy the requirements of the [English Language Proficiency section of this Calendar](#) may use that test to also satisfy the 4U English prerequisite requirement.

**Bachelor of Commerce (B.Com.)**

No direct entry; access is restricted.

**Advanced Standing****Bachelor of Commerce (B.Com.) (Honours)**

Applications for admission to the second or subsequent years will be assessed on their merits. Applicants must present an overall CGPA of 9.00 (B+) or higher.

Students may also be assessed for admission to second and subsequent years if they present with a minimum of 3 out of the following 6 courses (or equivalent): BUSI 1001, BUSI 1002, ECON 1001, ECON 1002, BUSI 1800, and MATH 1009 with no individual grade below C+ and with a Major CGPA of 7.00 or higher. Note that MATH 1007, MATH 1004, MATH 1052, or MATH/ECON 1401 ~~and MATH/ECON 1402 (both required)~~ are acceptable for transfer in lieu of MATH 1009.

Advanced standing will be granted only for those courses that are determined to be appropriate

Applications by B.I.B. (Honours) students for admission to the second or subsequent years of B.Com. (Honours) will be assessed on their merits. Students must present a Major CGPA and an Overall CGPA consistent with the [Academic Continuation Evaluation](#) requirements for B.Com. (Honours) students. Advanced standing will be granted for those courses determined to be appropriate.

**Bachelor of Commerce (B.Com.)**

No direct entry. Access is restricted to students in the Bachelor of Commerce (Honours) and Bachelor of International Business (Honours). (See Regulations for Business.)

**Co-op Option****Direct Admission to the First Year of the Co-op Option**

Applicants must:

1. meet the required overall admission cut-off average and prerequisite course average. These averages may be higher than the stated minimum requirements;
2. be registered as a full-time student in the Bachelor of Commerce (Honours) program;
3. be eligible to work in Canada (for off-campus work placements).

Meeting the above requirements only establishes eligibility for admission to the program. The prevailing job market may limit enrolment in the co-op option.

From Maria Walt ----- Good morning, Jen. As promised, here is the information for the advanced standing change for 202430. The strikethrough text should be removed – ECON 1401 has been approved to substitute MATH 1009. There is a preclusion between both courses. The preclusion between ECON 1402 and MATH 1009 has been removed – it is not required here for admission anymore. Students may also be assessed for admission to second and subsequent years if they present with a minimum of 3 out of the following 6 courses (or equivalent): BUSI 1001, BUSI 1002, ECON 1001, ECON 1002, BUSI 1800, and MATH 1009 with no individual grade below C+ and with a Major CGPA of 7.00 or higher. Note that MATH

**For Interactive Multimedia and Design:** the six 4U or M courses must include Advanced Functions. In addition, candidates for BIT in Interactive Multimedia and Design must submit a portfolio of any kind of work that demonstrates the applicant's creativity and aptitude in design work. **For Network Technology:** the six 4U or M courses must include one of Advanced Functions or Calculus and Vectors or Mathematics of Data Management (Calculus and Vectors recommended).

#### Advanced Standing

Hi Katie and Pam,

Thanks for meeting with me recently to discuss MPAD's Co-op work-study pattern. To summarize, I believe these are the concerns you identified:

-MPAD students would like to work earlier than winter of third year (which is currently their first opportunity – see their W/S pattern directly below). The department supports this. You indicated that your students find it somewhat de-motivating that the first entry point is the winter of second year, but the first work term is not until the winter of third year.

-MPAD students and faculty rather dislike that year three is broken up (fall being a study term and winter being a work term) because two of your compulsory classes are meant to be taken sequentially (one right after the other). Students who work in the winter have to wait a whole year to take "Part II" of the class in question. This is not ideal from a pedagogical standpoint.

I have raised your concerns with Katie LeBlanc, Manager of the Co-op Program, as well as some of our Business Development Coordinators, who are familiar with hiring trends. After some discussion, we feel the best way to address your department's concerns is to amend the MPAD work-study pattern so that it matches the Bachelor of Communications and Media Studies (see second W/S pattern below). This would mean that MPAD students' first opportunity to take COOP 1000 would be fall of second year, and their first work term would be summer after second year. In total, this pattern features two summer work terms, one fall, and one winter. As you know, your students need to complete three co-op work terms in order to achieve the Co-op Designation upon graduation.

A couple of things to be aware of: as I mentioned during our meeting, summer job searches, generally speaking, are the most competitive. Moreover, if you decide to match B.CoMS' pattern exactly, your students would be in competition with them for some of the same jobs. Having said that, MPAD students' summer track record is very good:



Summer 2023: 10 out of 12 students were employed  
 Summer 2022: 12 out of 15 students were employed  
 Summer 2021: 9 out of 10 students were employed

Given these impressive employment rates, the Co-op Office would support MPAD changing its work-study pattern to match B.CoMS'. If you would like to go ahead with this change for the 2024-25 school year, please let me know as soon as possible. The Undergraduate Calendar editor has asked me for final Courseleaf submissions within the next week or so.

Should you have any questions, please don't hesitate to let me know.

#### Rationale for change

Adjusting MPAD's work-study pattern so that students can work earlier (summer after second year, rather than winter of third year). This aligns with the department's and their students' wishes. Admission requirements remain the same.

#### Transition/Implementation

Students admitted to Co-op in fall 2024 and after will receive this work-study pattern. Students admitted prior to this will have the older work-study pattern. Department and Co-op will communicate this to students.

### 2.1.2 Full- and Part-time Study

When responding to a legitimate request from an external agency that has not supplied its own definition, the following definitions are used:

1. A *full-time undergraduate student* is one who is registered in at least 1.5 credits per academic term.
2. A *full course load* is the normal maximum course load as defined by the student's program and is evaluated term by term.

#### 2.1.2.1 Regularly Scheduled Break (Undergraduate)

For immigration purposes, the summer term (May to August) is considered a regularly scheduled break approved by the University. Students should resume full-time studies in September.

**Note:** a regularly scheduled break as described for immigration purposes does not supersede the requirement to register in co-op, a practicum, an internship, or for continuous registration in a thesis course.
