#### Rationale for change

These changes are needed to enable sociology MA students to fulfill the requirements of the concentration in quantitative methodology using the coursework option. The changes also restrict the additional required courses to SOCI 5102 and SOCI 5104 which are the only two quantitative methods courses that we offer. This is to ensure that students have actually taken courses related to quantitative methods prior to graduating with the concentration in quantitative methodology. Otherwise, students could graduate with the concentration in quantitative methods without having taken any quantitative methods courses. Finally, "With department permission 0.5 credit maybe selected from courses at the 4000-level" is added so that the text is comparable to that of the MA in Sociology.

#### Summary

new post-bac diploma program

This proposed change to our program will serve to advance Carleton's institutional priorities, as outlined in the SIP plan. Specifically, by transitioning the Q-year into a diploma, we are transforming a programmatic necessity into a free-standing academic credential. This will increase the potential appeal of our undergraduate offerings, both to incoming MA students, and to prospective students who have already finished a BA degree and are seeking out additional training. As such, implementing this change will increase the Religion Program's ability to share knowledge with a broader cohort of undergraduate and post-BA students. Likewise, by creating a more robust pipeline between the undergraduate and graduate degrees, this proposed change will also allow the Religion Program to more effectively serve Ottawa and serve the world by providing an important new learning opportunity to mature students, especially those in the civil service. One of the rationales for choosing to focus our MA on Religion and Public Life is tied precisely to Carleton's location in Ottawa: a city whose primary employer is the federal government. A more religiously literate civil service would be an unfettered good for Ottawa, but also for Canada's general public as a whole. This, of course, also speaks to Carleton's EDI priorities. Religious diversity is one of the hallmarks of Canada's famed commitment to multiculturalism, as enshrined in the Canadian Charter of Human Rights and Freedoms. By helping the Religion Program more effectively recruit new students and by offering an independent credential in Religion for students who already possess a BA, the proposed program change represents an incremental step toward Carleton's overall goal of providing an education that highlights the diversity of Canadian culture, and that provides both theoretical and practical tools for constructing a more inclusive society.

#### Rationale

#### Transition/Implementation

Given that we are already offering the Q-year to incoming MA students, transitioning this requirement into a Post-Baccalaureate Diploma will incur no additional costs and require no additional resources. Q-Year students will now be able to receive a diploma instead, and we can eliminate the Q-Year. At the moment, we anticipate only one or two students per year, however we hope this number will increase with the offering of the diploma. Students will apply to the Religion program graduate admissions committee (as all potential graduate students do) who will deliberate and decide on eligibility and suitability to the program.

Subject: Major Program Modification (A2) – Post-Baccalaureate Diploma in RELI

#### Program Description:

As the acting coordinator of the Religion Program, I am pleased to announce that our forward-looking, and still relatively uncommon,<sup>1</sup> decision to focus our MA program on the specific sub-specialization of *Religion and Public Life* has led to a steady growth in our ability to recruit qualified graduate students over the last few years.

In our attempt to be as welcoming as possible to students with a wide variety of educational backgrounds, and in recognition of the multi-disciplinary character of Religious Studies, we gladly accept applications from students whose undergraduate studies have focused on a variety of cognate topics. That said, in cases where students seek to enter our program without the requisite background in Religious Studies – and especially if they are lacking a grounding in courses related to the theories and methods particular to RS as an academic discipline – we require them to complete a Qualifying (Q) year prior to their formal admission into the graduate program.

To date, a number of our graduate students have finished the Q-year and then gone on to successfully complete the program. That said, this requirement has also often served as an impediment to initial enrollment. I have been informed by several prior grad coordinators that many prospective students have lost interest in joining our program after being informed of the Q-year requirement. As such, we seek to re-implement our Q-year program as a **Post-Baccalaureate Diploma in Religion**, following the example of other FASS departments that have already done so (e.g., Art History, Cognitive Science, and Film Studies). The q-year has fluctuated in previous years between 3.0 and 3.5 credits. Usually, students were required to take RELI 1710 Judaism, Christianity, Islam; RELI 2350: Classical Islamic Thought; RELI 4741 Contemporary Issues in the Study of Religion; and RELI 4850 Seminar in the Study of Religion with additional electives of the student's choice.

We see two major merits to this modification of our program: first, it will provide a tangible benefit (i.e., the credential) to students wishing to enter the MA, thus reducing the barrier to entry erected by the existing Q-year protocol; second, it could potentially attract new mature students to our undergraduate program, who are simply seeking to augment their existing undergraduate degree with a specific, focused palette of classes tied to the academic study of religion. In both cases, I would argue that it is a net positive for both our program and the university, as it will increase the viability and visibility of both

the Religion and Public Life MA and the Religion program as a whole, while incurring no additional costs or obligations at the Faculty-, program-, or university-levels.

The post-baccalaureate Diploma entails the following program structure:

- 1. 1.0 credits in RELI theory: RELI 3741 (0.5) and RELI 4741 (0.5)
- 2. 1.0 Breadth Credits in RELI (2<sup>nd</sup> year or above- 0.5 credits from *Traditions and Contexts: Judaism, Christianity, and Islam; Traditions and Contexts: Hinduism, Buddhism, Religions of China.* Indigenous Religions (RELI 2800) can be submitted for either).
- 3. 1.0 credits in RELI at the 3000-level or above.
- 4. 1.0 credits in RELI at the 4000-level.
- 5. Requests for alternative course choices may be granted at the discretion of the Religion Program Undergraduate Supervisor. In addition, 0.5 credit of coursework may be taken outside the department, assuming the approval of the Religion Program Undergraduate Supervisor.

Admission Requirements: Admission to this program requires the permission of the Religion program. Normally, students would be required to have completed an undergraduate degree with a minimum B average or higher to be admitted. Applications will be reviewed on a case-by-case basis.

Current International, National, and Provincial Profile

As noted above, Carleton's MA in Religion and Public Life is one of very few such programs currently being offered at North American universities. Likewise, our undergraduate program, in being constructed to lead logically into the MA, is similarly distinctive. In a survey of Canadian undergraduate Religious Studies programs that I conducted several years ago, I discovered that Carleton's program requires almost twice the credits in theory and methods as compared to the average program (3 vs. 1.6), highlighting our commitment to Religious Studies as a distinct field of academic inquiry. These requirements also speak to the necessity of our Q-year program, as we expect more prerequisite disciplinary knowledge from our incoming MA students than do many comparable programs. By allowing our incoming MA students to earn a post-baccalaureate diploma for their qualifying years, we can transform what could be seen as an onerous requirement (i.e., the necessity that certain incoming students "catch up" with their peers) into a strength. This is, of course, the same logic used to justify the other FASS post-bac diplomas, as outlined here: https://admissions.carleton.ca/certificates/

#### Mission and Strategic Directions

This proposed change to our program will serve to advance Carleton's institutional priorities, as outlined in the SIP plan. Specifically, by transitioning the Q-year into a diploma, we are transforming a programmatic necessity into a free-standing academic credential. This will increase the potential appeal of our undergraduate offerings, both to incoming MA students, and to prospective students who have already finished a BA degree and are seeking out additional training. As such, implementing this change will increase the Religion Program's ability to **share knowledge** with a broader cohort of undergraduate and post-BA students. Likewise, by creating a more robust pipeline between the undergraduate and graduate degrees, this proposed change will also allow the Religion Program to more effectively **serve Ottawa and serve the world** by providing an important new learning opportunity to mature students,

especially those in the civil service. One of the rationales for choosing to focus our MA on Religion and Public Life is tied precisely to Carleton's location in Ottawa: a city whose primary employer is the federal government. A more religiously literate civil service would be an unfettered good for Ottawa, but also for Canada's general public as a whole. This, of course, also speaks to Carleton's EDI priorities. Religious diversity is one of the hallmarks of Canada's famed commitment to multiculturalism, as enshrined in the Canadian Charter of Human Rights and Freedoms. By helping the Religion Program more effectively recruit new students and by offering an independent credential in Religion for students who already possess a BA, the proposed program change represents an incremental step toward Carleton's overall goal of providing an education that highlights the diversity of Canadian culture, and that provides both theoretical and practical tools for constructing a more inclusive society.

#### *Impact on Other Programs*

While we hope that this proposed change will allow the Religion program to recruit new MA students more effectively, there is no reason to assume that it will draw students away from existing Carleton programs. More than anything, we would expect this change to allow us the opportunity to recruit outside students (and especially mature students) in greater numbers.

#### Societal Need

As noted above, religious diversity is one of the pillars of Canadian multiculturalism. That said, the role of religion in Canadian life (both historical and contemporary) is by no means simple, nor is it an unalloyed good: consider, for example, the role of Christian denominations in administering Canada's residential schools, the passage of Quebec's discriminatory Bill 21, and the employment of apocalyptic Christian language and imagery by the convoy protesters that shut down our city for weeks earlier this year. Our program provides students with the historical context and practical tools to make sense of such phenomena, while also laying the groundwork for the sort of engagement and empathy that allow for productive participation in civil society.

Graduates of Carleton's Religion program have gone on to productive careers in government, law, higher education, the tech sector, and elsewhere. The practical abilities and aptitudes developed via a liberal arts education, like the one offered in our program, are precisely the sort of transportable skills highlighted in the RBC's 2018 report on the future of the Canadian job market: *Humans Wanted – How Canadian Youth Can Thrive in the Age of Disruption*.<sup>2</sup>

By replacing a disincentive to enrolling in our MA program (the Q-year) with an incentive (a Post-Baccalaureate Diploma), and by offering a free-standing credential for interested mature students, this proposed program change will provide the Religion Program with improved recruitment opportunities, allowing us to more robustly address the societal needs outlined above.

#### Student Demand

As noted above, the Q-year requirement has been a disincentive to potential students considering joining our MA program, as reported by past and present Graduate Coordinators, who have come to this conclusion following years of informal conversations with potential MA students. In the past five years, there have been 2 students (one in 2020 and one in 2022) registered in the q-year and 3 students have deferred their start until next year (for various reasons). This speaks strongly to the potential student demand for a Post-Baccalaureate Diploma. The fact that so many other FASS programs have already made this switch is a further testament to its utility and desirability. At the moment, we anticipate only one or two students per year, however, we hope this number will increase with the offering of the diploma.

#### Resources

Given that we are already offering the Q-year to incoming MA students, transitioning this requirement into a Post-Baccalaureate Diploma will incur no additional costs and require no additional resources.

**Modification Description**: The proposed modifications to the Indigenous Studies program involve 1) creating a 15-credit General BA and a 20-credit Honours BA to provide students with the opportunity to earn stand-alone Indigenous Studies degrees; 2) making the program requirements for the Combined Honours BA less prescriptive to give students more course options to complete the program; 3) updating the titles and calendar descriptions of courses to remain current and more closely reflect the field of Critical Indigenous Studies; and 4) augmenting course offerings by introducing two new second-year courses that fill gaps in the curriculum, Inuit Ontologies and Global Indigenous Studies.

The changes listed above constitute a 33% change to the program. All proposed changes are informed by discussions and consensus of the Indigenous Studies program committee, as well as agreement within the School membership. The proposed modifications reflect the ongoing commitments and priorities in the program to deepen and broaden Indigenous-focused and -led teaching and learning at Carleton. The proposed changes also align with the content and calls to action in the Kinàmàgawin report.

The updates to the language of the course titles and calendar descriptions pertain to the first- and second-year courses. As part of the long-term vision that faculty in Indigenous Studies developed to expand the program and reflect current priorities within the field, proposed modifications at the third-and fourth-year level will be introduced next year. Faculty in Indigenous Studies see the future of the program cohere around the following priorities: Critical Indigenous Studies; Indigenous temporalities and futurity; Global Indigenous Studies; Gender, Two-Spirit and Indigiqueer Studies; Land-based learning; Bodies and borders; and Decentering colonial power. These priorities are reflected in the language of the proposed calendar updates and the two new course descriptions.

#### Changes to the program structure include the following:

1. Introduction of a 15-credit General BA and a 20-credit Honours BA.

- 2. Removal of specific course requirements for the Combined Honours BA.
- 3. For the Combined Honours BA, revising the third- and fourth-year requirements from 1.0 to 1.5 credits each, while reducing the requirements for electives from 1.5 (from the list of approved electives) and 1.0 (for electives at the 4000-level) to 1.0 and 0.5 credits, respectively.

**Graduation requirements**: The graduation requirements for the 15-credit BA are 7.0 credits included in the Indigenous Studies major and 8.0 additional requirements. The graduation requirements for the 20-credit Honours BA in Indigenous Studies are 9.0 credits included in the Indigenous Studies major and 11.0 additional requirements.

**Delivery:** The delivery of the Indigenous Studies program is unchanged. The majority of courses are to be offered in person. Depending on the circumstances of students and instructors, however, there may also be reasons to offer specific courses online.

**Impact on other programs:** The impact of the proposed changes to Indigenous Studies programming on other programs is considered to be minimal. Many of our courses are identified as approved electives in a wide range of sister disciplines and a few programs have made Indigenous Studies courses mandatory. We believe that the updated course titles and descriptions, as well as the two new courses, will have even greater appeal to students in other programs.

**Impact on learning outcomes**: The modifications included in this proposal will not impact the learning goals of the program. We anticipate more updates to the program as well as the learning outcomes in subsequent modifications proposals but initial meetings with OVPAVPA have commenced.

**Student demand:** Student demand for Indigenous Studies courses is high across programs and faculties. Based on what instructors have observed in their classrooms, students are particularly interested in land-based learning opportunities, global Indigeneity, and the conversations within Critical Indigenous Studies, particularly in Gender, Two-Spirit and Indigiqueer Studies. Adding stand-alone Indigenous Studies degrees will provide students with more options to pursue their interests in Indigenous Studies. We anticipate that students will respond very positively to the updates to the calendar at the first-and second-year levels that will make the program more current. The two new second-year courses address serious gaps in the curriculum, and we believe that both Inuit Studies and Global Indigenous Studies courses will be popular with our program students and students in other programs.

**Resources:** The proposed changes are fairly minor and should be resource neutral. We hope to continue to grow the program and hire new faculty in the future. Faculty in the Indigenous Studies program have the expertise to teach the updated and new courses, with the exception of Inuit Ontologies which should be taught by an Inuk colleague. We will also seek to increase the number of cross-appointed Indigenous faculty from other units. The School is currently well supported by its administrative staff.

a. Faculty resources: While additional faculty are not required to enact the changes proposed here, we certainly hope to be in a position to strengthen and diversify the Indigenous Studies program by hiring more full-time faculty members in the future. We can enact the current proposed changes with the School's faculty and contract instructor contingent. However, given the imminent departure of a full-time faculty member and the secondment of another full-time faculty member to the Office of the Associate Vice-President Indigenous Teaching, Learning and Research, we anticipate that we need to engage in faculty renewal to continue to sustain

- curriculum innovation. We plan to explore options to work with Indigenous colleagues in other units to address the teaching needs and further growth in Indigenous Studies.
- b. *Contract instructors*: With the existing faculty complement, delivery of the program will not require additional contract instructors.
- c. Administrative support: While the changes in programming are not expected to impact on the workload of administrative staff, the potential impact on administrative support would need to be monitored, given the expanded range of programs and two additional courses.
- d. *Library resources*: a Library Report will be requested by FGPA (graduate programs) or OVPAVPA (undergraduate programs). The proposed changes will have no significant impact on library resources.
- e. Space: Additional space will not be required for the modifications in the programming.
- f. Equipment: Additional equipment will not be required for the modifications in the programming.
- g. *Graduate student funding*: Changes to programming apply only to the undergraduate programs in Indigenous Studies.

## INDG 2020 Decolonizing Gender, Sex, and Sexuality

## Effects of colonization in unbalancing Indigenous peoples' lives through the imposition of constructions of gender, sex, and sexuality, and the ways that Indigenous peoples are working to restore balance to their families and communities.

#### INDG 2020 Indigenous Feminisms: Perspectives on Gender, Sex, and Sexualities

Indigenous articulations of gender, sex, and sexualities. This may include a focus on specific embodied roles and responsibilities within Indigenous communities, individual and collective identities, gender-based violence and resistances, and complex relationships between external and lateral systems of power and privilege.

## INDG 3011 Indigenous Rights, Resistance, and Resurgence

Summary

This new 0.5 credit 4th year course provides students with an opportunity to critically reflect on the theme of religion and public life through experiential community-engaged learning. Through a 30-hour placement, students will (1) enrich their knowledge and understanding of religious community/communities, (2) apply religious studies theory, knowledge, and skills in a professional context, (3) reflect on their experience as a case study for religion and public life (4) contribute meaningfully to a community-based program and (5) gain substantive real-world professional experience.

Class Format text:

A Practicum Course (with some synchronous check-ins with instructor/coordinator, see details

below).

#### Check-Ins:

Successful completion of all Check-Ins are required and reflected in the final grade for the course.

- 1. Weekly: The student will document their hours and tasks each week on Brightspace and will immediately signal any issues which may delay or otherwise impede their ability to attend and fulfill the terms of their placement.
- 2. (If we have two or more students placed in one term): Weekly: The students will meet with the faculty supervisor and other students registered in the experiential learning course once every three weeks to discuss their placements and how their placement relates to the academic study of Religion.
- 3.(if we do not have two or more students placed in one term) Week Three: The student will meet with the coordinator to discuss placement and any concerns).
- 4.Week Three: The coordinator will also follow up with the placement supervisor to identify any concerns the placement supervisor may have and raise these with the student.
- 5. Week 6 (midterm): The student will submit a 2-3 page mid-term report on the placement. This midterm report is aimed at ensuring that the placement is proceeding appropriately and provide an opportunity for any corrections that need to be made to allow the successful completion of the placement. It also serves as a proposal for the final report.
- a. summarize the tasks and goals of the placement and signal any challenges that should be addressed in order to complete the placement successfully (1-2 paragraphs)
- b. draw preliminary connections between their observations at the placement and Religion coursework. (1 page)
- c. suggest 2-3 questions that will focus their Final Analysis & Reflection (FAR) including framing their learning in terms of the study of religion and public life.
- d. identify and annotate a preliminary bibliography for sources that will be relevant for the FAR 6. End of Term: The student will submit a 10-12 page Take-Home Final Analysis & Reflection (FAR) which reflects on their professional experience in the placement

In keeping with the University's commitment to Experiential Education, and our program's internal efforts to engage more directly with Religion and Public Life (defined broadly), we are proposing this community-engaged learning course to offer students the opportunity to gain first-hand experience with the ways that religion is implicated in public life in our community.

Implementation: in the semester in advance of the placement students should meet with the experiential learning coordinator to complete the following approval process:

- 1. 8-6 weeks before the start of term: Meet with the experiential learning coordinator to better understand the goals and parameters of this course and to explore possible placements. The coordinator's role is to help students navigate the application process and facilitate and negotiate the terms of a placement with the host program or organization.
- 2. Apply to participate in the experiential learning course by filling out the online form on the Religion program web site no later than 6 weeks before the start of term.
- 3. 6-4 weeks before the start of term: With student interests in mind, the experiential learning coordinator will seek out appropriate possible placements over the summer, students should not seek out their own placements.
- 4. 4-3 weeks before term: Matching process: Students will be given list of placements that are available with contact information.
- 5. 3-2 weeks before term: placement confirmed.
- 6. Term starts: placement begins no later than the second week of classes.

New course.

The Department of Neuroscience currently offers four capstone course options, with NEUR 4906 and NEUR 4908 best suited to students interested in pursuing graduate studies. In response to COVID measures, several NEUR students had NEUR 4908 projects switched to the completion of meta-analysis or systematic reviews with successful results, including published papers. These projects use defined methodologies for literature searches, assessment of data quality, and statistical analysis of previously published research and are thus considered examples of novel research, akin to NEUR 4908. Given the success of these projects as well as student interest we plan to formalize this as a capstone option for our honours thesis students.

Rationale for new course

NEUR 4002 provides students with key training in the methodologies required for the proposed NEUR 4904 project. Furthermore, student in NEUR 4002 can select their own topic for preliminary explorations of published literature that could form the foundation for the NEUR 4904 thesis.

The planned structure for NEUR 4904 is therefore for students to join NEUR 4002 for the fall semester and receive the same training while focusing on their own NEUR 4904 research topic. In the winter semester, students will continue developing and completing their honours research thesis in Systematic Reviews or Meta-Analyses under the individual supervision of faculty, with the goal of generating a publishable product.

Over the past seven years the research skill requirement – that students demonstrate either a language skill or take a graduate level 0.5 credit methods course, regardless of whether they have any previous knowledge of research methods – has not been enforced. However, incoming M.A. and Ph.D. students have been required to demonstrate that they have taken a research methods course, and if not, have been required to take PSCI 5700. This change brings the calendar in line with current practice. The proposed change mirrors the language that is already in the calendar for the corresponding Political Theory requirement.

The normal requirement for admission to the master's program is B.A.(Honours) (or the equivalent) in Political Science, with at least high honours standing.

The Faculty of Graduate and Postdoctoral Affairs requires applicants whose native language is not English to be tested for proficiency in English. Applicants to the Political Science graduate program must meet the General Regulations requirements.

<u>Applicants must have completed</u> It is anticipated that candidates will enter having taken some political theory at the undergraduate <u>level</u>, or will be required to take PSCI 5310 History of Political Thought. <u>level</u>. Those who have not will be required to take PSCI 5310 History of Political Thought. This 0.5 credit counts toward the normal MA program requirements of 5.0 credits.

<u>Applicants must have completed a social science research methods course at the undergraduate level, regardless of their desired field of specialization, or will be required to take PSCI 5700 Basic Research Methods or PSCI 5705 Approaches to the Study of Political Theory. This 0.5 credit counts toward the normal M.A. program requirements of 5.0 credits.</u>

Honours graduates in fields other than political science will be considered on the basis of their academic background and standing, and will be judged on a case-by-case basis. Those with only minor deficiencies may be required to take certain specified courses, while others whose degrees are less closely related to political science may be required to register in the qualifying year, at the discretion of the Department. Graduates of three-year programs in political science will be required either to complete the fourth year of an honours degree and reapply, or register in the qualifying year, depending on work completed to date and academic standing. The qualifying year is intended only for those students (with at least an 8.0 grade point average) whose universities do not offer an Honours degree or for graduates in other fields who did not major in political science. The qualifying year program is not intended to be a method for improving a student's undergraduate record. Admission to the qualifying-year program does not imply automatic admission to the master's program.

## Accelerated Pathway

The accelerated pathway in the Department of Political Science is a flexible and individualized plan of graduate study. Students in their final year of a Carleton B.A. Honours degree in Political Science with demonstrated academic excellence and aptitude for research may qualify for this option.

Students in their third-year of study in the B.A. Honours degree in Political Science should consult with both the Undergraduate Supervisor and the Graduate Supervisor to determine if the accelerated pathway is appropriate for them and to discuss the selection of courses for their final year of undergraduate studies.

#### **Accelerated Pathway Requirements**

- 1. At least 0.5 credit in PSCI courses at the 5000-level with a grade of B+ or higher.
- 2. Minimum overall CGPA of 10.5.

Students may receive advanced standing with transfer of credit of up to 1.0 credit which can reduce their time to completion.

#### **Modification Description**

Rationale and Description: This modification is for the introduction of two Streams as pathways; one in Investments and the other in Corporate Finance, both offered through the Finance Teaching Area. No two Streams offered by the Sprott School have common courses. These Streams, unless explicitly stated to the contrary, will be offered to students through both the BCom and BIB programs. Students in either program would follow a pathway through either a concentration or non-concentration to a Stream. The BCom and BIB cores both contain 12.5 credits, with concentrations containing 4.0-4.5 credits depending.

The development of the Streams is in direct response to Sprott's current Strategic Plan:

Principle 1: Transformational Lifelong Learning Journeys
Goal 2: Develop unique curricula and integrated opportunities for experiential learning

The Streams in Investments and Corporate Finance will be undergraduate programming specifically targeted to undergraduate business students not pursuing a concentration in Finance, yet providing these students with exposure and an introduction to the discipline(s) at the undergraduate level. The streams have been designed to equip these students with the foundational skills and knowledge in the fields of Investments and Corporate Finance that apply to their particular interests. Students will be exposed to key concepts and topics in Investments and in Corporate Finance, and accompanied with the Commerce degree, students will explore the applications of these two sub-disciplines in various business settings. The streams are designed to be an introduction to these two areas and address the fundamental concepts and applications for those students wanting to explore it further, as it pertains to their discipline.

It is expected that students in other areas (most notably, but not exclusively, Accounting and Business Analytics) will pursue streams in Corporate Finance and Investments respectively, to complement their studies. This will allow for these students to gain some background in closely related fields as they apply to their disciplines, creating a more marketable and better-informed student. As the courses in each Stream are unique, it is possible for students to therefore complete the equivalent of a second pathway through their elective courses. As noted below in the credit requirements, each Stream contains 1.5 credits of unique courses.

*Program Structure*: The Streams in Investments and Corporate Finance will be available to students registered in the B.Com and BIB programs only. Neither Stream will be available to students pursuing a concentration in Finance, as these courses are embedded within that concentration.

#### 1. 1.5 credits in:

BUSI 3502 [0.5]	Investments

#### Requirements For Corporate Finance Stream

BUSI 4510 [0.5]	Mergers and Acquisitions

The courses which comprise the Streams already exist within the Finance concentration and will be offered in face-to face, online or HyFlex delivery, dependent on the environment.

#### **Impact on Other Programs**

The Streams are expected to enhance our recruitment efforts by allowing students not enrolled in the Finance concentration access to a transcript notation. There is no expectation of a decline in enrolments in other areas within business as there is no overlap. As these courses already comprise the Finance concentration (students in that concentration must complete all of the courses above), the expected impact will be increased enrolments from other students.

#### Impact on Learning Outcomes and Curriculum Map

The following program learning goals and objectives for the Bachelor of Commerce and Bachelor of International Business will be further explored within the Streams:

BC1 Knowledge: Graduates will be skilled in applying foundational business knowledge to appropriate business contexts

- 1.1 Graduates will interpret and critique quantitative and qualitative data to draw conclusions through a summary of findings.
- 1.3 Graduates will use financial information, models and datasets to make decisions.

<sup>\*</sup>To note, both BUSI 4500 (Corporate Finance Stream) and BUSI 4502 (Investments Stream) require STAT 2602. STAT 2602 is a core concentration requirement for students in Finance and for students in Business Analytics. Students pursuing these Streams must satisfy that prerequisite condition.

BC3 Critical Thinking: Graduates will be discerning critical thinkers, able to discuss different viewpoints, challenge biases and assumptions, and draw conclusions based on analysis and evaluation

3.1 Graduates will make decisions by gathering, interpreting and applying information from a variety of sources to address complex business issues

Students will not only explore these learning objectives within their Major (Concentration), but also through the lens of Finance. Additional exposure to these learning objectives will provide greater depth, specific to the application of Investments and/or Corporate Finance.

#### Societal Need

Ontario presently has 12,235 CFA Charterholders (https://info.cfainstitute.org/CFA-21A-Acquisition-Nurture\_cfa-fy21-map-feb.html?s\_cid=eml\_CFA21ANews\_T6SI). This number trails only the State of New York (13,228) and the United Kingdom (12,459). The CFA Charter is *the* required certification for work in the field of Finance in Ontario, and most of our Sprott Finance students remain in Ontario (Toronto the top draw). This was one of the primary motivations for developing our new Master of Finance, and it is only expected to continue to grow in numbers throughout the world as markets and investors continually become more sophisticated. Developing key skills in either of these two areas (or both) will enhance our recruitment efforts and allow students in the Accounting or Business Analytics concentrations (other concentrations are more tangential) to broaden their toolkit and gain valuable skills and knowledge in key areas that CFA has indicated are critical to the investment industry.

#### **Student Demand**

The Streams in Investments and Corporate Finance will allow students to develop marketable skills in both the markets and firms sides of the financial world, and allow students beyond core finance to explore the potential for a CFA charter. In keeping with our other Streams, this provides students with further choice in creating a bespoke degree specific to their career needs. Not only can a student now

include the Streams in Investments and/or Corporate Finance in completing their degree, but they can create independent combinations of streams or concentrations to better market themselves.

#### Resources

We do not initially anticipate a need for a full-time faculty member at the assistant level or higher, but anticipate that there may be significant growth. It is possible that there will be increased demand that may require the addition of sections in some of these courses, though we anticipate that there is still a bit of room to grow before we hit section size capacity. As Streams become more commonplace, especially in Finance and Business Analytics, we will monitor to determine whether these Streams replace other concentration electives or whether they add to it. Neither Library nor space requirements are needed.

**Introduction of a New Graduation Pathway** 

TIM is an inter-faculty program of the Sprott School of Business and the Faculty of Engineering and Design (FED). The TIM program started operating a Centre for Cross-Border, Digital & Inclusive (CBDI) Entrepreneurship that will enhance Carleton's entrepreneurship agenda by focusing on digital transformation and digital entrepreneurship research, education, and value creation for companies and organizations in the Ottawa-Carleton region.

The TIM program currently offers three project-based pathways: Master of Engineering (MEng); Master of Entrepreneurship (MEnt); and the Master of Applied Business Analytics (MABA). The proposed modification consists of introducing a new graduation pathway within the Technology Innovation Management (TIM) Master Program titled "Master of Digital Transformation & Entrepreneurship (MDTE) in Technology Innovation Management" and the new corresponding project, TIMG 5908 (Master of Digital Transformation & Entrepreneurship Project). The new MDTE graduation pathway will complement existing pathways, support the TIM's program objective to enhance Carleton's entrepreneurship agenda, and grow the number of TIM full-time students from 200 to 400 in the next three years.

The new pathway draws on three new courses being independently proposed as electives for the extant pathways: TIMG 5008 (Foundations of Digital Transformation & Entrepreneurship), TIMG 5202 (Moving Digital Transformation & Entrepreneurship Research into Business Practices), and TIMG 5203 (Cross Border Businesses and Digital Innovation).

 TIMG 5008, TIMG 5202 and TIMG 5203 are new courses which are compulsory for students on the new MDTE graduation pathway and are available as electives for TIM students on other TIM graduation pathways. A version of the new TIMG 5203 (Cross Border Businesses and Digital Innovation) was offered previously as a section of TIMG 5103: Advanced Topics in TIM.

- The MDTE project (TIMG 5908) is comparable to the existing graduate project courses for the MEng (TIMG 5901), the MEnt (TIMG 5905) and the MABA (TIMG 5907) pathways. It follows the same TIM program Gate Process for project proposals, supervisor assignment, graduate supervision, and evaluation.
- There will be a total of five compulsory courses for the MDTE pathway: The existing TIMG 5001, the existing TIMG 5002, the new TIMG 5008, the new TIMG 5202 and the new TIMG 5203 courses. The selection of elective courses by students will follow the same logic as the existing TIM graduation pathways.

The course descriptions for the required new courses are as follows.

#### TIMG 5008 [0.5 credit]

#### Foundations of Digital Transformation & Entrepreneurship

Antecedents, patterns, and consequences of agile digital business transformation, digital business development, digital business model innovation, disruptive digital technology, digital entrepreneurship, and marketing and sales for a digital age. Managing digital business transformation and development of new digital value propositions in new and existing companies.

Includes: Experiential Learning Activity Prerequisite(s): TIMG 5001 and TIMG 5002.

#### TIMG 5202 [0.5 credit]

#### Moving Digital Transformation & Entrepreneurship Research into Business Practices

Tools, models, approaches, theories, and frameworks used to deploy digital technology to frame, create, appropriate, distribute, protect, sustain, convey, and deliver value. Streamlines the movement of research findings in digital transformation, business model innovation, and technology entrepreneurship into business practices.

Includes: Experiential Learning Activity

Prerequisite(s): TIMG 5008

#### TIMG 5203 [0.5 credit]

#### **Cross Border Businesses and Digital Innovation**

Examines the mechanisms that leverage digital technology and innovation to scale the value of entrepreneurial cross-border businesses rapidly, early, and securely.

Prerequisite(s): TIMG 5008

#### TIMG 5908 [1.0 credit]

#### Master of Digital Transformation & Entrepreneurship Project

The proposed curricular changes are all related to the introduction of the new courses: TIMG 5008 (Foundations of Digital Transformation & Entrepreneurship); TIMG 5202 (Moving Digital Transformation & Entrepreneurship Research into Business Practices); TIMG 5203 (Cross Border Businesses and Digital Innovation), and TIMG 5908 (Master of Digital Transformation & Entrepreneurship Project). These new

courses provide the substance of the new MDTE graduation pathway which seeks to address the growing need for digital transformation and entrepreneurial competences in the industry and the opportunity to equip our students with the competences needed to drive digital transformation and digital entrepreneurship initiatives in existing companies and organizations.

The new TIM MDTE graduation pathway will follow the existing TIM program structure which applies to all existing pathways and includes a set of compulsory courses, a set of elective courses and a final TIM graduate project.

The MDTE graduation pathway course structure is as follows:

- a) 2.5 compulsory credits:
  - TIMG 5001 Principles of Technology Innovation Management
  - TIMG 5002 Technology Entrepreneurship
  - TIMG 5008 Foundations of Digital Transformation & Entrepreneurship
  - TIMG 5202 Moving Digital Transformation & Entrepreneurship Research into Business Practices
  - TIMG 5203 Cross Border Businesses and Digital Innovation
- b) 1.0 credit in Technology Innovation Management electives
- c) 1.0 credit in approved electives in Engineering, Business, or Science
- d) 1.0 credit in a graduate project (TIMG 5908)

Total: 5.5 credits

#### **Description of graduation requirements** (required for stand-alone credentials)

Graduation requirements will be the same as for all other existing TIM graduation pathways in accordance with the course structure provided above.

#### **Impact on Other Programs**

We do not expect the MDTE pathway to impact other Carleton programs. The MDTE does not compete for enrolment with existing programs at Carleton, such as the Sprott MBA or the various Carleton degrees with specialization in data science. It appeals to a different type of students with very different career goals. The MDTE targets experienced professionals with at least two years of relevant work experience (similar to all other TIM graduation pathways) who wish to take leading roles in existing companies and organizations (including Government departments), and seek to acquire the digital technology management competences that will help them transform the way their organizations operate, explore new entrepreneurial opportunities and shape digitally-enabled offerings for the key stakeholders.

The MDTE pathway will nicely complement the existing TIM MEnt graduation pathway whose target group are experienced professionals with at least two years of relevant work experience who are

interested in creating their own ventures or contributing to the growth of early-stage companies (start-ups). The MDTE offers a unique and timely competence development opportunity to aspiring professionals interested in managing the distinctive innovation and entrepreneurial aspects of digital transformation practices in established firms and organizations.

At the same time, the new MDTE pathway will provide a pull of valuable elective courses for MEnt and other TIM students interested in digital transformation management theory and practice. It will also complement the existing TIM MABA and MEng pathways by providing students with the opportunity to concentrate on exploring the opportunities of using data and emerging digital technologies to improve existing business processes and shape new value propositions in their specific organizational context.

Some MDTE students may request to register in elective courses from other programs. Decisions on admitting TIM students to courses from other departments would follow standard Carleton processes.

#### Impact on Learning Outcomes and Curriculum Map

The MDTE pathway will complement the existing TIM program learning outcomes with a focus on digital transformation competences. More specifically, graduates of the TIM MDTE pathway will be able to:

- Distinguish between management and entrepreneurial practices focusing on a) using emerging
  digital technologies to enhance operational efficiencies (digitization or digital transformation of
  business processes), and b) pursuing the development of new digital value propositions, i.e.,
  configuring people, processes and digital technologies to rapidly develop and innovate new
  digital offerings (digital entrepreneurship) as part of established and new companies and
  organizations.
- Adopt digital transformation and digital entrepreneurship theories, frameworks and tools to develop actionable insights that could be valuable to managers and leaders of companies and organizations committed to engage in a digital transformation pathway.
- Conceptualize and design the various aspects of a company's digital transformation strategy:
  from a comprehensive evaluation of the business process improvement capacity of digital
  technologies such as blockchain, cloud computing, AI, IoT and cybersecurity, to creating a vision
  for new digitally inspired value propositions, to generating insights about what digital offerings
  customers are willing to pay for, to figuring out the technology and process platforms that
  would power the new digital offerings, to designing accountability frameworks that enable
  company managers to achieve their strategic goals.
- Adopt inclusive digital technologies to enable existing companies and organizations to benefit from cross-border entrepreneurial opportunities.
- Use the competences acquired in the MDTE pathway to engage in applied digital transformation research projects with existing companies and organizations focusing on advancing their digital transformation agenda.

#### Societal Need

The Canadian industry has a high demand for talented professionals combining digital transformation, innovation and entrepreneurship competences, who could help companies to improve their business

processes, discover new cross-border business opportunities and shape new digital value propositions to help businesses grow and compete beyond national and international borders.

The Government of Canada is also going through a digital transformation mode which requires similar managerial and leadership roles. The feedback from our external partners associated with the Centre for Cross-Border, Digital & Inclusive Entrepreneurship does also indicate that the proposed MDTE pathway will address urgent industry and government needs. For example, Dr. Sevgui Erman is the Executive Director of the Digital Technologies Research Centre at the National Research Council. Dr. Erman is one of TIM's Advisors who has recommended focusing the new program pathway on digital innovation/transformation managers or professionals aspiring to engage in the digital transformation of young and established companies as well as in Government Departments. Dr. Erman has also indicated the Canada School of Public Service Digital Academy as a potential partner with significant experience in providing digital transformation/innovation skills for public service managers. Another one of our partners – John Shannon, is Industrial Technology Adviser in the Industrial Research Assistance Program at NRC. He has also pointed out the local industry need for management talent in the digital business transformation domain.

There are multiple publicly available publications emphasizing the need of management professionals who can drive the digital transformation of Canadian companies. The links to and quotes from such publications are provided in the **Appendix**.

#### Students

The TIM program has responded to industry demand by increasingly introducing digital transformation and digital business model innovation theories, frameworks and tools in TIM course work, in theses and graduate projects, in TIM projects with companies, and in the launch and growth of new digital ventures. TIM students have responded enthusiastically to the introduction of digital transformation content. The number of final TIM student projects focusing on the ways of using digital assets to explore new cross-border business opportunities and value propositions has grown visibly in 2021 and 2022. We have introduced the course TIMG 5103 "Cross-border Entrepreneurship" (Summer, 2022) which focused on how digital technology and differences across borders enable new entrepreneurial opportunities and company growth. TIMG 5103 - D "Cross-border Entrepreneurship" is the prototype of the newly suggested 0.5 credit course TIMG 5203 (Cross-Border Businesses and Digital Innovation). It has met a significant interest from students (31 students in a new 0.5 credit course offered in July-August is a good testimony of student interest), showing that the topic is very dear to our international student base.

Our experience with the introduction of the TIM MABA pathway (which is currently our most popular pathway including 38% of our students) shows that students are highly attracted by the opportunity to acquire competences related to data analytics and digital asset management for business model innovation and new value proposition development. Like the launch of the MABA graduation pathway in 2020-2021, we expect enrolment in the MDTE graduation pathway to grow each term for the next three years and contribute significantly to our growth plan of increasing the TIM full-time students from 200 to 400. Although we expect the initial MDTE cohort to be applicants already applying to the TIM program, we anticipate that the MDTE cohorts will include new applicants to Carleton that would otherwise have applied elsewhere to other universities with digital business transformation programs. Our examination of similar programs in Canada and North America shows that there are several short

professional development programs (course modules) and several academic programs focusing on digital transformation. However, there is no program integrating the digital transformation and entrepreneurship themes. In this sense, the MDTE pathway is unique in its positioning among existing programs in Canada and North America.

The MDTE will follow the existing processes of the TIM program for applications and admissions, with two student intakes each year in fall (September) and winter (January), and continuous operation through the summer term including both course offerings and graduate supervision.

#### Resources

The new MDTE pathway is drawing entirely on courses that are being developed and funded entirely independently as electives for the other pathways, and are thus drawing only resources already committed to TIM by Sprott. The only new course that is required by this proposal is the project course (TIMG 5908), which does not require new resources other than the ones that are currently required for the other pathway project courses. The other new courses referred to in this proposal (TIMG 5008, TIMG 5202) were developed as part of a larger independent already funded project that also includes new course proposals that are de facto renumbering (such as TIMG 5203 having been previously offered as TIMG 5103 (a topics course) and TIMG 5205 having been previously offered as 5005. The MDTE pathway requires *no net new faculty resources and thus does not include a budget*.

Administrative support, space, equipmen:

The MDTE will use the existing administrative support of the TIM program which is under development at this moment. We have a new TIM Administrator, a part time Grad Administrator, and in the process of hiring a Grad Administrator on a casual one-year term position to help growing the number of students. The MDTE will use the existing space and equipment of the TIM program. The TIM program's computer lab was updated in 2019 with high-performance computers configured specifically for advanced business analytics and machine learning. The MDTE will use the existing equipment of the TIM program and focus on using open-source tools for analytics and data analysis. The MDTE pathway requires *no net new administrative suport, space, or equipment resources.*

Replacing TIMG 5003 with TIMG 5008 The course change will strengthen the entrepreneurial content of the TIM MEnt pathway and address the growing need of both industry and students for management competences in digital business transformation and digital entrepreneurship. The need for such competences has been around for more than 10 years, but the Covid period has created the urgency to act on offering courses addressing it. The course change will enhance the distinctiveness of the TIM MEnt pathway with respect to other program pathways and help in growing the number of students pursuing it. The new course focus on digital transformation and entrepreneurship will make the program pathway attractive to a broader student audience interested in modern entrepreneurship theory and practice. Students will benefit from the adoption of a broader entrepreneurial perspective which includes the management of digital assets for the sake of transforming business processes and developing new digitally enabled value propositions in existing organizations. The change is not expected to affect student enrollment in other TIM program pathways. The change will not affect the existing program learning outcomes; it will only make explicit the value of pursuing entrepreneurial opportunities and acquiring management competences in the digital business domain. 2. Changing the course number of TIMG 5005 to TIMG 5205 This is a cosmetic change aiming to align the course numbers of TIM courses offered in the entrepreneurship domain. It will have no impact on any other aspects of the TIM MEnt program pathway. 3. Allowing students two options to complete the program: a) by completing the 1 credit TIMG 5905 project, or b) by completing two courses (2 x 0.5 credits) instead of the TIMG 5905 project. The modification will have two potential benefits. First, it will facilitate the growth of the program pathway providing an opportunity for new students who would prefer to take two more courses instead of completing a project. Second, it will facilitate the program completion for students who would like to complete the program pathway through the online delivery mode (the online delivery mode has been approved by VPARC). These will be international or domestic students who will not be physically present

in Ottawa and may find it difficult to engage in a project with an Ottawa-based company or organization. They will however still have the option to work on a project with a company or

organization in their own location (if they decide to do so). Last but not least, the modification will align the course structure of the two entrepreneurship pathways - the present MEnt pathway and the new Master of Digital Transformation & Entrepreneurship -

- 2. Allowing students to apply up to 1.5 credits in relevant language courses toward the LACS Minor requirements.
- 3. Removing LACS 4001/LACS 4819 as a mandatory requirement for the LACS Minor.

Introduce more flexible language that permits students to take courses at different levels while maintaining the academic integrity of the program.

#### Rationale for change

1. Creating LACS 2001 provides students with multiple entry points into the LACS Minor program. Students who are interested in the LACS Minor will have the option of taking a LACS foundational course at EITHER the 1st year OR the 2nd year. 2. Encouraging students to study languages relevant to the region without making it a mandatory requirement. 3. Makes the LACS Minor consistent with other interdisciplinary minors and better accommodates students in the three-year BA degree programs.

#### Transition/Implementation

We will contact LACS Minor students to inform them of the Calendar changes. If needed, we will use Audit Exceptions to move appropriate courses around and make sure students under the old Calendar can meet their Minor requirements.

We are also contacting the DARS Audit team to put coding in place so that LACS students can maximize courses with regional relevance.

Green. nataliephelan (11/30/22 11:16 am): Reworded sub-requirements following consultation with the DARS team and the LACS supervisor: two of the sub-requirements were functionally the same so these have been folded together, and the explanation of the language course substitution has been separated out from the sub-requirement text to avoid confusion. Language courses are not subject to the 2000- and 3000-level restrictions. Also removed a deleted HIST course from the electives list.
