1. Welcome

The President welcomed the new Senators.

2. Approval of Agenda (open)

It was MOVED (W. Felepchuk, W. Jones) that Senate approve the open agenda of the meeting of October 26, 2016 with the following two changes. Item 4 was deferred to the next Senate meeting as this was a topic request by a Senator unable to attend today's meeting. W. Felepchuk requested that the November 2, Day of Action be added to the agenda under 'Other Business'. The motion PASSED.

- 3. Minutes:
 - a) September 9, 2016

It was MOVED (R. Goubran, M. Neufang) that Senate approve the minutes of the meeting of September 9, 2016. The motion PASSED.

- 4. Member Request: Update on the Global Academy (P. Ricketts)
 This item is deferred to the November Senate meeting.
- 5. Reports:
 - a) SAPC (P. Ricketts)

It was MOVED (P. Ricketts, M. Butler) that Senate approve the addition of the Astrophysics stream in the BSC honours program effective fall 2017. The motion PASSED UNANIMOUSLY.

It was MOVED (P. Ricketts, W. Clement) that Senate approve the Final Assessment Report and Executive Summary for the MA program in Religion and Public Life.

The motion PASSED UNANIMOUSLY.

It was MOVED (P. Ricketts, W. Clement) that Senate approve the Final Assessment Report and Executive Summary for the Undergraduate and Graduate Programs in Sociology.

The motion PASSED UNANIMOUSLY.

A Senator asked if the issue of over-reliance on contract instructors is mentioned in many program reviews. P. Ricketts stated that it is mentioned in some instances and the department responsible for the program generally addresses the issue.

b) SCCASP (H. Nemiroff)

H. Nemiroff introduced the following motions:

It was MOVED (H. Nemiroff, A. Arya) that Senate approve revisions to section 2.5, Deferred Final Examinations and the addition of section 2.5.1, Early Departure from Final Examinations as amended, effective the 16-17 calendar. The motion PASSED UNANIMOUSLY.

It was MOVED (H. Nemiroff, J. Shepherd) that Senate approve the revised admission requirements for the Bachelor of Information Technology program in Photonics and Laser Technology with a report to be submitted at the conclusion of the 2017-2018 academic year to the Carleton University Committee on Quality Assurance on the degree to which the first cohort of students admitted to the program under the revised admission requirements successfully completed first year.

The motion PASSED UNANIMOUSLY.

It was MOVED (H. Nemiroff, R. Hoey) that Senate approve inclusion of the WDN notation on official transcripts, for graduate and undergraduate students who withdraw after the full fee adjustment date in each term, for courses commencing the 17-18 academic year.

S. Blanchard stated that this change would bring Carleton in line with the standard practice of most other universities. Senators discussed the benefits and disadvantages of this change for the university and for students. H. Nemiroff stated that the motivation for this change was to provide better transparency and to align with provincial practices. It is not retroactive and

does not impact a student's CPGA. L. Ralph stated that students can appeal the WDN notation for health reasons.

The motion PASSED.

It was MOVED (H. Nemiroff, J. Shepherd) that Senate approve changes to regulation 2.3, Standing in Courses/Grading System, as amended, for the 17-18 calendar.

The motion PASSED UNANIMOUSLY.

It was MOVED (H. Nemiroff, J. Shepherd) that Senate approve the Academic Nomenclature document, as presented, effective the 18-19 calendar. The motion PASSED UNANIMOUSLY.

c) Academic Colleague (J. Smith)

The report was included in the meeting materials.

6. Senate Administration

The Clerk presented updated membership of Senate and Senate Committees (see Appendix A).

It was MOVED (D. Russell, J. Paulson) that senate recommend to the Board that a representative of the alumni be appointed to Senate and that Jack Coghill be the alumni representative on Senate.

The motion PASSED UNANIMOUSLY.

The GSA made an appeal to the Provost for academic amnesty on this day to encourage students to attend this event. However, P. Ricketts was unable to consider this request due to the August deadline in the 2010 Senate policy that addresses this type of request. W. Felepchuk stated that several universities have granted academic amnesty for this event. The GSA will be seeking to amend this policy in the near future.
 - J. Paulson reported that since the last Senate meeting he and others have received a lengthy email regarding the Senate Financial Review Committee. The Senate Office was not aware of this email. The Clerk asked J. Paulson to forward it to him and stated that it will be circulated to all Senators (see Appendix B).

In response to a question, H. Nemiroff stated that the new WPN notation will become active in 2017-18 and the method of informing students has not yet been determined.

Dear Members of the Carleton University Senate,

As an outgoing member of the Senate Financial Review Committee (SFRC), I write to you to provide my personal report on the doings and affairs surrounding the SFRC and it's mandate to review the University budgeting process. Some of you may remember me as a longstanding graduate member of Senate, as well as one of the new members of the SFRC after it was re-established at the orders of Senate in academic year 2014-2015.

For those of you who were not present at the time, I have appended a short prehistory of the drama of the SFRC below. The abbreviated version would be that SFRC has faced consistent obstruction of it's business since at least 2008, when then Vice-President Finance Duncan Watt, by his own admission to Senate in May 2014, had struck a private arrangement behind closed doors with the Clerk of Senate to insure that the Finance Committee would no longer be populated or meet. Learning this, in October of 2014, Senate ordered the Clerk to populate the committee and for meetings to begin promptly. Shortly thereafter, the SFRC was asked to independently investigate allegations that the VP-F had been vastly understating surplus revenues in his budget reports to Senate, and the committee was asked to consider a motion to revise its terms of reference to make it more active and independent from the Administration in carrying out its duties. This was a motion that I myself had submitted to Senate, but which the Senate Executive did not allow to be read on the floor (another gross breach of the Senate's rights and prerogatives, and one that's become habitual).

Now, to cut a long story short, at the end of a sequence of meetings over the 2014-2015 academic, VP-F Duncan Watt appeared at the SFRC to present his budget. At that meeting, he reiterated his oft-made claim that, given his definition of terms, Carleton did not have any appreciable budget "surpluses".

I referred him to the footnotes on Net Assets and Capital Disclosures in the independently audited financial reports*. These showed vast increases in the "Special Reserve Funds", such that e.g., the "Capital Reserve" had ballooned from \$43M to \$120M and the "Pension Liability Reserve" had expanded from \$36M to \$90M from 2011 to 2015. I asked him that if this money did not, by his nominal definition, constitute a "surplus", might they, by his definition, be considered "appropriations". He admitted that they would, and that his office had been "appropriating" many millions of dollars for

special reserves for a good number of years. Needless to say, these reserves are not reported in "budgets".

Now, dear Members of Senate, I have rarely had the occasion to see an entire roomful of seasoned professors quite literally drop their jaws and leave them hanging there for a solid two minutes. That was definitely one of them.

It was also a rare occasion to be exposed to what one wise man dubbed "the Humpty Dumpty Theory of Language" whereby words always mean exactly whatever the speaker wants them to mean. By this alchemy, "budget surpluses" are transmogrified into "reserve fund appropriations" and are magically whisked away from view and placed in a realm beyond debate.

In spite of (or perhaps because of) this ongoing business on the SFRC's table, the sitting Chair of the committee (who was, of course, appointed by the Senate Executive) has refused to call the committee to order since the Summer of 2015. That is a solid year of refusing to obey even the existing rules. The Chair has repeatedly stated (on the record) that he does not personally think that the committee should exist, has insisted that nobody inside or outside the faculty cares about its business, and has at least once claimed that he wasn't aware that his three-year appointment hadn't ended in year two.

Needless to say, if the SFRC was called, it would be asked to report back on all of this, and to send back to Senate the motion to approve new terms of reference which might buttress its independence from interference. It remains for you, good Senators, to determine whether you would prefer to have your Financial Review Committee to provide you independent counsel on Carleton's finances in the future, or not. If you do have a mind to keep accurately informed of financial matters (which quite obviously impinge upon the curriculum, on academic programming, and on the actual necessity of various programs, cuts, or academic out-sourcing proposed by the Administration), I would encourage you to Recall from Committee and debate the original motion of March 16th, 2015 to revise the SFRC terms of reference. Whatever your course of action, I'd also encourage you to read through the attached report from the CAUT, which outlines the various common ways that University administrations in Canada have found for hiding assets from their faculties, and how to see through the prestidigitation.

Whatever your decision, I am glad to have at least attempted to be of some service to you and to Carleton over the years.

- i) September 2014 The "Carleton: Red or Black?" report on Carleton's finances prepared for the Campus United group in September 2014 by Doctor Matthew Kurtz (Carleton) and Doctor Tyler Chamberlin (U. of Ottawa), alleged that Carleton's surplus revenues were being vastly understated in the former Vice-President Finance's (VP-F) budget reports to Senate and the Board of Governors.
- ii) May 2015 Both Prof. Chantal Dion and I express concern over the matter that the SFRC has not been involved in vetting the budgets being presented to Senate. It is later admitted by the VP-F Duncan Watt, that he had, in effect, asked the Clerk of Senate to smother the SFRC some years prior. This occurred at least as far back as 2008, shortly after the committee recommended to Senate that it's terms of reference be revised to allow it to operate more freely and to more actively review the University's budget and it's implications for curricular reforms on an ongoing basis. President Roseanne Runte would, in his absence at a later meeting, repeat the VP-F's admission that the SFRC had not been populated and involved in validating the budget presentations to Senate because of a private agreement between the VP-F and the Clerk.
- iii) September 2015 Senate committees are again populated... except for the SFRC. At this time, I give Notice of a Motion ordering the Clerk issue a call for members to populate the Committee promptly, and without further delays, and that the SFRC meet within thirty-days of the motion's ratification by Senate.
- iv) October 2015 Senate PASSED the motion as amended, thereby instructing that the SFRC begin meeting promptly.
- v) March 2015 I give a Notice of Motion to the Senate Executive of a motion to revise the SFRC Terms of Reference along the lines originally proposed by the committee in 2008. The Senate Executive illegally refers the Motion to two different committees (the SFRC included) without allowing it to be known or considered by Senate. The Motion has since remained on the Table of SFRC, awaiting either to be recalled to the Senate or for the SFRC to meet and to send it back to the floor.

THAT Senate approve the commencement of the Joint PhD program in Biomedical Engineering with the University of Ottawa with effect from September 2017, with a report to be submitted to the Ottawa Carleton Committee on Graduate Quality Assurance by June 30, 2019 on a reconsideration of the requirement that students entering the program who have already successfully completed BIOM 5010/BMG 5112 or the equivalent be required to take an additional 3 credit (University of Ottawa) or 0.5 credit (Carleton University) elective.

Background

The PHD program in Biomedical Engineering is a joint program with the University of Ottawa and is governed by the Joint Institutional Quality Assurance Process.

The program has followed the necessary approvals processes at each of the universities. These approval processes involve first a decision from the Ottawa Carleton Committee on Quality Assurance. From that point the proposal is considered by the Graduate Program Committee, Senate Executive and Senate at the University of Ottawa, and the Carleton University Committee on Quality Assurance, Senate Academic Program Committee and Senate at Carleton University. The proposed program is to be considered by the University of Ottawa's Senate on November 28th.

The requirement for a report originated with the Ottawa Carleton Committee on Quality Assurance and has subsequently been endorsed by all committees at the University of Ottawa and Carleton University.

Senators will note that the self-study (Appendix A) contains additions and changes using track changes. The reason for this is that the Quality Council Appraisal Committee appreciates seeing easily identifiable evidence in the self-study for a proposed program when the champions of the program have responded to recommendations made by the external academic reviewers or observations made by university committees as these committees have reviewed the documentation after the external academic reviewers have submitted their report and the program champions have responded to it.

Background

Senators will note that the self-study (Appendix A) contains additions and changes using track changes. The reason for this is that the Quality Council Appraisal Committee appreciates seeing easily identifiable evidence in the self-study for a proposed program when the champions of the program have responded to recommendations made by the external academic reviewers or observations made by university committees as these committees have reviewed the documentation after the external academic reviewers have submitted their report and the program champions have responded to it.

Senators will also note that, while the Carleton University Committee on Quality Assurance unanimously recommended that the proposed programs be approved to commence, the Committee nonetheless had a significant concern about maintaining the quality of the student experience in all four programs (BHSc, MSc: HSTP, MSc and PhD) the Department of Health Science intends to deliver in 2017 given the ambitious timeline for the implementation of the MSc and PhD programs. This concern was communicated to the Department in a memorandum of November 10th (Appendix G). In response, the Department provided an addendum (Appendix H) to their original response (Appendix E) to the external academic reviewers' report (Appendix D). This addendum was considered by Senate Academic Program Committee in making its recommendation to Senate.
