### Admissions Information

Admission requirements are based on the Ontario High School System. Prospective students can view the admission requirements through the Admissions website at [admissions.carleton.ca](http://admissions.carleton.ca). The overall average required for admission is determined each year on a program-by-program basis. Holding the minimum admission requirements only establishes eligibility for consideration; higher averages are required for admission to programs for which the demand for places by qualified applicants exceeds the number of places available. All programs have limited enrolment and admission is not guaranteed. Some programs may also require specific course prerequisites and prerequisite averages and/or supplementary admission portfolios. **Note: If a course is listed as recommended, it is not mandatory for admission. Students who do not follow the recommendations will not be disadvantaged in the admission process.**

### Admission Requirements

#### First Year

##### **Bachelor of Commerce (B.Com.) (Honours)**

The Ontario Secondary School Diploma (OSSD) or equivalent including a minimum of six 4U or M courses. The six 4U or M courses must include English (or *anglais*), Advanced Functions, and Calculus and Vectors. Applicants who do not present with Calculus and Vectors must successfully complete [MATH 0009](#) at Carleton in the Fall semester of first year in order to be eligible to continue.

Applicants submitting an English language test to satisfy the requirements of the [English Language Proficiency section of this Calendar](#) may use that test to also satisfy the 4U English prerequisite requirement.

##### **Bachelor of Commerce (B.Com.)**

No direct entry; access is restricted.

### Advanced Standing

**Bachelor of Commerce (B.Com.) (Honours)**

Applications for admission to the second or subsequent years will be assessed on their merits. Applicants must present an overall CGPA of 9.00 (B+) or higher.

~~Students must present a major CGPA of 6.50 (C+/B-) or higher, and an overall CGPA of 8.00 (B) or higher. Advanced standing will be granted only for those courses that are determined to be appropriate. Students Current Carleton students may also be assessed for admission to second and subsequent years if they present BUSI 1001 and BUSI 1002 with a minimum an average of 3 out 8.0 or higher (with no individual grade below C+) and a Major CGPA of the following 6 courses (or equivalent): 6.50 (C+/B-) or higher. BUSI 1001, BUSI 1002, ECON 1001, ECON 1002, BUSI 1800, and MATH 1009 with no individual grade below C+ and with a Major CGPA of 7.00 or higher. Note that MATH 1007, MATH 1004, MATH 1052, or MATH/ECON 1401 and MATH/ECON 1402 (both required) are acceptable for transfer in lieu of MATH 1009.~~

Advanced standing will be granted only for those courses that are determined to be appropriate appropriate.

Applications by B.I.B. (Honours) students for admission to the second or subsequent years of B.Com. (Honours) will be assessed on their merits. Students must present a Major CGPA and an Overall CGPA consistent with the Academic Continuation Evaluation requirements for B.Com. (Honours) students. Advanced standing will be granted for those courses determined to be appropriate.

**Bachelor of Commerce (B.Com.)**

No direct entry. Access is restricted to students in the Bachelor of Commerce (Honours) and Bachelor of International Business (Honours). (See Regulations for Business.)

**Co-op Option****Direct Admission to the First Year of the Co-op Option**

Applicants must:

1. meet the required overall admission cut-off average and prerequisite course average. These averages may be higher than the stated minimum requirements;
2. be registered as a full-time student in the Bachelor of Commerce (Honours) program;
3. be eligible to work in Canada (for off-campus work placements).

Meeting the above requirements only establishes eligibility for admission to the program. The prevailing job market may limit enrolment in the co-op option.

**Note:** continuation requirements for students previously admitted to the co-op option and admission requirements for the co-op option after beginning the program are described in the Co-operative Education Regulations section of this Calendar.

### Academic Continuation Evaluation for Bachelor of Music

Students in the Bachelor of Music (Honours) follow the continuation requirements for Honours programs, as described in [Section 3.2.6](#) of the *Academic Regulations of the University*, with the following additions and amendments:

- Students with 15.5 or more program credits completed, but who have a Major CGPA less than 6.00, will be required to leave the B. Music program with the decision *Continue in Alternate* (CA).
- The Bachelor of Music defines a Performance Core consisting of the following courses:

- Bachelor of Music students who fail to obtain a grade of B- or higher in any two consecutive performance courses at the 2000- and/or 3000-level, or in any two consecutive attempts at the same 2000-level and/or 3000-level performance course, course in credits 5.5 to 15.0 must leave the the program with the the status *Continue in Alternate* (CA).

Hi All:

I concur with Jazz's take and would add the following. Typically, these courses are taken in first year and, if they did very poorly, would not result in being asked to leave the program. However, it is conceivable, as Natalie wrote, that due to transfer credits, change of program, etc., a student could take MUSI 1900 and 1901 beyond credits 5.5. In this case we would treat them the same as first years and it would not result in removal. Again, as Jazz wrote, from our standpoint, we keep a close eye on our students and easily deal with such

situations. The trick will be in the language.

There is no way I can see that a student could take MUSI 2900 or 2901 in the first 5.5 credits due to the nature of our prerequisites and the structure of our program. If they came in with 1900 and 1901 course transfer equivalents and a total of 5.5 or more credits from another institution, even if these were lower than B- (highly unlikely), this should still be treated as if they were earned at CU and would not count.

Hope this makes sense early on a Friday evening. Have a nice weekend all.

#### Rationale for change

Clarifying the rules around the Music Performance Core. The department has confirmed that the first year performance courses, MUSI 1900 and MUSI 1901, should not be included in the ACE rule which could see a student CA'd from the program. The B- requirement in consecutive performance courses, and the requirement to achieve a B- by the second attempt at a specific performance course, only applies to the 2000- and 3000-level courses. This is how the department has managed the Performance Core check in APE, and now with the introduction of ACE we are adjusting the wording of the regulation so that the CA rule properly applies to MUSI 2900, 2901, 3900, and 3901 only.
