CALENDAR DESCRIPTION:

This seminar will meet on a regular basis for students who are writing their doctoral theses to present draft chapters for constructive critical discussion. Normally required for all PhD Anthropology students who have completed their doctoral research, until the completion of their theses.

PRE-REQUISITES AND PRECLUDED COURSES: Available to doctoral candidates in anthropology currently writing their doctoral theses, or permission of the instructor.

COURSE DESCRIPTION AND OBJECTIVES:

The purpose of the seminar is to support the thesis-writing process, both by providing structure for the writing process, and by providing feedback on individual chapters from faculty and peers.

The seminar will meet at least six times in the Fall term and six times in the Winter term, approximately once every two weeks. During the first class of each term, a schedule will be established for students to present draft chapters of their theses. Ideally we will have one PhD candidate presenting a chapter at each meeting, having provided the chapter at least one week in advance for everyone to read. The student's supervisor and committee members will also be invited to attend the meeting in weeks when their student is presenting. The student will present the chapter in 5-10 minutes and will then receive written and verbal comments from all participants. Thus, your obligation as a seminar participant is to present a chapter at least once per term for comment by the group, and to, in turn, comment on the work of your peers in writing as well as orally in the remaining meetings.

As time permits, we may also spend some time discussing other issues of relevance to this stage and upcoming stages of your careers. This may include discussion topics such as the writing process, giving conference papers, applying for academic jobs, academic cv.'s, interviewing for jobs, preparing job talks, grant writing, writing for publication, career trajectories and career planning, etc.

READINGS/BOOKS:

There are no required readings for this course. However, academic resources to support the writing process and professional development will be posted on Brightspace for your reference.

COURSE REQUIREMENTS AND METHODS OF EVALUATION:

This is a zero-credit course, which receives a grade of 'satisfactory' or 'unsatisfactory.' All anthropology PhD students who are at the dissertation writing stage are required to complete two terms of this seminar with a grade of 'satisfactory.' Students must register for the Fall and Winter terms separately. Students are welcome and encouraged to continue to enroll in the seminar as long as they are working on their thesis, beyond the minimum two term requirement.

There are no graded assignments for this course.

A grade of satisfactory requires:

- regular attendance and participation in class meetings
- informed written and verbal feedback on peers' work
- presentation (in writing and orally) of at least one draft chapter of the dissertation per term for comment by peers, committee members, and the instructor

*Presentation chapters must be circulated to class members, the instructor, and the student's committee members a minimum of 7 days prior to the scheduled feedback session, but students should also consult their committee members well in advance of this to let them know to expect the chapter and ensure the committee member has time to read it before the session.

*Students are responsible for contacting their supervisor and committee members about the scheduled feedback session well in advance of the date, and to bring any time conflicts to the attention of the instructor as soon as possible.

*Chapters should be emailed to everyone in the class and the committee members. The instructor will also upload the chapter to Brightspace where everyone registered in the class can access it. You may also submit the url of a Google document if you want people to comment on a single document, however, this could result in a lot of comments on a single text, which can be cumbersome. Committee members and class participants may choose to comment on a separate, clean version of the chapter, or write comments separately in an MS Word file, and send this back to you if they prefer.

*If a student joins the seminar prematurely and is not at the point of being able to distribute a draft chapter for commentary by the end of the first term, the student will be asked to withdraw and re-register for the following term as their official 'term one.'

PEER WRITING GROUP:

Students are encouraged to use the off-weeks, when there is no scheduled meeting, to meet up as a 'writing group,' either virtually or in-person. Since our classroom is booked for every week but we only meet every second week, you are welcome to use the classroom as a group writing space during those weeks when we are not holding a class meeting. Alternatively, you could arrange a Zoom session during this time block on the off-weeks where those who wish to participate can join a Zoom meeting for a fixed period of time and then either discuss your writing, circulate smaller pieces of writing for comment, or simply sit and write in each other's presence. Making writing social and taking part in a peer writing group can be helpful for breaking the sense of isolation associated with the thesis writing process.

Other faculty and grad students in the department sometimes form writing communities that are open to all grad students, and I will communicate any information about such possibilities to the class.
