COURSE DESCRIPTION & OBJECTIVES:

This course will introduce students to the socio-cultural study of psychoactive drugs by critically exploring some of the main debates and issues in the field of drug studies, with a particular focus on psychedelic substances. Generally speaking, drug use has predominantly been studied within a framework that views it as a problematic and deviant activity. Within this framework users are reduced, on the one hand to being enslaved addicts largely lacking agency, due to their dependence on narcotic drugs. On the other, they are framed as dangerous criminals, delinquents, and hedonists that threaten the social and moral order and cause many of the social problems that contemporary society suffers from. Critical Drug Studies not only mounts a critique against the prohibitionist drug war paradigm but also develops an array of conceptual tools and theoretical frameworks that allow for a more sophisticated and evidence-based analysis of drug use, both licit and illicit. In addition to outlining a post-colonial critique of the prohibitionist paradigm, the course will focus on three main areas: 1) the medicalization of psychoactive drugs; 2) the religious uses of drugs; and 3) the colonial neuropolitics of psychedelic plants and molecules. Some of the topics to be covered include: the cultural history of psychedelic healing, the appropriation and commodification of indigenous medicinal plants, the pharmaceuticalization of psychedelics, the globalization of ayahuasca, drug tourism, the political economy of psychoactive drugs, indigenous plant knowledge, and evolutionary perspectives on psychoactive substances, among others.

LEARNING OBJECTIVES:

- 1. Enhance academic reading and writing skills, as well as skills in expressing ideas in other mediums, such as oral presentations.
- 2. Develop the ability to critically engage with a range of concepts and theories, such as pharmaceuticalization, drug discourses, psychotomimetic, the theory of set and setting, cognitive liberty, among many others.
- 3. Learn to connect and analyze issues in drug studies from a sociological perspective using the theoretical tools introduced in class.

PREREQUISITES:

One of the following: SOCI 1001 and SOCI 1002, or SOCI 1003 [1.0], or ANTH 1001, or ANTH 1002, AND third year standing.

CLASS POLICIES, EXPECTATIONS, DIVERSITY & INCLUSION STATEMENT

You are expected to attend class regularly and be prepared to participate and talk during class. This means having read the required readings before the class begins. This point cannot be stressed enough: you must read the required material! If you do not read the required readings, you will not do well in the course. You are also expected to actively participate and contribute to group discussions both in meetings and the online forum. You are also expected to complete all assignments on time.

Throughout the course you will be expected to speak and share your ideas with the class and in small groups. We learn better when we share our perspectives and interpretations on the course material. In addition, since the course revolves around controversial aspects of drug use revolving around class, race, gender, and colonialism, you are encouraged to openly express any disagreements with the authors you will read, as well as with your fellow classmates, with the Professor and Teaching Assistants. The ultimate aim of this is to understand each other but it does not imply striving towards finding agreement. Our class will be racially, religiously, politically, culturally, generationally, and economically diverse. We will be of different gender identifications and sexual orientations and our lived experiences and reactions to the course material will reflect this diversity. So even though we will practice being critical, you are expected to conduct yourself in such a way that shows the utmost respect to others who may – or may not – share your views. Derogatory comments and hateful behaviour towards others (and their views) will not be tolerated.

In this course the use of artificial intelligence (AI) programs, such as ChatGPT, for the purposes of handing in course work that is to be graded is strictly forbidden. This means that you should not be using AI programs to generate answers, essays, presentations, or any element of the course that will be graded by the professor or the teaching assistants.

General Discussion Forum: There will be an on-going general discussion forum on Brightspace for the duration of the class. Since there is so much to talk about concerning psychoactive drugs you are expected to contribute at least 10 posts throughout the semester at your own leisure. You are free to start your own discussion threads or add to existing discussion threads that others have posted. Discussion forum participation is worth an overall total of 10%. In other words, for every posts you make you will receive 1% and contributing 10 well-formed posts will earn you the full 10% for discussion forum participation. The discussion forum will close on April 8, 2025, at 11:59 p.m.

Reading Reflections: During the semester you will write **10 short reflection pieces** (at least 300 words) based on the required readings for the class. The aim of this element is for you **to engage the required readings** and articulate your thoughts on the main issues brought up in the readings. You will submit your short reading reflection pieces through Brightspace on a weekly basis. The short reflections are worth a total of 20% of the final grade (2% per reflection).

Quiz: There will be one quiz worth 15% of the overall grade. The quiz will consist of multiple-choice questions based on the main material covered in class and readings. It will be made available through Brightspace over a two-day window scheduled for March 5/6,

Group Presentation: There will be one group presentation (10 minutes in duration maximum) worth 15% of the overall grade. **Your attendance is required on March 5, 2025.** We will dedicate part of this class to outlining the specific details for the group assignment (guidelines will

also be posted on Brightspace). During our meeting you will have time to form groups of 4-5 people, begin the assignment, and allocate different sections of the project to each member of the group who will in turn be responsible for that specific section of the presentation. If you cannot be present for our meeting, then you should arrange beforehand to be part of a group. If you do not do this, then you may need to carry out the presentation on your own. **Group presentations will take place in class on April 2, 2025**.

Final Essay: The final assignment is a research paper (10-12 double-spaced pages, excluding title page and bibliography) worth 40% of the overall grade and based on a topic of your choosing related to drug studies. Detailed guidelines for the final essay will be explained in class and will be posted on Brightspace. Essays must be submitted through the Brightspace drop box. Essays are due on **April 8, 2025**. To be fair to those students who submit papers on time, late papers will be penalized at a rate of 3% per day.
