#### **Course Description and Objectives:**

Introduction to the discipline of sociology; theory, methods, history; key thinkers, concepts and disciplinary subfields in sociology; issues and problems in contemporary society. Emphasis on the everyday world of lived experience and social relations. Topics may include class, gender, sexuality, racialization, culture, social interaction.

### **Learning Outcomes:**

At the end of this course, students should be able to:

- Identify different sociological theories (Marxism, symbolic interactionism, feminism, critical race theory)
- Apply sociological theories to new social phenomena
- Recall central sociological questions in a breadth of areas of study (gender, race, social class, sexuality, disability, religion)
- Closely read and take notes on academic texts
- Take notes while listening to a lecture
- Use appropriate studying techniques to successfully pass short-answer and multiple-choice tests

### **Tutorial Participation:**

Attending weekly tutorials is an essential part of the course. 15% of your final grade will come from attendance and participation in tutorial discussions and activities. Each week you should come to the tutorial prepared, having done your reading, attended lecture, and prepared to engage with the course material with other students and the Teaching Assistant. 50% of this mark will be an attendance mark. 50% of this mark will be based on activities designed and marked by the TA. Participation marks cannot be 'made-up'.

#### Weekly tests:

In the last 30 mins of every lecture there will be a reading comprehension test based on the assigned reading for that week. For example, on October 3<sup>rd</sup>, the test will be on Chapter 20 by Patrizia Albanese in the assigned textbook.

Why are there so many tests?

- Class discussions, tutorials, and course engagement are greatly improved when students come to class prepared, having done the assigned readings
- A key learning outcome of this course is to encourage students to develop their academic reading skills, studying skills, and ability to recall material
- Ongoing tests are pedagogically preferable to fewer assignments with higher stakes; students are less likely to procrastinate on doing course readings, skip classes, etc.
- Prof. Davidson is still grappling with the impacts of artificial intelligence on students' writing
  assignments. In-class tests are seen as preferable to devoting TA and professor time to AI
  policing.

Students with accommodations will have their accommodations met for these tests. For all students missed tests can be made-up within two weeks of the missed test in Prof. Davidson's office hours. No appointment necessary. (Office hour details at top of syllabus).

#### What are the Procedures?

All allegations of plagiarism are reported to the faculty of Dean of FASS and Management. Documentation is prepared by instructors and departmental chairs. The Dean writes to the student and the University Ombudsperson about the alleged plagiarism. The Dean reviews the allegation. If it is not resolved at this level then it is referred to a tribunal appointed by the Senate.
