Community Philanthropy

Formal and informal mechanisms communities use to mobilize their assets for public benefit and social change; analysis of major innovations and trends in community philanthropy from a global perspective.

Knowledge of the literature, approaches and theories of “community philanthropy” and familiarity with innovative professional practices (of community organizations, foundations and other stakeholders) in community-based mobilizing and action for change and societal benefit. The ability to apply in the Canadian and possibly international context and critically assess such approaches.

Case studies, simulations, role playing and other pedagogy suitable to adult learners is an important component of the course. Professional experience in the nonprofit, charitable and philanthropic sector is a valuable asset.

The students are a diverse mix of experienced and aspiring professionals enrolled in the Master or Diploma of Philanthropy and Nonprofit Leadership, the only degree of its kind in Canada.

The instructor must be able to teach in an interactive, online format using the Carleton University system.
