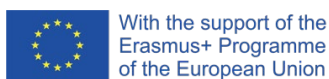

## Speakers

### **Ece Özlem Atikcan**

Ece Özlem Atikcan is Professor in Politics and International Studies at the University of Warwick and a Visiting Senior Research Fellow at the European Institute of the University College London in the UK. Her research combines a theoretical focus on political campaigns, issue framing, politicisation of trade agreements, transnational social movements, and diffusion with a regional focus on the European Union. She teaches politics of the European Union and comparative politics more broadly. Her work has appeared in *European Journal of Political Research*, *Journal of Common Market Studies*, *Journal of Elections Public Opinion and Parties*, *Journal of Public Policy*, *Journal of European Integration*, and as books with Cambridge University Press, Oxford University Press and McGill-Queen's University Press.

She is currently leading a multinational research project, *Frames in Production: Actors, Networks, Diffusion (FRAMENET)*. The project team aims to create a new, comparative research agenda that investigates when and how specific statements emerge in a political debate, by which kinds of actors they are proposed, and whether and how they diffuse to others. The project focuses on five issue areas (migration, environment, global health, transparency and trade), and relies on Discourse Network Analysis (studying the content of arguments together with the networks of actors) and interviews to study these exciting research questions.

### **Dirk De Bièvre**

Dirk De Bièvre is Professor of International Politics and Chair of the Department of Political Science at the University of Antwerp (Flanders, Belgium). He studied at the universities of Leuven, Louvain-la-Neuve and Konstanz, Germany, and obtained his PhD at the European University Institute in Firenze, Italy, in 2002. From there, he went on as a postdoc at the Max Planck Institute for Research on Collective Goods in Bonn and the Mannheim Centre for European Social Research of the University of Mannheim until 2006. He was a visiting fellow at the London School of Economics and Political Science during the academic year of 2014-15.

He has published extensively on multilateral trade politics, European Union trade policy, and the role of interest groups in public policy making and is the co-author of a monograph on judicial politics in the World Trade Organization with ECPR Press together with Arlo Poletti (Trento) and a handbook on European trade policy with MacMillan together with Sieglinde Gstöhl (College of Europe, Bruges).

Dirk is Official Representative of the University of Antwerp for the ECPR and member of the steering committee of the ECPR Standing Group on International Relations (SGIR). In that capacity, he is jury member of the ECPR Hedley Bull prize in International Relations and member of the Joint Management Committee of the *European Journal of International Relations* (together with representatives from the European International Studies Association EISA). He is member of the Editorial Boards of the *Journal of European Public Policy* and *Politics and Governance*.

### **Jean-Christophe Defraigne**

Jean-Christophe Defraigne is currently professor in International and European Economics at the Institute for European Studies of Université Saint-Louis Bruxelles and at the Louvain School of Management UCLouvain. He is also a research fellow at



the Leuven Centre for Global Governance Studies of the KU Leuven University. Professor Defraigne holds a MSc in Economic History at the London School of Economics and a PhD in Economics at the University of Brussels. In 2003-2004, he was a research fellow at the University of International Business and Economics of Beijing (Jing Mao Da Xue) on EU-China economic relations. He has been visiting scholar and professor at UIBE Beijing (Jing Mao Da Xue) and Zhejiang Da Xue. As an academic expert, he has participated to numerous international research projects for various international institutions such as the European Commission, the European Parliament, the Japan External Trade Organization or the Jacques Delors Institute. His research focuses on long term comparative analysis of regional integration processes (East Asia, Europe, Americas), their links with the strategies of transnational corporations and technological changes; the analysis of the history of technological changes, industrial and trade policies in Europe, USA and East Asia (1870-2005); the transition of the Chinese economy and East Asian integration and the rise of emerging economics and its effect on Europe.

### **Francesco Duina**

Francesco Duina is Professor of Sociology and a faculty member of the European Studies Program. He has held appointments at Harvard University, Copenhagen Business School, and the University of British Columbia (where he was Professor and Head of Sociology during 2013-2015).

His work lies at the intersections of economic sociology, political sociology, and international political economy. He is especially interested in globalization, international organizations, and the continuing relevance of nation states. In that context, he has written on a variety of themes – such as international trade, competition, consumer policy, nationalism, democracy, law, and regional integration. Much of his work is comparative (Europe, the Americas, Asia, and beyond) and in theoretical terms adopts an institutionalist perspective. Professor Duina has published articles in a wide range of political science and sociology journals. He also has contributed chapters to edited volumes on the European Union and other international organizations, international trade, nationalism, the distinctiveness of national institutions, and related themes. He has authored six books on questions of national identity and nationalism, international organizations, and globalization. Along with scholars from five other universities, Francesco is a partner in the Jean Monnet Network on Transatlantic Trade Politics.

### **Michelle Egan**

Professor Michelle Egan focuses on comparative politics and political economy. She works on Europe and the United States, with a focus on issues of federalism, trade, governance and law. She is past Chair and Vice Chair of EUSA, the EU Studies Association, and is editor of series on EU with Palgrave. She is a Global scholar at Wilson Center. She has published two single authored books with Oxford, three edited volumes, and is currently working on another book on trade and comparative federalism. She has published a variety of policy papers, articles, and book chapters. She has appeared on CNN International, NPR Marketplace, NPR the World, Al Jazeera, as well as quoted in various news media, notably on Brexit, Trade Policy, and EU affairs. Professor Egan is co-director of the Transatlantic Policy Center with Professor Garret Martin. She is founding member of the global TradeExperettes a



network of women trade experts from around the world who provide insights on trade as well as promote expertise, engagement and empowerment to enhance the voice of women in trade policy circles. <https://www.tradeexperettes.org/>

### **Elvire Fabry**

Elvire Fabry is Senior Research Fellow at the Jacques Delors Institute, in charge of trade policy, EU in globalisation and Brexit. Her areas of expertise include EU bilateral trade negotiations, investment, global governance, WTO reform, Brexit, EU-US relations, EU-China relations, and perceptions of globalisation. She previously conducted research on the EU's external action policies (trade, security and defense, neighbourhood, migration). After being at the European Commission's Forward Studies Unit (1995), she joined the prospective studies and foresight centre, Futuribles International. In 2003-2004 she was research fellow at the Fondation Robert Schuman. From 2005 until spring 2009 she was director of the European programme at the Fondation pour l'Innovation Politique. She joined the Jacques Delors Institute in 2009.

Elvire Fabry holds a PhD in political science from the IEP (Sciences-Po) Paris, and Master's degrees in philosophy and international relations from the Panthéon Sorbonne – Paris I University. She has been an auditor ("Defense policy" 64th session) at the Institute of Higher National Defence Studies (IHEDN) in 2011-2012. She is Colonel of the Citizens' Reserve of the French Air Force.

### **Achim Hurrelmann**

Achim Hurrelmann is Professor of Political Science at Carleton University and currently serves as Chair of the Department. He is Co-Director of the Centre for European Studies (CES), a Carleton University Research Centre. He is cross-appointed to the Institute of European, Russian and Eurasian Studies (EURUS). Dr. Hurrelmann's scholarly work focuses on the politics of the European Union. He is particularly interested in political discourses about European integration (in parliaments, the media, and among citizens), the democratization of the EU, as well as Canada-Europe relations. His articles have appeared in some of the leading journals in the field, including *European Journal of Political Research*, *West European Politics*, *Journal of European Public Policy*, and *Journal of European Integration*.

### **Danielle Kinsey**

Danielle Kinsey focuses on the history of 19th century Britain and empire, comparative women's and gender history, and global history. She is particularly interested in studying transnational connections and commodity chains that show the centuries-old development of globalization and how interconnection has been formative in the making of the modern world. Her current book project examines the meaning of diamonds in Britain and Empire across the nineteenth century. With Jennifer V. Evans, she is also embarking on a new project about photography and sexual revolution in the twentieth century. Dr. Kinsey completed her MA at the University of Calgary and her PhD at the University of Illinois at Urbana-Champaign. Dr. Kinsey is currently the co-editor-in-chief of *H-Material Culture*.

### **Gabriel Siles-Brügge**





Dr Gabriel Siles-Brügge is a Reader in Public Policy in the Department of Politics and International Studies at the University of Warwick. Gabriel's research interests sit at the interface of the study of public policy, political economy and European Studies. He has extensively researched the politics of trade and investment negotiations, the role of economic ideas and quantification in policymaking and civil society contestation of economic integration (including the role of frames and emotions), and the politics of Brexit. Dr Siles-Brügge is a member of the Jean Monnet Network on 'Transatlantic Trade Politics', where he co-leads a work package on 'The reconfiguration of transatlantic trade after Brexit', and has been a visiting researcher at Ghent, Copenhagen and Carleton University.

He is the (co-)author of *Constructing European Union Trade Policy: A Global Idea of Europe* (2014, Palgrave Macmillan) and of *TTIP: The Truth about the Transatlantic Trade and Investment Partnership* (Polity, 2016). His work also has been published in leading academic journals such as: *New Political Economy*, the *Review of International Political Economy*, the *Journal of Common Market Studies*, the *Journal of European Public Policy*, *Policy & Politics*, *Globalization and Health*, and *Contemporary Politics*. He is one of the incoming editors of the leading European Studies outlet, the *Journal of Common Market Studies*.

Dr Siles-Brügge has provided extensive commentary in the UK and international media and has consulted for and/or advised NGOs, trade unions and parliamentary committees on UK and EU trade policy. From April 2017 to July 2019 he worked as one of the very first Parliamentary Academic Fellows, advising the UK House of Commons International Trade Committee. Since April 2021 he has been a Specialist Advisor to the same Committee. He has separately provided specialist input for a 2021 UK National Audit Office report on the 'Department for International Trade: Progress with trade negotiations'. Gabriel has served for several years as a Scientific Advisor to the European Public Health Alliance and was appointed as one of the organisation's representatives on the European Commission Directorate-General for Trade's former Expert group on Trade Agreements.

### **Elinor Sloan**

Elinor Sloan joined the Department of Political Science at Carleton University in 2002 after 6 years as a defense analyst in the Department of National Defence, focusing on United States defense policy and advanced military technologies. Prior to completing her PhD she was a logistics officer in the Canadian Armed Forces following graduation from the Royal Military College of Canada.

Dr. Sloan has published widely on Canadian and US defense and security topics. Her teaching focuses on International Security Studies, Transatlantic Security Issues, and North American Security and Defense Policy. She currently has two projects underway: a book manuscript on Canada's International Security Policy and a SSHRC-funded research project on the naval shipbuilding strategies of Canada and its close allies.

### **Gabriele Spilker**

Gabriele Spilker is Professor of International Politics – Global Inequality at the Department of Politics and Public Administration and co-speaker of the Excellence Cluster "The Politics of Inequality". Her main research interests concern both the determinants and the consequences of inequality. In particular, she investigates the



consequences of climate change for migration and conflict as well as inequalities in perceiving globalization processes. Gabriele Spilker completed her PhD at ETH Zurich. Before joining the University of Konstanz, she was a Fritz Thyssen Fellow at the Weatherhead Center of International Affairs at Harvard University (2011-2012), a postdoctoral researcher at the Center for Comparative and International Studies (CIS) at ETH Zurich (2012-2013) as well as Assistant/Associate Professor of International Politics (2014-2020) and Professor for Empirical Research Methods at the Department of Political Science and Sociology of the University of Salzburg (2020-2021). Her work has been published in the British Journal of Political Science, International Organization, Journal of Politics and Nature Climate Change. Gabriele Spilker is an active part of Scientists for Future (S4F).

### **Crina Viju-Miljusevic**

Crina Viju-Miljusevic is an Associate Professor at the Institute of European, Russian and Eurasian Studies (EURUS) at Carleton University. She serves as Associate Director of the Centre for European Studies (CES). She teaches a number of courses related to Europe and Russia, at both the undergraduate and graduate levels, focusing either on interdisciplinary or economic issues. Her research interests include the economic effects of trade policies applied within the EU, US and Canada, as well as European economic integration and EU enlargement. In the past six years, she has received a major research grant for an EU-related project from the Social Sciences and Humanities Research Council of Canada; and she has been academic coordinator of two Jean Monnet Projects on EU learning in Canadian high schools (funded 2016-2018 and 2019-2021).

### **Alasdair Young**

Alasdair Young is Professor and Neal Family Chair in the Sam Nunn School of International Affairs at the Georgia Institute of Technology. He co-directs the Center for European and Transatlantic Studies, a Jean Monnet Center of Excellence, and the Center for International Strategy, Technology, and Policy. He held a Jean Monnet Chair (2012-15) and received the Ivan Allen College's Distinguished Researcher Award in 2015. Beyond Georgia Tech, he was co-editor of JCMS: Journal of Common Market (2017-2022). Studies and was chair of the European Union Studies Association (USA) (2015-17). Before joining Georgia Tech in 2011, he taught at the University of Glasgow in the UK for 10 years. Prior to that he held research posts at the European University Institute in Florence, Italy, and the University of Sussex, outside Brighton in the UK.

Alasdair has written five books, including *Supplying Compliance with Trade Rules: Explaining the EU's Responses to Adverse WTO Rulings* (Oxford University Press, 2021). He has edited 15 other volumes, including the eighth edition of *Policy-Making in the European Union* with Mark Pollack, Christilla Roederer-Rynning, and Helen Wallace (Oxford University Press, 2020). He has published almost a score of refereed journal articles -- including in *Global Environmental Politics*, the *Journal of Common Market Studies*, the *Journal of European Public Policy*, the *Review of International Political Economy*, and *World Politics* -- and written more than 40 book chapters. He has also performed consultancy work for the US and UK governments and for the European Commission.

## About your hosts and organizers

### **The Jean Monnet Network of Excellence**

The Jean Monnet Network on Transatlantic Trade Politics studies the politicization of international trade with a particular focus on trade relationships across the North Atlantic. The network brings together five universities, from Europe and North America, whose scholars possess recognized expertise on European and international trade. The Jean Monnet Network engages in a broad range of activities to further research, teaching, and outreach to non-academic constituencies. In addition, by establishing scholarly connections between researchers and shared educational environments for students, the network promotes scholarly knowledge on the politics of international trade, particularly in the EU, and helps train a new generation of experts, who will be in a position to promote transatlantic understanding in their future teaching, research and professional careers. ### **Carleton University**

Carleton University is a comprehensive higher education institution located in Ottawa, Canada's capital city. Established in 1952, the university currently has an enrollment of more than 27,000 undergraduate students and more than 4,000 graduate students. Carleton University offers a broad range of undergraduate and graduate degree programs, with particular strength in public and international affairs, as well as in other areas such as engineering and computer studies. ### **Antwerp Summer University**

Since 2010, Antwerp Summer University offers intensive, short-term courses during the summer months within the areas of excellence of the University of Antwerp and its partners. Next to several interdisciplinary summer schools, summer school topics range from Law over Design Sciences to Health. Target groups are different for each summer school and may consist of students, researchers, and/or working professionals.

As you will notice, summer schools consist of intensive full-time programs in which a wide variety of teaching methods are used. Sessions are taught by international speakers and experts from both within and outside the academic world. 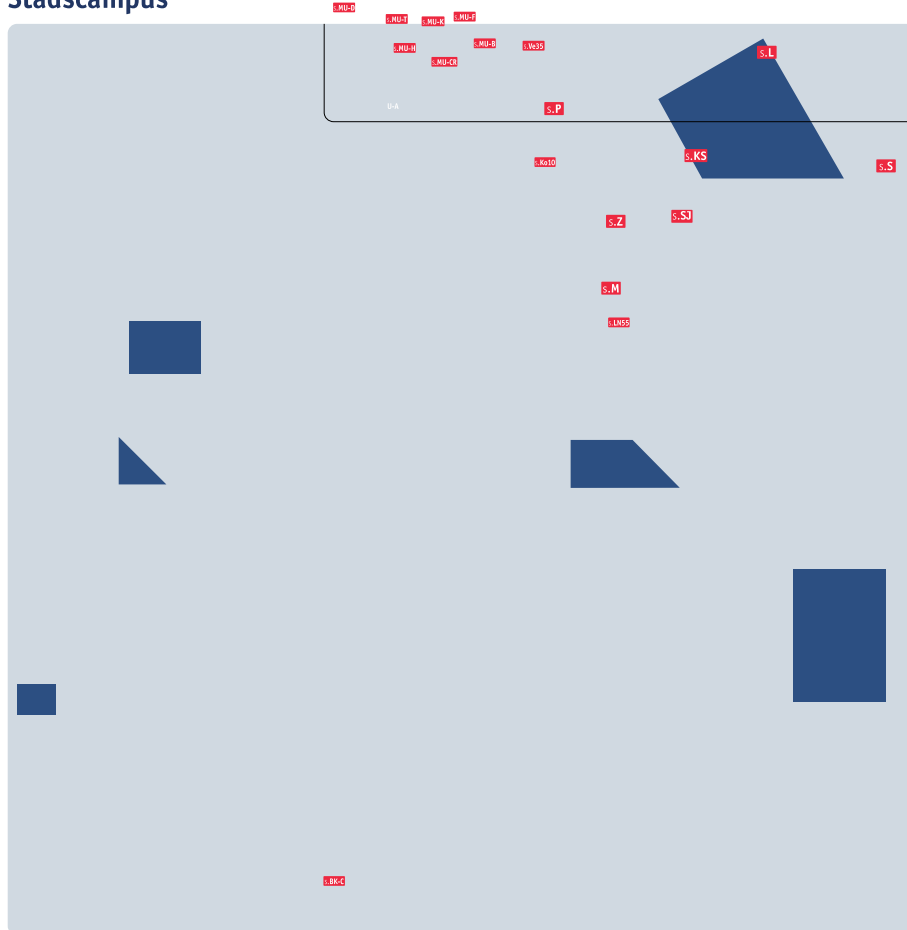
